All White people across the world come from Europe. We are one family with a common origin.

We Europeans are everywhere. Of course, we're mostly in Europe, the British Isles, North America, Canada, Australia, New Zealand, South Africa, Russia, and other white countries that we have founded and where we belong (and where all third-world people want to move). On every continent and in every corner of the world, you'll find the descendants of white Europeans. Wherever we've gone, we have thrived and built Christian civilizations based on God's laws rather than the law of the jungle. Non-whites have never been able to achieve this on their own. Even if whites establish a Christian civilization for them, they cannot maintain it (unfortunate South Africa is but one example).

However, we whites have not always been scattered across the world. We did not always live in Europe; nor were we always called Europeans. To rediscover our forgotten origins, we must go back to God and His Scriptures. Our presence across the earth and our unparalleled accomplishments of Western Civilization were prophesied in the Bible long ago when Yahweh made His covenant with Abraham, who was white, and to Abraham's white progeny. It has always been our God-given destiny to be the greatest race to ever walk the earth. Long before we migrated to Europe, we lived in the Middle East. That was over 2,000 years ago. And, yes, the Middle East was white back then, and this is where we were born as a people. We whites were and still are the original Biblical Israelites. We are Abraham's genetic children, the people with whom God made His covenant.

How did this expansion from the Middle East to Europe happen? Fundamentally, it began when the Israelites were freed from slavery in Egypt. As we well know, most Israelites followed Moses into the Sinai Desert and forty years later, conquered the land of Canaan.

But not all the Israelites went with Moses. A sizable group broke away when they first left Egypt and this group set sail for Europe. The others followed Moses. Then some years later, in conquered Canaan, another swath of Israelites — descendants of the Israelites who had followed Moses — migrated during the Judges and Kingdoms periods and also set sail for Europe. We know about these migrating Israelites from ancient secular history and stone inscriptions rather than from the Bible, which focused on the Israelites in Canaan.

However, the largest migration came with the Assyrian deportations in 722 BC, when masses of our Israelite ancestors were uprooted from the Promised Land and resettled near the Caucasus Mountains. Some of these Israelites stayed in the Caucasus area and eventually became the Parthian Empire, but large numbers migrated over the Caucasus mountains and into Europe. These Israelites morphed into the multitude of Germanic tribes who swarmed across Europe and eventually conquered and destroyed the Roman Empire. Since our purpose here in Proof 1 is to show that we white Europeans are the Biblical Israelites, we'll concentrate on these later migrations of Israelites who became the Germanic tribes. We'll cover Israel's earlier migrations in later Proofs.

These migrations are our forgotten beginnings as white Europeans. Our journey as a race happened under the direction of Providence and according to prophecy. We did not indigenously sprout up across Europe as Frenchmen and Italians, Londoners and Dubliners, Swedes and Finns. All of these modern white nations and designations grew from the same genetic root: the tribes of Israel. Europeans of all stripes share the same ancestors. Those ancestors were the adventuring Israelites tribes who came crashing onto the European landmass all those centuries ago. As their numbers multiplied, they split apart into their own territories and their own unique tribes but were collectively known as the Germanic tribes. Our Germanic forefathers became the Franks, Saxons, Angles, Frisians, Danes, Swedes, Goths, Vandals, Lombards, Celts, and many other tribes. With the eventual advent of Christianity, these peoples founded new nations and built the greatest civilization (Western Civilization) ever to exist.

These original Germanic tribes, they are our people. We come from them and we carry their genetic heritage to this day, and yet, most of us do not know our own identity. This means although we may refer to ourselves as English, or French, or American, and so on, in reality, we are men and women of the tribe of Dan, or Judah, or Ephraim, or one of the other twelve tribes. We have forgotten our ancestry, and we have assumed new nationalities. To remedy this unfortunate situation, let's take a closer look at the story of the Germanic tribes, which is really our story. Our ancestors did come from Europe nor did they "evolve" within Europe from primates and Neanderthals, as we are misinformed by pagans, antichrists, and secular white nationalists. We white Europeans are not chimps out of Africa nor pond scum. We have very deep, very ancient genetic roots, in another land. Certain peoples who have different and antagonistic roots would prefer that we remain ignorant of our real early history.

In the books of Chronicles in the Bible, we read that the Israelite Kingdoms began to be conquered and deported by the Assyrians. This process began around 740 BC and took several decades, as piece by piece the former mighty Israelites kingdoms were dismantled by the Assyrians. Empires such as Assyria used deportation to subdue and control conquered

nations. Once defeated, the Israelites were deported into regions just below the Caucasus Mountains. Those displaced Israelites are sometimes called the “lost tribes,” but that’s a false designation. How lost or misplaced could these people have been if we know they were settled near the Caucasus Mountains? It wasn’t the tribes who were lost; it was the memory of their identity as children of Israel that was lost. In these Proofs, we intend to reclaim that identity.

The Assyrian Inscriptions



The important question is, what happened to these people? Does their story end with their deportation? If they eventually forgot that they were Israelites, did history also forget them? Indeed, history did not forget our ancestors. We can be thankful that their story has been preserved in the many stone inscriptions and other historical landmarks and findings that modern archeology has dug up during the past two hundred years. In these two centuries, archaeologists have unearthed in many Biblical locations the story of the lost tribes. One such site is Ninevah, the ancient capital of the Assyrian Empire. Many stone pillars and tablets have been unearthed and, you might say, these stones talk and narrate our ancient history. When translated, these records show that the Assyrians, the Persians and Medes, the Babylonians — all talked about in the Scriptures — really did exist. The Assyrians really did conquer Israel and really did deport millions of Israelites.

But the narrative isn’t always straightforward due to the fact that the Israelites weren’t always referred to as Israelites. Different peoples called them by different names. For instance, these Assyrian records called the Israelites by the name of Cymri or Bit Cymri. If you’re coming across this information for the first time, you might be thinking: “How is he getting Israelite out of Cymri? These words don’t sound alike at all.” And you’d be right. They don’t. That’s because the names Cymri and Bit Cymri come from the Assyrian perspective and tongue. The Assyrians called their captive people (the Israelites) by the name of the King of the Northern Kingdom of Israel at the time. This was the famous King Omri (his name has also been translated as Humri and Amri). The Assyrians transliterated the name into

Cymri and Bit Cymri (possibly due to a harsh guttural beginning “c” sound in the original Hebrew). “Bit Cymri” means “the house of Omri” or “the people of Omri.” King Omri, his reign, conquest, and deportation can all be found in the Bible in I Kings (3 Kings in the Septuagint, LXX) Chapter 16.

It should be noted that in older translations of the Bible, King Omri used to be spelled King Cymri. However, since it was pronounced with an initial guttural “gggg,” it’s likely that people other than Hebrews had difficulty pronouncing the word, and hence the Assyrians went with a modified transliteration they could pronounce more easily, Cymri. In the King James Bible (by the 17th century), the translators decided to modify certain spellings in order to simplify pronunciation; as a result, they modified many words such as Cymri to start with a vowel instead of a consonant. This is the reason why we have King Omri in our Bible, but the Assyrian inscriptions call him Cymri.

The Cimmerians, Galatae and Scythians



During the reign of the Assyrians, the Israelites became known as Cymri. The Assyrian Empire was vast and far-reaching, therefore the lingua franca (the common language, especially for trade) was Akkadian (the Assyrian language), so other surrounding nations also began to call the Israelites by these names, although in their own transliterated versions. The Greek historians called the Cymri by the name of Kimmerioi (Κιμμέριοι) which modern translators anglicize to Cimmerians. These same Greek historians tell us that these Cimmerians migrated out of Assyria, from the regions to which the Israelites had been deported, and that they eventually migrated into Europe. Since the Greeks lacked a guttural sound in their language, they pronounced the name Cimmerians with a “C” as we would say “kill.” The Romans used a “k” instead of a “c” and so called them Kimmerii.

It would certainly be easier if the traveling tribes of Israel were always called by the same name, but they weren’t. We have to deal with that historical reality. The early changing of their name is understandable, and perhaps to be expected. After all, conquered and

dispersed people generally do not get to insist on their own name. With the passing of many generations in new lands, the original name may have passed from memory. As the tribes of Israel pushed farther into Europe, their name was modified again and again by people with yet another language.

Nevertheless, we can track the names historically, and the evolution of their name tells a fascinating story in itself. The Babylonians transliterated Cymri to Khumri, thus the name remained virtually identical. The Persians however called the Cymri/Khumri by a new name altogether: the Saka/Sacae (Sakā) or Saka Suni, which means the Sons of Saka (some people believe Saka is a shortened form of Isaac). From the Saka Suni, we get the more modern name of Saxons which is still with us to this day. Saxons is a combination of Saka and Sons.

The evolution of names doesn't stop there. As the Cimmerians or Saxons invaded more of Europe, they gained two more names: Scythians (Scythae/Σκύθοι) and Galatians (Galatae/Γαλάται). Scythians means "tent dwellers," and the Israelites may have given themselves this name because they were nomads and therefore did indeed dwell in tents. "Scythian" is a corruption of the Hebrew word "succoth" meaning tent. Galatae was a name given them by the Greeks and may be related to the word "milk" since the Hebrews lived on the products of their cattle. Since the Greeks drank primarily wine and not milk, the Greek historian Homer mocked the Galatae for being milk drinkers. Eventually, these Israelite tribes who were now called Scythians and Galatians spread out all over Europe, to the east, to the north and west. By around 300 BC, some tribes began raiding Northern Italy and after numerous victories against the Romans, they sacked Rome. The Galatians, who had taken part in the destruction of Rome, were eventually repelled and moved into what we call France today. The Romans shortened the name Galatae to Gauls (Galli).

The Celts, Gauls and Germanic Tribes

Now we come to the final name: the Germanic tribes. None other than Julius Caesar gave us this concluding name that has lasted until today. Caesar distinguished between the Gauls (Galatea) who had settled in today's France and intermixed with the native population and the Gauls who settled in the region now called Germany. France at that time was called Celtica, as Celts lived there. The Gauls in what we call modern France occupied a region originally called Celtica, which had been previously settled by the Phoenicians (another Hebrew tribe who had arrived in Europe much earlier) and the Gauls and Phoenicians likely merged with each other. But it should be noted that this "intermixing" is Julius Caesar's perspective. He thought of the Phoenicians/Celtica as a different tribe or race than the Gauls. But in fact, these two tribes were both originally Israelites. Caesar called the latter Gauls in modern Germany (who had not mixed with any previous tribe since they were the first settlers in those cold lands) Germani, meaning "genuine," "authentic," "true," and "sincere." He perceived these Germani as a purer breed than the Gauls in France. The tribes in Germania — the Saxons, Scythians, and Cimmerians — would gradually adopt their new name of Germania or the Germanic peoples.



The first-century Greek historian and geographer of the Greek and Roman worlds, Strabo, described the Germans or all of Germania as an enormous mass of people beyond counting who inhabited the lands beyond the western Rhine and as far as the Black Sea. Essentially this shows that at that time, the landmass from the border of France all the way to the Black Sea was all considered Germania. In other words, the Germanic, Cimmerian, Scythian people controlled and occupied all of the territories north of the Roman Empire, what we today consider Central and East Europe. Historians such as Pliny the Elder further verify this. Pliny recounts that the people known as Germans or Germani were also called Scythians and Cimmerians. "The name of the Scythians is everywhere changed to that of Sarmatae and Germans," he wrote (The Natural History of Pliny the Elder, Book 4, Chapter 25). These historical documents prove that these people were all one and the same people no matter what name was attached to them.

To sum up the transformation of the Israelites into Europeans: After being deported by the Assyrians, the Israelites migrated from Assyria and Media through the Caucasus Mountains. From there, they traveled into Europe and became known as the Germanic tribes. Later, they solidified into the modern European peoples and nations. That is why today Europeans are collectively called Caucasians. We white Europeans came from these Germanic tribes. Our people were originally deported from the lands of Israel and Judah. Thus as we trace our lineage back in time, we can know with certainty that we are the Israelites, the descendants of Abraham, Isaac, and Jacob. We are the people of the Bible. We are the inheritors of the Biblical promises and prophecies. There is no true Christianity without a true understanding of this ancient history. We are the Children of God and the Bible is our history and no one else's.

2) *The Laws of God are Part of Every White European Civilization*



“Moses commanded us a law, even the inheritance of the congregation of Jacob” Deuteronomy 33:4 KJV

Now that we know who the true Israelites are, our next step is to understand that Yahweh gave His law only to Israel. Only Israel. No one else. He gave us His law through Moses, first on Mount Sinai in what we know as the Ten Commandments, and later through Moses' rulings as the children of Israel traveled through the Sinai Desert to the Promised Land. Many years later, King David praised Yahweh for giving His law to the Israelites alone. “He declares his word to Jacob, his statutes and ordinances to Israel. He has not dealt thus with any other nation; they do not know his ordinances. Praise the Lord” Psalm 147:19, 20.

It follows logically that if Yahweh's laws are only for Israel, then no other race has His laws nor could ever be expected to uphold His laws. Nor did they. Nor could they. As David said: “They do not know His ordinances.” If we're looking for the so-called lost tribes of Israel, we need only to examine the moral structures of other races and compare these structures to God's moral law. We find that Christian Europeans have upheld God's moral laws for centuries while non-white races haven't. Yahweh promised to write His law in the hearts of His people. As a result, wherever Europeans go, they build a white civilization based on Christian law and morality. Wherever Africans go, they build Africa, and whenever Chinese go they build China. Non-white races do not (nor are able to) build civilized Christian societies. So you need only answer the question, “Which race follows God's law?” and you will know who the true Israelites are. Obviously, the white race alone fits this description.

“But this shall be the covenant that I will make with the house of Israel; After those days, saith the LORD, I will put my law in their inward parts, and write it in their hearts; and will be their God, and they shall be my people” Jeremiah 31:33 KJV.

The Laws build a thriving civilization and protect from infiltration

Even a few decades ago, almost every white man, woman, and child would have known the Ten Commandments by heart. Bibles were in the homes, churches, and even in the schools. White people read and knew their Bibles, to a greater or lesser degree. The average white person feared God and knew that His law should be upheld. But that is no longer the case. Most modern white people have only a vague idea of the Ten Commandments or any of God's other laws. So here is a list of the Ten Commandments, which can be found in Exodus 20:

You shall have no other gods before Me.
You shall make no idols.
You shall not take the name of the Lord your God in vain.
Keep the Sabbath day holy.
Honor your father and your mother.
You shall not murder.
You shall not commit adultery.
You shall not steal.
You shall not bear false witness against your neighbor.
You shall not covet.

Although God's moral code is broadly condensed into these Ten Commandments, Yahweh gave many other laws to Moses and the children of Israel as they journeyed to the land of Canaan. These other laws include prohibitions against usury, sodomy (or homosexuality as it is called today), bestiality, miscegenation (miscegenation is a form of adultery as it adulterates the bloodline), and the eating of pork, shellfish, and other food laws. Yahweh commanded the children of Israel to be a separate and holy people, dedicated to Him as His servant race. On this basis, we were allowed interaction with the other Adamic races, such as the Egyptians, Persians, and so on, but we were forbidden interaction with the non-Adamic races: the Nephilim, Rephaim, and Kenites, to name but a few. Yahweh warned that if we mixed with non-Adamic races, they would always be pricks in our eyes and thorns in our sides. In other words, their ungodly and immoral ways would tempt us into sin and lead us astray. And that certainly has been the case.

These moral laws are our Creator God's blueprints instructing us how to build a moral, functioning, thriving civilization. They are a loving Father's directions to His children. You only have to look at any European nation to see the truth of this. Yahweh's commandments teach us what virtue is and they train us how to live properly. In addition, they protect us from antichrists, the enemies of God, and therefore our enemies. If we followed God's laws (which we are not doing for the most part), these laws would prevent non-Adamic people (the enemies of God) from infiltrating our societies and undermining our Christian morality and civilization. Intermarriage with them would be forbidden. These non-Adamics and antichrists are the "tares" or weeds in the Gospel parable of Matthew 13:24–43. If we uphold God's laws and punish those who break His laws, these immoral non-Adamics would be cast out from

amongst us. They would not be controlling our banking and making our laws or parasitically draining our resources and bringing their mayhem, immorality, and chaos into our societies. We certainly would not be miscegenation with them.

Christ is Yahweh and His Laws are Forever

Some modern people hold the mistaken opinion that the Ten Commandments and other laws of God were temporary. That is not true. The moral law is forever. It never expired, although the Levitical ritual laws were retired once Christ came. Since the moral law did not pass away, every generation of Israelites is required to follow it. Christ Himself told his followers: “If you love me, keep My commandments” John 14:15. He was referring to the same Ten Commandments and the subsequent Biblical laws that He, being God, had given to Moses and our ancestors.

In the Gospels, Christ gave His followers an additional commandment: “A new commandment I give you; love one another. As I have loved you, so you must love one another. By this everyone will know that you are my disciples, if you love one another” John 13:34–35. No man can just appear and make new additions to God’s commandments; only God Himself can do that. And Christ is God. Furthermore, if a new commandment is made to complement and complete the old ones, we are still expected to keep the other commandments as well. In Christ’s name, we are commanded to truly love and care for one another; that is, to care for our white brethren. As true children of Yahweh, we are our brothers’ keeper — our white brothers and sisters — but this commandment to love each other is all too frequently twisted to incorporate other races. If we want to obey Yahweh and be a separate and holy people, we must keep His law, especially this one.

The Ten Commandments and God’s other laws are the inheritance of Israel, and when the early Israelites branched out into Europe and beyond, they brought the moral laws with them, in one form or another. Once the dispersed Israelites had adopted Christianity, they brought with them not mere memories of the law but explicit Christianity. Other nations do not have God’s law, unless and except white Christian civilization introduces and enforces that law on them. But even then, law and order don’t take root with non-white races. God’s law is not in their nature, and it is certainly not written on their hearts. Once the white man leaves, the dark races sink back into barbarism, as has happened in South Africa.

Non-Adamites corrupt our societies

In fact, ever since the law was given to Israel through Moses, Israel alone has upheld (or tried to uphold) those moral laws right up to this day. Promising obedience to Yahweh’s law, the children of Israel journeyed from Sinai into the land of Canaan. As they entered the land, Yahweh commanded them to fully exterminate the evil Canaanites. He warned if they didn’t, the Canaanites would be pricks in their eyes and thorns in their sides and would vex and corrupt Israel and entice them away from God’s law. The Israelites failed to heed Yahweh’s warning and did not exterminate all the enemies of God, and the remaining Canaanites did indeed corrupt Israel into the worship of idols and murdering their children, prostitution,

miscegenation, and all kinds of evil, dark, pagan practices.

“But if ye will not drive out the inhabitants of the land from before you; then it shall come to pass, that those which ye let remain of them shall be pricks in your eyes, and thorns in your sides, and shall vex you in the land wherein ye dwell” Numbers 33:55 KJV.

Because Israel did not obey Yahweh and instead turned to paganism, even mingling with the Canaanites and adulterating their bloodline, Yahweh sent corrective punishment on His nation, His family, largely in the form of war, conquest, and deportation. He punished our ancestors precisely because we are His family and so that we would repent, learn, and grow into the holy race and nation that He wants us to be.

“Hear this word that the LORD hath spoken against you, O children of Israel, against the whole family which I brought up from the land of Egypt, saying, You only have I known of all the families of the earth: therefore I will punish you for all your iniquities” Amos 3.1–2 KJV.

Centuries later, Israel was forcibly separated from the accursed Canaanites when the Israelites were deported by the Assyrians. At first, the Israelites were settled near the Caucasus Mountains, but soon swaths of them began migrating into Europe. Once in Europe, they became great nations — just as God had promised Abraham — and in time, these former Israelites became Christians. Through Christ’s Gospel, they were able once again to know and keep the Ten Commandments and Yahweh’s moral law.

No matter where you go in Europe (or any white country), you will find moral law and innate respect for law and order. Is this not further proof that white people are the Israelites of the Bible? It’s only since the infiltration of our white governments and nations by these same antichrist Canaanite people that our countries have become secular and begun to depart from the Christian laws that our forefathers established. Once again, we, the descendants of Israel, are being corrupted by the descendants of Canaan. But this time, the Canaanites have managed to deceive the Israelites (Western Christian nations) into believing that they, the Canaanites, are the true Israelites. So the Usurpers vaunt themselves as the moral authority, vaingloriously boasting of a heritage that was never theirs. They have stolen our identity and set themselves up as a moral authority even over God. It is these deceptions we are attempting to rectify in these Proofs.

In our current culture, we are experiencing exactly the same problem our ancestors faced when they entered the land of Canaan. Back in their time, our ancestors lived in proximity to the remaining Canaanites (those whom the disobedient Israelites had not exterminated) and those Canaanites gradually corrupted them. In our time, the Canaanites have followed our European civilizations wherever we have gone; they have gradually and stealthily infiltrated and corrupted our white Christian societies. One difference today is that these Canaanites don’t call themselves Canaanites. They wear a mask and go by a different name, which is based on the identity that they have stolen from us. They have cleverly woven a web of deceit around the real identity of the children of Israel, and as is their Canaanite nature, they work tirelessly to drive a wedge between us and our obedience to Yahweh.

God's Laws are Found Within all European White Societies

This Canaanite deception is why the most important tasks of our lives are to uncover the truth that the ancient Israelites were white, that we are their descendants, and to separate ourselves from lies and people who are not of God. There are many irrefutable proofs that the ancient Israelites were white, but for this particular Proof 2, we need but honestly ask, "What people have kept the Ten Commandments up to the modern time? Whose societies were built on God's moral law? What nations keep the moral law as their inheritance?" When we look at the traditional Christian European countries and compare them to, say, Africa or India or Haiti, we see that only white Europeans have been the inheritors of God's moral law. Our law systems and governments were built upon the Bible. God promised that He would write His law on the hearts of His children; consequently, we white Europeans have naturally accepted and followed God's laws, whereas other races have not nor are they capable of doing so.

"But this shall be the covenant that I will make with the house of Israel; After those days, saith the Lord, I will put my law in their inward parts, and write it in their hearts; and will be their God, and they shall be my people" Jeremiah 31.33 KJV.

We Europeans and the white countries we've created have consistently been the only civilization which traditionally opposed practices prohibited by the Bible, such as usury, sexual deviancy, paganism, pornography, prostitution, homosexuality, pedophilia, bestiality, miscegenation, abortion, witchcraft, cannibalism, gambling, and other vices. Except for usury — which was illegal in Christian nations until it was allowed by the Roman Catholic Church in the Middle Ages (which by that time had been infiltrated and corrupted by antichrist forces) — these sinful practices were all outlawed until Europe became secular and atheistic in recent times, again under Canaanite influence and persecution under various guises. "Social justice" causes such as rights for sexual deviants are in reality antichrist, Canaanite acts of aggression and war against white Christian civilization, with the same ancient goals of leading Israel into perdition. Now we have laws, statutes, even church doctrines that are contrary to the Christian ideals upon which our white ancestors built our Western civilization. Many, many sins that are natural to the non-white nature are now norms in our corrupted Christian cultures.

Non-whites lack our innate respect for God's law. Seek as you may, you'll not find the Christian sense of morality and respect for law in non-white nations. This is because white Europeans alone are the true descendants of the ancient Israelites, and we are the only race to have Yahweh's law written in our hearts (and in our nature). The Bible tells us that God's law was only for Israel, not the other nations (Ps. 147:20). Why is that? Only the white race (whether Israelites or Adamites) was created by God; other races are not His creation. They are evil corruptions of God's good creation. He made only that which is good. The white Adamic race alone has been given His spirit; other nations have the spirit of their father, the devil. Even within our white countries right now, we can witness non-whites scheming, rioting, and even murdering to tear down law and order precisely because "they do not know His ordinances,"

and know only the law of the jungle and chaos. Law and order feel like oppression to them and they will have none of it.

But white Christianity has always known, upheld, and respected Yahweh's ordinances, and you can find many written proofs of that attitude in our older legal literature. For example, renowned English jurist and member of parliament Sir William Blackstone (1723–1780) put into these memorable two quotations from his Commentaries on the Laws of England the attitude of the white Christian man and woman toward law and order: "The Bible has always been regarded as part of the common law of England" and "No enactment of man can be considered law unless it conforms to the law of God." Blackstone's writing also had a tremendous influence on America's Founding Fathers.

No non-white race can conform itself to the law of God. Yahweh's law is not written in their nature. Only the white race has been shown to have this noble and Godly attitude toward law, order, and morality, and this is one more proof that the white peoples are the Israelites.

3) All Europeans Countries and Nations were Christian



Can you name a single White Nation that did not accept and become Christian?

Historically, once a white European nation accepted Christianity, there was no going back. Christianity began to spread to Europe very quickly after the resurrection of Christ, as early as the first century for the British Isles. Christianity swept across the entire white world. Over the centuries, tribe after tribe, nation after nation, and even the Roman Empire itself embraced Christianity. Most of our ancestors converted willingly, and once they became Christian, they never returned to their former pagan religions. We became Christian and we stayed Christian.

Never before in history had an entire race converted collectively to a religion. But the Europeans did. From that time, every European nation remained proudly Christian, at least up to our modern times. For centuries, Europe was known as Christendom. As Christ promised, His sheep heard His voice and they embraced Christianity precisely because they were His sheep. “My sheep hear my voice, and I know them, and they follow me” John 10:27. White Europeans were already His sheep genetically. We did not “become” His sheep through a declaration of faith or a trip to the baptismal font. To approach this Proof 3 in another way, we can ask, “Who are Christ’s sheep?” Well, obviously, according to His own words, His sheep are the people and nations who heard His gospel and embraced Christianity. This race must be — proof positive — the lost sheep of Israel who heard their Shepherd’s voice and returned to Him. That race is the white Europeans and no other.

In Proof I, we examined the Germanic migrations into Europe. We see how the ancient Israelites (before their deportations) were given the laws of Yahweh our God. But in time, they turned to paganism, being influenced by the surrounding Canaanites and heathen nations whom they’d failed to exterminate completely according to Yahweh’s command. As

corrective punishment, Yahweh caused His erring children to be conquered and deported by the Assyrians. First settled below the Caucasuses, many of the Israelites migrated into Europe and became known as the Germanic tribes. During these migrations, the pagan beliefs and practices of our Germanic forefathers evolved; nevertheless, the true original religion of our people was always with Yahweh, in Whose image we were created. The notion that paganism is the true European religion is completely false and fabricated. The idea that Christianity replaced our native paganism is nonsense. To use the analogy of a train, our ancestors had “derailed” themselves by turning to paganism; Christ simply put us back on track.

And we stayed on track for many centuries. It has only been within the past few decades that Christianity has seriously been derailed in Europe and other white countries. How did this happen? It is the result of a concerted antichrist effort to wipe out white Christian nations and Christianity itself. It is the same Canaanite game from centuries ago, only the tactics differ in some ways. Our countries have been flooded with hostile third-world people of different religions. These non-whites hate us, envy us, want to devour our livelihood, and when our resources are gone, they will turn on us with a murderous vengeance. Our governments and educational systems have been infiltrated so as to undermine Christian values and laws. Nearly every deviance is now tolerated under the mirage of “human rights.” Soon enough, under this same banner, all deviancies will be tolerated and even celebrated, including the worst offenses of the pagan world.

European Christian Colonies all Over the World

Now antichrists in positions of power proclaim that Europe is “post-Christian” and “religiously and culturally diverse.” White Europeans for the most part have been blindsided by these sustained attacks made in the name of progressive liberalism over many years precisely because we have not known our true identity as descendants of the ancient Israelites and inheritors of the promises and prophecies of the Bible. Nevertheless, Christianity stood strong on the European continent for well over one thousand years, and in some countries, nearly two thousand, and it took deliberate subversion from within by the enemies of Christianity to change that.

Throughout the centuries, wherever white Europeans set up colonies or nations (such as the United States of America), these were Christian colonies and nations. No European pagan colony or nation was ever formed or even proposed. Our ancestors were truly Godly people who took their faith seriously. We see this especially in the creation of America, Canada, South Africa, Australia, and New Zealand. These lands became large and powerful nations for the most part, and their morals and laws were based on Christian laws and the Bible.

On the other hand, no non-white Christian colony or nation has ever existed. Not a single one. Christianity is white. Any semblance of Christianity in a non-white country was brought by whites and enforced by whites, and once the whites left, that country did not remain a Christian country in any meaningful way. Why is that? According to Christ’s words, these non-white nations do not hear His voice because they are not His sheep. Only the white race are His sheep. Throughout history, only one race has been Christian and no other race.

Since Christianity is a continuation of the Bible, the New Testament after the Old Testament, the New Covenant after the Old Covenant, is it not logical to conclude that the Christian people, the white Europeans, must be the Israelite people of the Bible? Furthermore, since the ancient Israelites were white, how can any race of non-whites possibly be Israel?

Percentage of Christianity Throughout White Nations

Some subverters try to rewrite history and claim that Christianity in white countries was only the “major” religion among many. Supposedly, white lands were rife with paganism and other non-Christian religions all along. But this is ridiculous. Even as late as 1948 in America, 69% of Americans were Protestant and 22% Catholic. Only sixty years ago, at least 91% of Americans were Christians. You’ll find similar statistics in all white nations. For example, Australia. Christianity came to Australia with the arrival of the first fleet of white British convicts in 1788. Christianity grew in Australia to account for 96.1% of the population at the time of the Federation of Australia in 1901.

America, in particular, has been an exceptional Christian nation in several ways. Once the Americans became independent from British rule and King George III, they became very similar to Israel during the period of the Judges. Americans were ruled by a constitution, not a king. The American Constitution put God and His law above everything else, thus making America a truly Christian nation. To see the Christian commitment of the Founding Fathers and early presidents of America, all we need to do is look at some of their writings about God, the Bible, and Christianity. Here are a few of their quotations:

“It is impossible to rightly govern a nation without God and the Bible.” — George Washington, First U.S. President, farewell speech on Sept. 19, 1796

“I am a real Christian – that is to say, a disciple of the doctrines of Jesus Christ.” — Thomas Jefferson, Founding Father, 3rd President of the United States, *The Writings of Thomas Jefferson*, p. 385.

“Cursed be all that learning that is contrary to the cross of Christ.” — James Madison, Fourth U.S. President

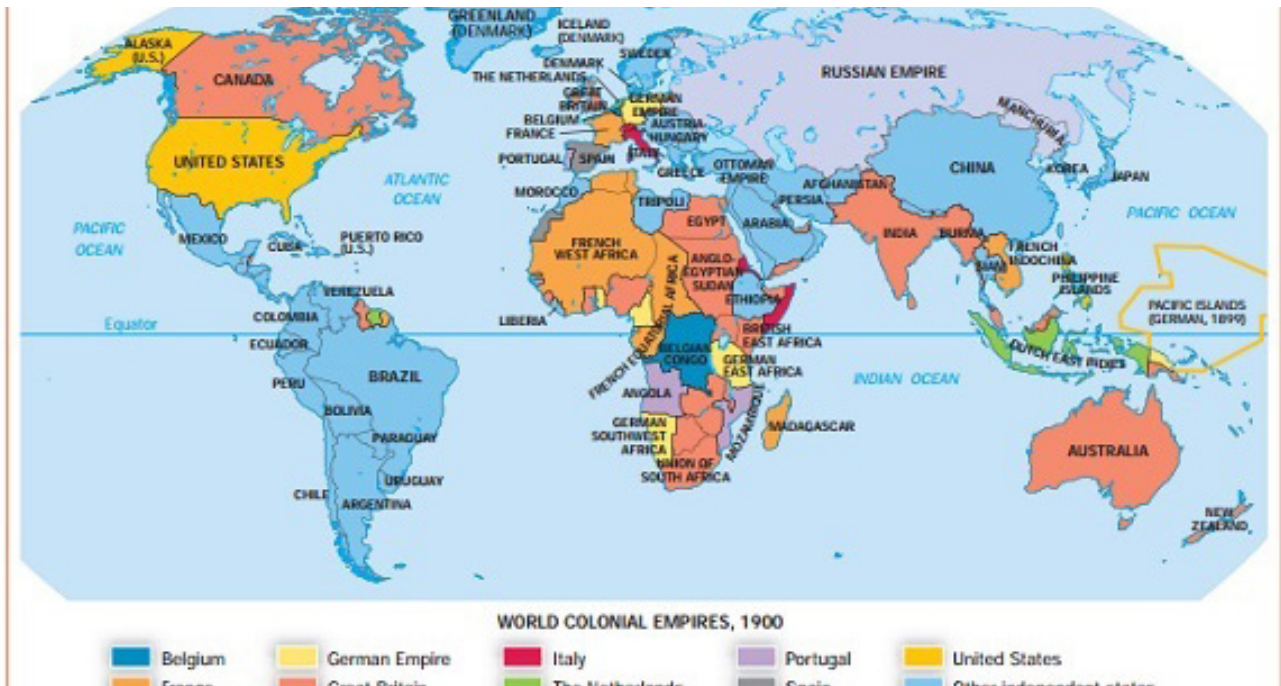
“The hope of a Christian is inseparable from his faith. Whoever believes in the divine inspiration of the Holy Scriptures must hope that the religion of Jesus shall prevail throughout the earth. Never since the foundation of the world have the prospects of mankind been more encouraging to that hope than they appear to be at present time. And may the associated distribution of the Bible proceed and prosper till the Lord shall have made ‘bare his holy arm in the sight of all the nations, and all the ends of the earth will see the salvation of our God (Isaiah 52:10).’” — John Quincy Adams, Sixth U.S. President

These words represent sincere Christian convictions from several Founding Fathers and early presidents of America. There has been a long and concerted effort to deconstruct the Christianity of these leaders, often through manipulation of partial quotations. But America

was founded overwhelmingly by Christian men and women who recognized the necessity of Christian morality in public and private life. Despite the modern antichrist culture — which despises Christian law and religion — and bitterly mocks Christian convictions, these words are the words of men who strove to enact a white Christian government.

To recap, historically once white Israelite nations converted to Christianity, they never went back. No white Christian nation has ever by itself sunk back into paganism or into atheism and secularism. The key phrase here is “by itself.” Today, all the Christian nations have been systematically infiltrated by satanic and antichrist forces who have undermined Christian government, law, morals, and society, and even Christianity itself. But God is not mocked. The antichrist may tear down Christian nations for now, but Yahweh’s plan for mankind will prevail.

4) *Jacob's Seed to Spread Across the Whole World*



“And thy seed shall be as the dust of the earth, and thou shalt spread abroad to the west, and to the east, and to the north, and to the south: and in thee and in thy seed shall all the families of the earth be blessed.” Genesis 28:14 KJV

The Bible clearly states that Jacob's seed was destined to spread across the entire world. The Israelites were never supposed to be limited to the land of Canaan. Yahweh had bigger plans for us right from the beginning. These prophecies of expansion were given early on to the patriarchs Abraham, Isaac, and Jacob in Genesis 28:14: “And thy seed shall be as the dust of the earth, and thou shalt spread abroad to the west, and to the east, and to the north, and to the south: and in thee and in thy seed shall all the families of the earth be blessed.”

Yahweh promised that Jacob's seed (the children of Israel) would become a vast multitude and spread to all corners of the world: north, south, east, and west. In them and because of them, the world would be blessed. And this wasn't the only prophecy. At the time of his death, Moses blessed the Israelites and prophesied that “the horns of Joseph” would drive the Israelites to “the ends of the earth” Deut. 33:17. Later around 700 BC, the Prophet Isaiah spoke Yahweh's promises to the Israelites who were being deported by the Assyrians: “He [Yahweh] shall cause them that come of Jacob to take root: Israel shall blossom and bud, and fill the face of the world with fruit” Isaiah 27:6. This fruitfulness would happen at a future time, after the punishment of the deportations.

The fact that both Moses' and Isaiah's prophecies were similar to the Patriarchs' and were given hundreds of years later shows that the original promises to the Patriarchs were yet to be fulfilled. Even though the Kingdoms of Israel and Judah had been established by the time Isaiah was writing to the Israelites who were being deported by the Assyrians, the Israelites had yet to spread across the entire world. We will show how the seed of Jacob gradually

migrated into Europe. From those massive migrations over many centuries, it becomes obvious that the Europeans and only the Europeans (the new name for the seed of Jacob) fulfilled these prophecies, primarily through European colonization and especially through the British Empire.

With these prophecies in mind, let's step back and ask a basic question: "What race has spread across the entire world?" Because whatever race has fulfilled these Bible prophecies, that same race is the recipient of the promises. That race alone is the true seed of Jacob. Over the past few thousand years, only one race — the white Europeans — has spread across the earth, populated every continent, and brought the blessing of Christian civilization with them. Only the Europeans have accomplished this. This is proof that white Europeans are truly the descendants of Jacob, the true Israelites, the true people of Yahweh who is the God of the Bible. To claim that any other people have fulfilled these prophecies is to deny Scripture, mock reality, and to engage in self-deception.

When we look at maps from over a century ago, we clearly see the extent of white European civilization and colonization. That was the result of the deportations of the Israelites and their migrations to Europe (including Russia) and from Europe to Greenland, Iceland and then during the colonization periods to the rest of the world: North, Central, and South America; Canada; Australia; New Zealand; Africa; India; and even but to a lesser degree the Middle East, China, and Indonesia. There is no place on earth that our people and race have not settled. We are everywhere and wherever we settled, we have brought the civilizing effects of Christianity. No other race throughout history can claim to have fulfilled these prophecies; therefore, no other race can be Israel except the European race.

Let's look more closely at how this Scriptural prophecy unfolded through the migrations of the Israelites. Ancient historians and ancient historical inscriptions record these journeys. To fully grasp the prophecies and the real identity of the Israelites, we must first be familiar with the ancient migrations of the seed of Jacob. We must uncover the truth of history as it unfolded under the hand of Yahweh, and not read antichrist propaganda back into history.

The Untold Story of the Exodus

It might come as a surprise, but not all the Israelites followed Moses into the desert. In fact, the first Israelite migration of any magnitude happened right at the beginning of the Exodus when a large swath of Israelites stuck out for Europe in ships. Unfortunately, most of our people today are unaware of this early migration to Europe; this ignorance is due to the fact that real history is no longer taught in schools. This group of Israelites sailed to Anatolia and Greece and lands that would become Europe. But most Westerners are familiar with the story of Moses and the Exodus, at least in outline. The Israelites were liberated from Egyptian slavery, wandered forty years in the desert, and finally entered the Promised Land of Canaan.

Historian Diodorus Siculus recounts the Exodus from Egypt and confirms that the Israelites split into two groups; the smaller one sea-bound for Europe; the other on foot following

Moses to the land that would be called Judea by the time of Siculus. We must note, however, that even this great historian made a few errors. He stated that Canaan was uninhabited. But the land was inhabited by Canaanites, as the Scripture records.

“The Aliens [Israelites] were driven from the country [Egypt], and the most outstanding and active among them banded together and, as some say, were cast ashore in Greece and certain other regions, their leaders were notable men, chief among them being Danaus and Cadmus. But the majority of the people descended into a country not far from Egypt, which is now called Judaea and at that time was altogether uninhabited.

“The leader of this colony was one Moses, a very wise and valiant man, who, after he had possessed himself of the country, amongst other cities, built that now most famous city, Jerusalem, and the temple there, which is so greatly revered among them. He instituted the holy rites and ceremonies with which they worship God; and made laws for the methodical government of the state. He also divided the people into twelve tribes, which he regarded as the most perfect number; because it corresponds to the twelve months within a whole year...” (Diodorus Siculus, *Bibliotheca Historica*, 40.2-3)

Danaus and the Danaans Greeks

The break-away group of Israelites who reached the shores of Greece is known as the Danoi (Δαναοί by Homer). Danoi is generally translated into English as Danaans, which indicates that they were primarily Israelites from the tribe of Dan. Greece was already largely inhabited by the Ionians, who were also known as “Yavana,” since they were descended from the Biblical patriarch Javan, son of Japeth. Among the Israelites (Danaans) were two notable leaders called Danaus and Cadmus, as noted by Diodorus Siculus.

Danaus is called “Danaus the Egyptian,” whilst Cadmus is known as “Cadmus the Phoenician.” Danaus, who led the Danaans, was said to have been a son of a Pharaoh of Egypt named Bellah. He is reputed to have led the Danaans to where they settled in Achaea (Ἀχαιοί Akhaioí), Argos being their most prosperous city and for that reason, the Danaans are sometimes called Achaeans in the Greek Histories.

“They say also that those who set forth with Danaus, likewise from Egypt, settled what is practically the oldest city in Greece, Argos.” (Diodorus Siculus, *Library of History*, 1.2)

Whilst we can trace no such man called Danaus in the Biblical Exodus account nor in the history of Egypt, we can assume a foundation of truth undergirding the Greek myths and legends centered around Danaus. He is likely the patriarch Dan of the tribe of Dan, one of the twelve sons of Jacob (Israel), whose mother was Bilhah (see Gen.30:1-6). Dan lived several centuries before the Exodus. The tribe of Dan habitually named everything after their patriarch, including themselves. Perhaps the Greeks and their historians assumed that the eponymous patriarch Dan led the Danaans and did not fully understand the origin and history of the tribe of Dan. Most likely a large number from the tribe of Dan migrated to Greece instead of following Moses into the Sinai desert.

Cadmus and the Phoenicians

The noted leader Cadmus was reputed to have founded the city of Thebes, which became a Phoenician colony. This is probably why he was called “Cadmus the Phoenician.” He introduced the Hebrew/Phoenician alphabet into Greece, and this alphabet gradually became the common alphabet throughout all of Greece. Although he was known as a Phoenician, Cadmus was an Israelite. That’s because the Phoenicians were Israelites (which we’ll get to shortly) and were among the waves of Israelites who were moving north and west and colonizing Europe.

“After this Cadmus, they say, in accordance with the oracle he had received, founded Thebes in Boeotia.” (Diodorus Siculus, Library of History, 5.49)

“These Phoenicians who came with Cadmus and of whom Gephyraens were a part brought with them to Hellas, among many other kinds of learning, the alphabet, which had been unknown before this, I think, to the Greeks. As time went on the sound and form of the letters were changed.” (Herodotus, Histories, 5.58)

Darda and the Trojans

Legendary Troy is another great civilization that seemed to have appeared from nowhere around the same time that the Israelites were spreading into Europe. Yahweh promised that Abraham’s stock would produce many nations and many kings. Abraham’s great-grandson Judah was assured that his tribe would be the kingly tribe. Judah had twin sons, Perez and Zerah. From the bloodline of Perez came King David, King Solomon, and others. But what kings came from Zerah? His sons are listed in the Bible:

“The sons of Zerah: Zimri, Ethan, Heman, Kalkol and Darda—five in all”(I Chronicles 2:6).

But after these sons are named, they disappear from the Bible. Around the time of the Exodus from Egypt, Zerah is mentioned and he is with his twin brother, Perez. But only the sons of Perez are present. Meanwhile, in Greek history of the same period, famous kings seem to appear out of nowhere with the same names as the sons of Zerah. Calchol (Kalkol) is linked to the Milesians, who later became Irish kings. A King Darda arose in the Troad (West Coast of Turkey), where he founded a colony named Dardania. His people were the Dardanians.

“Of these children Dardanus, who was a man who entertained great designs and was the first to make his way across to Asia in a makeshift boat, founded at the outset a city called Dardanus, organized the kingdom which lay about the city which was called Troy at a later time, and called the peoples Dardanians after himself.” (Diodorus Siculus, Library of History, 4.75.3)

Darda’s grandson named Tros founded the City of Troy, which he named after himself. The city of Troy and the Trojans became even more prosperous than Dardania and the Dardanians and grew large and wealthy enough to eclipse them. So we can see that the Trojans were Israelites from the tribe of Judah, coming down through Zerah.

“To Erichthonius was born a son Tros, who called the people of the land Trojans, after his own name.” (Diodorus Siculus, Library of History, 5.48)

Zerah’s son Calchol became the Kings of the Milesians, a colony in the southern part of Anatolia (Southwest coast of Turkey). Milesia did not rise to prominence until after the Trojan War. Calchol was another Israelite who founded a great civilization and a kingly bloodline. Throughout history, many kings have claimed descent from the Trojans or the Milesians, or even both. Clearly, these were among the nations and kings promised to Abraham which were to come through Judah. And indeed they were kings of great renown, and that is even recorded in Scripture. A few centuries after the Trojan War, King Solomon is compared for his wisdom to these very kings, most notably Calchol and Darda.

“For he was wiser than all men; than Ethan the Ezrahite, and Heman, and Chalcol, and Darda, the sons of Mahol: and his fame was in all nations around about” I Kings 4:31 KJV.

If Solomon, reputedly the wisest man who ever lived, is compared to these men in wisdom, then these men must have been considerable men of renown. If not then why would Solomon be compared to them? If they were insignificant men, the comparison would be senseless. But knowing that these men founded great dynasties that have lasted to this day and that they were kings of Judah just like Solomon, we can fully understand why the comparison is made in our Bible. The name “Mahol” could be a title meaning “greatness,” as in the “greatness of Darda” and so on. This greatness, this wisdom is our history.

The Colonization of the Phoenicians

The Israelites who followed Moses out of Egypt conquered Canaan and settled there. Around that time, we see the rise of another great civilization, the Phoenicians, which was another “kingdom” coming forth from Israel. Originating from the coast of Israel, the Phoenicians were a confederation of Israelite maritime traders. They gradually set up outposts, seaports, and colonies all across the Mediterranean, reaching as far west as Iberia (Spain) and as far north as Gaul (France), Albion (the British Isles), and Hibernia (Ireland).

Modern historians outright lie and say the Phoenicians were Canaanites, but they weren’t. They couldn’t have been. The Phoenicians only appeared after the conquest of Canaan, during which the Canaanites suffered heavy losses. The Phoenicians were Israelites from the northern coast of Israel, most notably from the seaport cities of Tyre and Sidon, both within the tribe of Asher’s territory. The name Phoenician comes from the unique purple dye from certain seashells that the traders specialized in. At the time, purple dye was rare and valuable. Phoenicians used this purple dye on their sails and banners and thus earned the name Phoenicians, which means purple people.

There are other reasons why the name Israelite was eclipsed by the appellation Phoenician. Most of Greek history (or at least that which survives) was written by Ionian Greeks from the line of Japeth (Adamic but not Israelite). Most of the Ionian Greek historians lived and wrote in Athens, their most populous and powerful city. These Ionian Athenians wrote history from

their own perspective. Most likely, they lacked a thorough knowledge of the true Israelite roots of the Phoenicians. These Ionian records make up the history that comes down to us today, but the records are not complete. Regardless of the speculations of modern historians, the Phoenicians were Israelites and not Canaanites.

The City of Tyre was a stronghold of the Phoenicians. By the time King David ruled over all of Israel, the city had grown powerful enough to demand their own king and gain a certain amount of autonomy. The King of Tyre ruled his own territory but acknowledged David as his superior. The Phoenician colony of Carthage, the powerful city-state on the north coast of Africa, was said to have originated from Tyre. So we can see that Carthage as well as Thebes (from Cadmus, one of the leaders of the original migration from Egypt to Europe) were great cities originating from the Phoenicians. After the fall of the Kingdom of Israel and the Assyrian and Babylonian deportations, these Phoenician colonies, which by that time had spread all over the Mediterranean and West Europe were cut off and would now be forced to fend for themselves. Carthage was the most prominent of these colonies and rose in power over the centuries. It is most notable for its rivalry and wars with the Romans. However, most of Europe, including all these Phoenician colonies and even Carthage would gradually come under Roman dominion, which resulted in the loss of their history and knowledge of their true origin.

The Dorian invasion into Greece

It's helpful to remember that Greece was a collection of tribes with a common culture. The Dorians invaded Greece shortly after the Trojan War. They would become the third major tribe in Greece, after the Danaans and the Ionians. The Dorians primarily became the Lacedaemonians and Macedonians. The Lacedaemonians territory was in the southern part of Greece which most famously included the city Sparta and thus the Lacedaemonians are often called Spartans. The Macedonians were to the north and are best known, of course, for Alexander the Great who united Greece and conquered the Middle East.

Modern historians try to claim that the Dorians came from the north; however, that is completely mistaken and wrong. Homer describes the Dorians as invading from the sea, not northern territories. Furthermore, Homer says the Dorians inhabited the Island of Crete before they invaded Greece. The Dorians were Israelites who originated from the City of Dor in the territory of Manasseh. "Dorian" means "people of Dor" or "people from Dor." Dor was a major seaport city along the southern coast of Israel. Another nearby seaport city was Joppa, in the territory of Dan. It is reasonable to imagine Israelites sailing from Dor to Greece on a conquest venture. The island of Crete served the Dorians as a place to gather strength and then launch a full-scale invasion of Greece.

Further historical proofs linking Dor to the Dorians are the many so-called Greek artifacts that have been found by archaeologists in and around the location of Dor in Palestine. Of course, that narrative gets the reality backward. These are not artifacts from Greece. These are ancient Israelite artifacts from Dor. The Dorian Israelites brought their artistic culture with them to Greece and continued to develop it there, but they also must have left some artifacts

behind. Further evidence that the Dorians were Israelites is found in Josephus, in his record of a letter written by a Spartan (or Lacedemonian, who were also Dorian Greeks) king to Jerusalem about 160 B.C., which is found in Antiquities 12.4.10 (12:226-227):

“Areus, King of the Lacedemonians, To Onias, Sendeth Greeting. We have met with a certain writing, whereby we have discovered that both the Judaeans and the Lacedemonians are of one stock, and are derived from the kindred of Abraham. It is but just, therefore, that you, who are our brethren, should send to us about any of your concerns as you please. We will also do the same thing, and esteem your concerns as our own, and will look upon our concerns as in common with yours. Demotoles, who brings you this letter, will bring your answer back to us. This letter is foursquare; and the seal is an eagle, with a dragon in his claws.” Josephus records a reply from Jonathan the High Priest in Antiquities 13.5.8 (13:163-170), thus verifying the authenticity of King Areus’ letter.

The Dorians gave rise to the Spartans. The Spartans were described as fair and white, so obviously the Dorians must have been fair and white. The Dorians came from the Israelites so the Israelites must have been fair and white. It is the law of genetics that white can only come from white. Kind after kind is mentioned many times in the creation account in Genesis. Race is a genetic fact, not a social construct.

The Israelite Dorians and the earlier Israelite Danaans gradually overwhelmed the Ionian Greeks (Javan), the descendants of Japheth, who originally inhabited Greece. Japheth, a son of Noah, was a white Adamic man but not an Israelite. The Israelites were Adamics who came through Noah’s son Shem and his descendant Abraham. Yahweh chose to extend His covenant through Abraham. This phenomenon of the Israelite tribes subjugating, ruling over, and assimilating the Adamic tribes would continue all over Europe and the entire Adamic world. We will explain this in more depth in later Proofs.

Rome Originating from the Trojans

The Romans followed the Greeks. In time, Rome became an empire that ruled the world, and it was under the Roman Empire that Yahshua (Jesus) Christ was born. The Romans originated from the Trojans. In other words, the Romans were also Israelites. Most people know about the Trojan War and the sacking of Troy by the Danaan Greeks (and the story of the Trojan Horse). What many people don’t know is that a remnant of Trojans survivors fled Greece and after a long, meandering voyage settled in Italy.

This remnant was led by Aeneas, a prince of Troy and cousin of the famous Hector of Troy. Aeneas and his men sailed around the Mediterranean, wandering for several years until they finally settled in Latium, Italy. Aeneas married the daughter of the King of Latium, and in time, Aeneas became king and founded a dynasty of kings. The fact that the Trojan remnant settled in Latium is the reason the later Roman language was called Latin. Centuries later, a descendent of Aeneas named Romulus founded the city of Rome.

As time passed, Rome began to conquer and absorb the surrounding city-states. The city of Rome’s power and influence grew and eventually, Rome became the Roman Republic

(although technically it was already an empire already by this stage). Then came the famous Roman Empire ruled over by Emperors. Since the Trojans founded Rome and the Trojans came from Judah through Zerah, the Romans were also the descendants of Judah and thus were Israelites. The history of Aeneas, his journeys, the founding of Rome, and thus the descent of Romans from Trojans is confirmed by Strabo.

“...The wandering of Aeneas are a traditional fact...” (Strabo, Geography, 3.2.13)

We also find proof that the Romans were Israelites in the Bible. In Paul of Tarsus’ epistle to the Romans, he states that they (the Romans) once knew Yahweh (only the Israelites had known Yahweh) but that they had corrupted their belief in God and turned Him into a man, adding a whole pantheon of lesser gods and even beasts.

“Because knowing Yahweh, they thought of Him not as God, nor were they thankful; but they became foolish in their reasonings, and were darkened, their hearts void of understanding: alleging to be wise they became fools, and they changed the estimation of the incorruptible Yahweh into a resemblance of an image of corruptible man, and birds, and four-legged animals, and reptiles” Romans 1:21-24 CNT.

It’s crucial to note that according to Scripture, the only people who ever knew Yahweh in the first place were the Israelites. Of all the families or nations on the earth, Yahweh knew only the family of Israel, and only the family of Israel knew Yahweh. Paul was well aware of the fact that Yahweh has revealed Himself and His laws only to the Israelites. “He showeth his word unto Jacob, his statutes and his judgments unto Israel. He hath not dealt so with any nation: and as for his judgments, they have not known them. Praise ye the Lord!” Psalm 147:19, 20, KJV. Yahweh’s covenant was only ever with Israel, so for Paul to claim that the Romans once knew Yahweh shows that the Apostle understood Rome’s origin as dispersed and punished Israelites.

“You only have I known of all the families of the earth: therefore I will punish you for all your iniquities” Amos 3:2 KJV.

Interestingly and tellingly, the name of Jupiter, the chief Roman deity, combined two words: Jove and Pater. The meaning is “Father Jove” or “Jove the All-Father” or perhaps “Jove the Father God.” The letters J and V are both later additions to the English language, so the Romans spelled Jove with an “I” and an “au,” resulting in “loue,” a word with four vowels. In old Latin, loue was pronounced like Yahweh. “Pater,” of course, means “father.” This name of the main Roman pagan god is a strong indication that the Romans carried with them into their dispersion and paganism the dim memory of Yahweh the Father God. Paul must have noticed these traces of the name of Israel’s God’s name buried deep within the Roman religious memory and imagination.

The Rise of the Parthians

One more major civilization arising through the Israelite dispersion was the Parthians. So

far, we've traced the migrations of various groups of Israelites into Europe, but not all the Israelites migrated elsewhere after their initial deportation into the Caucasus region. Some Israelites remained there and eventually dominated that entire area. We know them as the Parthians.

After deporting the Israelites to the Caucasus area, the Assyrians ruled the Middle East for over another century. The Assyrian policy was to invade, annex, then depopulate the annexed region of its native people, moving them elsewhere in the empire as they had done with the Israelites. No doubt this tactic of domination and deportation was aimed at preventing uprisings. However, the tyranny eventually backfired. Various tribes within the empire, notably the Scythians, Persians, and Babylonians, joined forces and attacked the Assyrian capital city of Nineveh. This led to the destruction of the Assyrian Empire.

After the fall of Assyria, large masses of Scythians had begun migrating into Europe (see Proof 1). This left a power vacuum that the Babylonians filled; they seized all the formerly Assyrian territory and created the Babylonian Empire. But in time, the Persians in an alliance with the Medes overthrew the Babylonians. Then Alexander the Great of Macedonia crushed the Persian Empire. Alexander resettled a lot of Greeks, especially Macedonians, in the Parthian lands. As we explained earlier, the Macedonians were Israelites. So the racial reality of Alexander's empire and of the later Seleucid Empire was that they were Israelite empires ruling over Israelites and mixtures of other Adamic tribes, such as Assyrians, Persians, Babylonians, and Medes. After Alexander's death, his four generals carved up the Macedonian Empire, which reached from northern Greece to as far east as India and as far south as Egypt. Each general took a chunk of territory and created his own empire and dynasty.

Originally the Parthian lands were part of the Macedonian Empire east of the Caspian Sea (roughly equivalent to modern Iran). General Seleucus, Alexander's infantry general, gained the Parthian territory in the Middle East and the Far East. He gave his name to the Seleucid Empire.

But long before that happened, most of the Israelites had been deported to the Parthia region by the Assyrians. While some of these deported Israelites soon set out for other lands, others remained. No doubt, other Adamic peoples lived in those regions, notably the Medes. Historian Strabo tells us that during the Seleucid Empire period, the lands of Parthia was invaded and conquered by two tribes in particular, which he identifies as the Arsaces and Däae, and that both of these tribes were of the Scythian (or Israelite) stock.

So it was that at the onset of the Seleucid takeover, the Parthian lands and surrounding areas were largely populated with Israelites. Strabo explains that the most notable Israelite tribe, the Arsaces, were weak at first due to being continually at war. But they grew strong and conquered so much neighboring territory that they established themselves as lords of all the country inside the Euphrates.

According to Strabo, the tribes of Däae, Massagetae, and Sacae were also Scythians. These Däae, Massagetae, and Sacae were spread throughout the entire region. It did not take long for these Israelites in the lands of Parthia to become independent of Seleucid rule, whilst the

other tribes and regions — some Assyrians, Medes, Babylonians, and a mixture of Scythians and non-Israelites — remained under Seleucid dominion. But the Israelites in Parthia not only threw off Seleucid rule, but they gradually conquered all of the surrounding regions. Since their conquests began from Parthia, their later empire was called the Parthian Empire. This name reflects the geographic fact that the Israelites waged their conquest from the land of their deportation, Parthia.

By the second century BC, the Parthians had risen up and pushed the Seleucid Empire aside. The Parthians gained hegemony over the entire Eastern world, establishing their own Parthian Empire which rivaled the previous Assyrian, Babylonian, and Persian Empires, except this time it was Israelites in power first under the Seleucids and then under the name Parthians.

Every Israelite king in Parthia was given the surname “Arsaces.” This name may be a combination of two Hebrew words: Ar and Saka. The word “Ar” means mountain, high point, and hilltop. “Saka” is the name the Persians called the Israelites. When put together, the two words may mean “highest of the Saka.” If you believe (as many do) that the word “Saka” comes from the name of the Patriarch Isaac, then “Arsaces” would mean the “highest of Isaac,” the title given to the man who ruled over the Israelites (although this linking of Saka with Isaac is speculation rather than proven historical fact).

It should be noted that when the Israelite kings ruled over the region, the Parthians were known as the Arsaces, and the Parthian Empire was called the Arsaces (or Arsacid) Empire. As we’ve already noted, “Saka/Sacae” sometimes with the addition of “Suna” was the name the Persians originally gave to the Israelites. That is (or is highly probable) where the name Saxons (Sacae-Suna) comes from. Although, again, this is much-debated speculation. So the alternative names for Parthia — Arsaces along with Saka/Sacae-Suna — may well come from the same origins as does the name Saxons. This Arsaces name shows us linguistically that these people are the same as the Germanic Saxon/Scythian tribes who had migrated to Europe.

The Parthian Empire lasted about four hundred years. They were most notable for constant back-and-forth wars with the Romans. At various times, the Parthians were involved in the affairs of Judea and Syria. The Romans had conquered both those territories shortly before the birth of Christ. Because the Parthians had occasionally been involved favorably with Judea, the historian Josephus (born shortly after Christ) wanted his books to spread to the “Upper Barbarians” throughout the Parthian Empire. Josephus knew that the Parthians were Israelites. In the preface to his book Wars of the Judeans, he states that he wanted to give a balanced account of the wars, not a biased Roman perspective. No doubt he hoped that his histories would influence the Israelites (Parthians) to the north to assist the Judeans in overthrowing the Romans. But that alliance did not happen. Also, Josephus was ignorant of the fact the Romans were also Israelites.

“... and while those that were there present have given false accounts of things, and this either out of a humor of flattery to the Romans, or of hatred towards the Judeans; and while their writings contain sometimes accusations, and sometimes encomiums, but nowhere the

accurate truth of the facts; I have proposed to myself, for the sake of such as live under the government of the Romans, to translate those books into the Greek tongue, which I formerly composed in the language of our country, and sent to the Upper Barbarians... “

Josephus describes the tribes of Israel as an immense multitude beyond counting who lived beyond the Euphrates River. This area beyond the Euphrates was essentially the region of the Parthian Empire. The people within the Parthian Empire must have been an innumerable multitude of Israelites. If they were not, then what the hell is Josephus talking about?

“So he (Ezra) read the epistle at Babylon to those Judeans that were there; but he kept the epistle itself, and sent a copy of it to all those of his own nation that were in Media; and when these Judeans had understood what piety the king had towards God, and what kindness he had for Ezra, they were all greatly pleased; nay, many of them took their effects with them, and came to Babylon, as very desirous of going down to Jerusalem; but then the entire body of the people of Israel remained in that country; wherefore there are but two tribes in Asia and Europe subject to the Romans, while the ten tribes are beyond the Euphrates till now, and are an immense multitude, and not to be estimated by numbers” (Josephus, Antiquities, 11.5.2).

Josephus called the immense multitude “the ten tribes.” This is unfortunate because, in reality, all twelve tribes were present in the multitude beyond the Euphrates. This ten-tribes error has persisted to this day, especially amongst “British Israel” people, and it needs to be corrected. Even the Apostle James speaks of “... the twelve tribes which are scattered abroad ...” James 1:1. When the Assyrians deported Israelites from Judea, they also deported Israelites from the villages, towns, and cities around Jerusalem. But they failed to conquer Jerusalem and deport its people, who were mainly the tribes of Judah and Benjamin. Nevertheless, the Assyrians deported people from all twelve tribes who lived outside of Jerusalem. Because Jerusalem was populated largely by Judah and Benjamin, it was an easy mistake to think that only ten tribes had been deported. This error has led to the belief that only ten tribes went to Europe; this is wrong because all twelve tribes were deported except for Jerusalem (at least at that time). With those facts in mind, perhaps a more accurate rendition of Josephus’ words would have been: “There are but a small remnant of two tribes left in Judea, whilst there are twelve tribes of Israel spread throughout Parthia, Asia, and Europe. They are an immense multitude and not to be estimated in numbers.”

After the tragedy of the Assyrian deportation, the Israelites living in Jerusalem began to spread out from Jerusalem and repopulate the surrounding areas. Then about one hundred years after the Assyrian deportations, the Babylonians invaded, conquered, and deported everyone, including the people in Jerusalem. Thus what was left of Judah and Benjamin under the Assyrians were deported under the Babylonians. When a remnant of Israel returned under King Cyrus to rebuild the temple, that number was barely over 40,000.

Europe by the Time of Christ

Once we know about the early migrations of the Israelites and grasp the wide scope of

their travels, we can more clearly see the big picture: the whole Adamic world had become an Israelite world. This happened as the early Israelites migrated to Greece; later the Phoenicians colonized the coasts of the Mediterranean Sea and the West of Europe; the Trojan/Romans gradually expanded over all of Italy and then gained control over most of Europe; the Germanic tribes migrated and dominated the North/East of Europe; and finally, the Parthians rose to rule all the Middle East. Truly Yahweh's promises to Abraham have been fulfilled.

All the former Adamic nations had been transformed into Israelite nations. Just because Yahweh had given the land of Canaan to Israel did not mean that Israel was confined to the Promised Land forever. So even before Moses' Israelites entered Canaan, other Israelites were already beginning to fan out across the Adamic world. In time, Israel moved to the north and south, east and west, and eventually, the only nations remaining were Israelite nations. Slavs were white Adamic people but not Israelites. While these white Adamics are still amongst us, their nations tended to be short-lived. All white nations now are Israelite nations.

By the time of Christ, Europe was for the most part Israelite. An Israelite world was the perfect time and place for Yahshua Christ's ministry and for his Gospel to be preached and spread to His people. Since the white Adamic world had been replaced with His chosen people, the Israelites, they would all naturally accept Christianity and naturally transform into Christian nations, bringing any remaining Adamics with them.

Christianized Europe — the seed of Jacob — then colonized the world, creating new civilized white Christian countries. From Europe came all the other white nations and countries of the world, such as the United States of America; Canada; Australia; New Zealand; and South Africa. This historical arc fulfills the prophecy that Jacob's seed would spread to every corner of the earth. So it was prophesied and so it has happened.

5) To be Known by a New Name as Sons of God (Christians)



“The nations shall see your righteousness, and all the kings your glory, and you shall be called by a new name that the mouth of the LORD will give” Isaiah 62:2 KJV

The name Christianity is synonymous with Europe, and Europe has been synonymous with Christendom. Until recently, Christian has been our identity and our name. Throughout history, only one race — the white race — has called itself Christian. Even our European lands were known as Christendom until the last few hundred years. The name “Christian” did not happen by accident. It’s a fulfillment of Scriptural prophecy. Did you know the Bible predicts that Yahweh would give the name “Christian” to His people? He promised this “new name” (more on what this name is in a minute) to the genetic descendants of Israel and no one else. He did not promise this new name to all the peoples of the world, nor to any non-white nation, nor to random people within various nations who might profess belief in Him. Only to Israel.

God’s people have been known by many names — Hebrews, Israelites, Greeks, Romans, Saxons, and Celts, to name a few — but now, since the Messiah Yahshua Christ has come, His people are known collectively by one name: Christians. His people are one as He is one. His people belong to Him, so we are called by His name. The remnants of the tribe of Benjamin and Judah which were in Judea became Christian, as did the rest of all the twelve tribes scattered abroad all over Europe. Thus they all were called by one name, and returned to their rightful Creator, God, and Redeemer, Yahweh.

The tribes of Israel who once seemed lost to history have joined the first-century Israelites in Judah and become one family, called by the one name Christian, and returned to their rightful Creator, God, and Redeemer, Yahweh.

Children of Israel to be called the ‘Sons of the Living God’

We regard Yahweh’s promise of a new name for His people as sign and proof that those newly named people were and still are His redeemed ancient Israelites, the lost-but-found sheep of the house of Israel. This prophecy about their new name was given to the Prophet Hosea. Through Hosea, Yahweh spoke to the children of Israel about to be deported because of their sins, idolatry, and faithlessness. In effect, Yahweh was “divorcing” them through this tragedy of deportation. But He promised that one day He would redeem them (through Christ), they would be His people again, and they would be named after the Living God. They would be called Christians.

Yahweh instructed Hosea to “act out” this prophecy in a dramatic way, both through his choice of wife and the names of his children. As if to emphasize the importance of names, Yahweh revealed this prophecy of a new name through the names of Hosea’s future children. First, Yahweh instructed Hosea to marry a prostitute. This demonstrated how Israel was behaving toward Yahweh, their husband and God. As the husband of a whore, Hosea was a type of Yahweh, the husband of Israel who played the whore through her idolatry and unfaithfulness.

“The beginning of the word of the Lord by Hosea. And the Lord said to Hosea, Go, take unto thee a wife of whoredoms and children of whoredoms: for the land hath committed great whoredom, departing from the Lord” Hosea 1:2 KJV.

Hosea fathered three children in quick succession, and Yahweh instructed the prophet to give them specific names. These names would reveal what was about to befall Israel. Hosea named his first child, a son, Jezreel, which means “Yahweh scatters” or “Yahweh will sow.” This name indicated that Yahweh would scatter the children of Israel through deportations.

“So he went and took Gomer the daughter of Diblaim; which conceived, and bare him a son. And the Lord said unto him, Call his name Jezreel; for yet a little while, and I will avenge the blood of Jezreel upon the house of Jehu, and will cause to cease the kingdom of the house of Israel. And it shall come to pass at that day, that I will break the bow of Israel, in the valley of Jezreel” Hosea 1:3-5 KJV.

Hosea named his second child, a daughter, Loruhamah, which means “no mercy.” This name indicated that Yahweh would no longer tolerate or have mercy upon the children of Israel for their continuous whoredoms.

“And she conceived again, and bare a daughter. And God said unto him, Call her name Loruhamah: for I will no more have mercy upon the house of Israel; but I will utterly take them away.” Hosea 1:6 KJV.

Hosea named his last child, a son, Loammi, which means “not my people.” The children of Israel would no longer be His people but would become the “Lost Tribes.” History does indeed show that they lost their Israelite name and identity. As we explained in earlier Proofs,

they became the Cimmerians, Sacae, Scythians, Galatea and the Germanic and other tribes. Once again, we find that the Europeans fulfilled the prophecies made to the Israelites, this time as regards the tragedy of being scattered far from their home, with no mercy, and no longer His people. They went into the darkness and terror of the deportations and suffered the awful punishment of no longer being Yahweh's people because of their idolatry.

“Now when she had weaned Loruhamah, she conceived, and bare a son. Then said God, Call his name Loammi: for ye are not my people, and I will not be your God.”.Hosea 1:8-9 KJV

However, Yahweh's punishment was corrective in nature and not permanent. Even though scattered to foreign lands and their name forgotten, dispersed Israel would grow into an immense multitude in those European lands. Yahweh promised He would come after Israel, His bride, seek her out and save her. In His good time, He would gather in His dispersed people and call them by a new name, the sons of the Living God.

“Yet the number of the children of Israel shall be as the sands of the sea, which cannot be measured nor numbered; and it shall come to pass, that in the place where it was said unto them, Ye are not my people, there it shall be said unto them, Ye are the sons of the living God” Hosea 1:10 KJV.

That Living God was, of course, Christ. The apostles, particularly Paul, sought out dispersed Israel in the lands of Europe, where they had grown into a multitude past counting, particularly as the Germanic tribes. As the tribes of Europe accepted Christ, they were regathered under one Head, that Head being Christ God. They were given a new name — Christians — after the Living God, just as the prophecy had foretold.

“Then shall the children of Judah and the children of Israel be gathered together, and appoint themselves one head, and they shall come up out of the land: for great shall be the day of Jezreel” Hosea 1:11 KJV

The name Christian proves that the white race is Israel. But why does Hosea's prophecy use the term “Living God”? Let's take a closer look at that important detail.

Christ is the only true Living God

The Living God is, of course, Yahshua (Jesus) Christ. But how and why is He the Living God? Yahshua is Yahweh the Living God of Israel incarnated in the flesh as a living, breathing Adamic man. Yahshua came down from heaven and was born of the line of Judah for the salvation of His people, His family, the children of Israel. Only in the Bible do we find miraculous and amazing prophecies that God would become man out of love for His creation, Adamkind. These prophecies have been fulfilled. Israel had been sentenced to deportation because of her idolatry, which is the worship of false “gods.” These are idols of wood and stone and the deceit of devils. Nothing else. They are dead, not living. Yahshua Christ, who is Yahweh incarnated, is the only living and true God. He came in the flesh and called His people back from dead idolatry to Himself, the Living God.

Why the name “Christian”? Yahshua called Himself the Messiah (Christ in Greek) of Israel (Matthew 16:16-18) and after His resurrection, His apostles began preaching Him as the Christ. Acts 11:26 tells us, “And in Antioch, the disciples were first called Christians.” The timing and geography are significant. In the city of Antioch, the apostles moved beyond preaching in synagogues, as had been their habit. Now they boldly preached to and converted Hellenic Greeks. These Greeks were not “gentiles,” as was thought at the time, but they were actually descendants of the dispersed tribes of Israel. As the Gospel spread throughout Europe, the European peoples embraced the name of Christian. Christian means “the people of Christ,” since the Greek ending “-ian” means “people.” By adopting this name, the Europeans became a race named after the Living God, thus fulfilling the prophecy in Hosea.

Europeans must be the Israelites

Let’s put this Proof in its simplest form: Yahweh made an explicit promise that He would rename the Israelites as Christians. In all of history, only the white European race has been called Christian and their lands Christendom. The only logical explanation is the Europeans must be the ancient Israelites who were once deported and dispersed. You don’t need an IQ of 200 to work that out. Either the prophecy unfolded in history and Yahweh’s people are now called by His name, Christians, or Yahweh’s promises failed or were false. If we truly believe the Bible, then we’re forced to recognize how Yahweh’s word has been fulfilled.

The Europeans were His dispersed people. This is why the ancient Hebrews awaited the coming of Christ, but it was the Europeans who accepted Him en masse. The Europeans accepted Him precisely because they were the ancient Hebrews. What other race has even been identified primarily as Christians? The Africans? The Chinese? The Indians? None of them! Only white Europeans fulfilled this prophecy. Europe was even known as Christendom before the modern age when secularism got a firm foothold.

Furthermore, only Christians are His people, and only Christians are ancient Israel. Any people today who claim to be Israelites but hate Christ, Christians, and Christianity can not be the Israelites. In fact, they cannot even claim to follow the Hebrew/Mosaic religion of the Old Testament. Christianity alone is the continuation of the Old Testament. Therefore any usurpers masquerading as the people of the Bible, but rejecting Christ are liars.

“The nations shall see your righteousness, and all the kings your glory, and you shall be called by a new name that the mouth of the LORD will give” (Isa 62:2).

Our name is our identity. Yahweh gave us both. When we Europeans embraced our Christian identity and our Christian name, we became the historical reality foretold in Scriptural prophecies. We were lost, but now we are found. In accepting our identity, we fulfill the truth of God. The implications of these prophecies are staggering, and most Christians today still have to awaken to that reality. We white Europeans are the so-called lost tribes of Israel, the true Israelites. Yahweh sought us as a shepherd seeks His scattered sheep. He gathered us into one people, the Christian people, and He gave us His name, the people of Christ or Christians.

In times past, when Europe was Christendom, we understood that we were all brethren united under Christ our Savior. It's time that we recognize that truth again. We white people who live in these portentous times, let us not be ashamed to be known as Christians, to live as Christians, and to claim our historical reality as Israelites, lest Christ be ashamed of us on Judgement Day.

6) *Israel to have a New Home Located to the North West*



Would the Bible not give us a hint to where abouts or towards which direction the Lost Tribes would be heading to?

The enemies of Yahweh and His people like to claim that the ancient dispersed Israelites — those who broke away after the Exodus plus the millions deported by the Assyrians and then the Babylonians — just disappeared and are lost to history. Vanished without a trace. And they say this with a straight face. Or they conjecture fabulous tales such as that the Lost Tribes jumped onto boats and sailed for the Americans, intermixed with the natives, and faded away. Or that they scuttled south to Subsaharan Africa or trekked east to the Himalayas and Asiatic nations where they intermarried and lost their Israelite identity.

Anything and everything except that the Israelites went west and became the Europeans, most certainly did not fade away and are, in fact, with us today as the white race. No, the enemies of Christ can't have that. In fact, they shriek and howl that any mention that the Israelites became the white Europeans is "whitewashing" history, is hate speech, and is vile racism. These same forces seek to legally punish and silence those who insist on views that do not fit their agenda.

But what is the truth? Did the descendants of Jacob head to the African jungles? Or jump on ships to the Americas? Or disappear far off into the East of Asia? And if they did do these things, what then became of Yahweh's promises that Abraham would be the father of many nations? That kings would come of him? That through his Israelite descendants, the whole (Adamic) earth would be blessed? Was God so powerless that the Israelites just slipped through His fingers like sand and disappeared, due to miscegenation they were mixed out of existence and lost forever? His promises made null and void?

But that's what the enemies of God say happened. In addition, they want us to believe that the rag-tag group of descendants of Cain left in Judah in 70 AD are the true people of the Bible and not anti-Christ wandering merchants. That's just another lie to cover over the falsehood that the dispersed Israelites disappeared. These lies have so successfully permeated our culture and churches that it can be difficult to open our minds to a different version of history. But when we do, we see that these absurdities do not hold up to objective scrutiny. To find the truth, we need to search the Scriptures. Does the Bible tell us that the dispersed Israelites disappeared from history? Or does it do just the opposite? Does it tell us where they went geographically and where we might find them today? In order to discover the truth, we're going to examine what the Bible says and how secular historians support the Scriptural accounts.

The short answer is that the Bible does indeed paint a clear picture that Europe would be the Israelites' new home. Scripture says that the Israelites would migrate to the north and to the west, which points us towards the direction of Europe. Whilst the Bible does not explicitly say, "Then the Israelites went to Europe," it does essentially say this. It gives us this information when we study the prophets and match their accounts with ancient historical and geographical records. One prophet, Jeremiah, even addressed the deported Israelites who were already living in the lands that would become Europe.

In previous Proofs, we've shown that ancient Greek and Roman histories tell us about the migrations of the Israelites into Europe. To briefly recap, these histories recount the early Danaans' migrations into Greece soon after the Exodus from Egypt. Their arrival in Greece was later followed by the Dorian invasions and conquests of Greece. Centuries later, the Trojans also settled in Greece and later became the Romans. From the coasts of Israel, the Phoenicians colonized much of Europe. The Cimmerians, the Saca, and the Scythians all originated from the deported Israelites and migrated to Europe. The Gallic and Germanic tribes emerged from these migrating Israelites. Although the names of the Israelites changed over time, the people remained the same. History clearly shows us that the Israelites ended up in Europe.

In addition, in earlier Proofs, we've shown that the Bible states that the Israelites would be dispersed from the lands of Canaan as chastisement for their sins. But Yahweh never forsakes His people. He promised that at a later time to come down as a man to redeem them and that His apostles would preach His Gospel to the lost sheep of the house of Israel (who were scattered across the lands of Europe). This mission would result in the regathering of Yahweh's people into one people, the white Christian Europeans or Christendom. With that in mind, let's take a closer look at what Yahweh's prophets said.

Samuel's New Home

When King David ruled over the Kingdom of Israel, Yahweh promised him that one day the children of Israel would have a new homeland far away from the accursed Caananites. The lands of Canaan were never meant to be the permanent home of Israel. In fact, Canaan was far too small for the multitudes that the descendants of Israel would become. Let us

remember that the whole earth is the Lord's (Ps. 24:1) and Yahweh can settle His people wherever He chooses.



The prophet Nathan was standing in Jerusalem as he spoke this prophecy to David regarding the Israelite's destiny. "Moreover I will appoint a place for my people Israel, and will plant them, that they may dwell in a place of their own, and move no more; neither shall the children of wickedness afflict them any more, as beforetime" 2 Samuel 7:10 KJV.

Palestine never was "a place of their own" because the Israelites never fully drove out the Canaanites. As a result, they shared the land with these accursed people and were corrupted by them away from Yahweh's laws. To have a place of their own, the Israelites would need to find a land uninhabited or not assigned by Yahweh to any other Adamic nation. In Genesis 10, we learn that the land was divided amongst the Adamic nations (we'll cover these assignments in a later Proof). But for now, it's important to note that most of Europe was not assigned to any Genesis 10 nation. It would seem that Yahweh had reserved this region in order to assign it to the Israelites later.

We see the division of lands in Deuteronomy. "When the most High divided to the nations their inheritance, when he separated the sons of Adam, he set the bounds of the people according to the number of the children of Israel" Deut. 32:8 KJV. This is referring back to the time after Noah and his family left the ark. Yahweh then divided the lands amongst Noah's sons and their descendants. In other words, He divided the lands among the children of Israel who were alive at that time and those who were yet to come.

How were the lands divided? In Genesis 10, we're given a list of the Adamic nations that descended from Noah. It doesn't explicitly tell us where they ended up, but we can work that out by correlating history with the names given. We covered this more fully in Proof 8, but here's a quick summary. Generally, Shem's descendants built nations in the Middle East. Japheth's descendants spread out to the west, east, and north. Ham's descendants went southward. You'll notice that large swathes of Europe were left unassigned. That was for a reason. As we go through the prophets, it will become clear Europe was the true home

Yahweh planned for the Israelites. As for the lands of Canaan, we were just passing through.

Jeremiah to the North

We should begin with the timeline and background of Jeremiah's ministry, which likely began around 627 BC. He preached in Jerusalem to the kings of Judah a hundred years or so after the Assyrians had crushed the Northern Kingdom in 722 BC and taken millions of Israelites into captivity. Around 701 BC, the Assyrians also invaded the Southern Kingdom and deported large swathes of Israelites. Members of all twelve tribes were deported by the Assyrians, not just the ten tribes. It's a common mistake to think that Judah and Benjamin were not in the Assyrian deportations. Some of Benjamin and Judah were deported, yes, but many remained in and around the undefeated Jerusalem. Since Jerusalem was the capital city, it could have had millions of inhabitants. After the invasions, Jerusalem began to repopulate and revive the Southern Kingdom of Judah. It was to these people that Jeremiah preached repentance.

However, Yahweh had not forgotten the Israelites who had already been dispersed by the Assyrians. Jeremiah speaks to them in several prophecies. These prophecies show that the deported Israelites had gone north and west and were on their way into Europe.

The Assyrian Empire had collapsed by 612 BC. Its capital, Nineveh, was destroyed by a confederation of numerous tribes and provinces formerly under Assyrian control. Jeremiah warned the kings of Judah to repent or face deportation, yet — ironically, perhaps — shortly after his pronouncements, Assyria got wiped off the map. No doubt the Judeans assumed their deportation would have come through the Assyrians. Perhaps they were lulled into thinking that they were safe from deportation now that Assyria was now gone and out of the picture. If so, this was a false sense of security. We know from history that Judah was later conquered and deported by Babylon. Babylon rose up after Assyria and claimed much of the former Assyrian Empire's territory for itself, becoming the Babylonian Empire. The Babylonian King Nebuchadnezzar set his eyes on Jerusalem.

We'll pass over most of Jeremiah's prophecies and address them in a later Proof. Here we'll focus specifically on his prophecies that prove Israelites were migrating northward. In Jeremiah Chapter 3, Jeremiah was told to look to the north and make pronouncements. He wasn't told to look to the south, the east, or the west. He was to speak to the Israelites in the north. In these pronouncements, Yahweh said He was chastising the deported Israelites in the north, but He also beckoned them to return to His commandments, promising that He would not be angry forever. These words were directed to the Cimmerians/Scythians, the Israelites who migrated north out of Assyria. "Go and proclaim these words toward the north, and say, 'Return, thou backsliding Israel,' saith the Lord, 'and I will not cause mine anger to fall upon you: for I am merciful,' saith the Lord, 'and I will not keep anger forever'" Jeremiah 3:12 KJV.

Then in verse 18, Jeremiah prophesied that Yahweh would bring the houses of Israel and Judah, the two separate kingdoms, back together. They would once again become one people. Yahweh spoke of them being located in "the land of the north." Furthermore, He

refers to a land given as an inheritance to their forefathers, a land that obviously was not Palestine. “In those days the house of Judah shall walk with the house of Israel, and they shall come together out of the land of the north to the land that I have given for an inheritance unto your fathers” Jeremiah 3:18 KJV.

It’s important to note the timing here. This prophecy was given before the Babylon invasions and the captivity of Jerusalem. Yet even at this early date, we see that this land in the north was the intended inheritance that Yahweh had given to the ancestors of the Israelites. In other words, land to the north (Europe) was always the plan of Yahweh for His people.

But that’s not all. In Chapter 31, Jeremiah prophesied that Yahweh would gather the Israelites from the north AND from the coasts of the earth together under Christ. Be sure to note that “earth” does not mean what we moderns imagine it to mean; it is not the entire world. It merely means lands. Here Yahweh is referring to the coastlands of Europe where earlier migrations of Israelites had settled. He promised to merge those Israelites of the coastlands with the Israelites who migrated north after the Assyrian invasions. “Behold, I will bring them from the north country, and gather them from the coasts of the earth, and with them the blind and the lame, the woman with child and her that travaileth with child together: a great company shall return thither” Jeremiah 31:8 KJV.

This promise is reaffirmed a few verses later when Yahweh declares to the isles far off that He will gather scattered Israel together. Which isles (can be translated coastlands) is He addressing? They must be the coastlands of the Mediterranean and Europe. “Hear the word of the Lord, O ye nations, and declare it in the isles afar off, and say, ‘He that scattered Israel will gather him, and keep him, as a shepherd doth his flock’” Jeremiah 31:10 KJV.

We can historically trace the fulfillment of this prophecy. Earlier waves of migrating Israelites had built the Greek and Roman civilizations. Christ’s apostles brought the Gospel to them. Later the Germanic tribes which originated in the Assyrian deportations invaded and gradually conquered the Roman Empire. They also accepted Christianity. Thus the prophecy was fulfilled. The two houses were reunited as Christian Europeans. Yahweh merged the lost sheep of the house of Israel under himself as Christ. All the Israelites, all twelve tribes in Europe, were united again under Christianity.

Isaiah to the West

Isaiah’s ministry started around 729 BC, so he lived over one hundred years before Jeremiah. He was also a prophet in Jerusalem. Isaiah spoke to two different groups of Israelites: Chapters 1-40 focused on the Kingdom of Israel and the impending Assyrian invasion and Chapters 41-66 addressed the already scattered Israelites (who had spread abroad even before any deportations). Isaiah warned about the impending Assyrian invasions if the remaining Israelites didn’t repent. He also spoke about coastlands in the west, which can only be the European coastlands. By delivering the pronouncements of Yahweh to the Israelites living in the coastlands, Isaiah proves that God’s people were never confined to one geographical area. Ever since the Exodus and even before that, they’d been spreading

far and wide and toward Europe.

In Chapter 11, Isaiah declares that Yahweh would gather the Israelites from all the places they had passed through, and He would regather them together as one people. Obviously, this is referring to Yahweh coming down as Christ and sending his Gospel to the dispersed Israelites. “And it shall come to pass in that day, that the Lord shall set his hand again the second time to recover the remnant of his people which shall be left, from Assyria, and from Egypt, and from Pathros, and from Cush, and from Elam, and from Shinar, and from Hamath, and from the islands of the sea” Isaiah 11:11 KJV.

Who exactly is being addressed here? It wasn't the people living in those locations at that time. Isaiah was addressing the remnant of God's people who had already left those places. They had passed through all the places named but would eventually end up in the land Yahweh had designated for them. Passing through Egypt and through Assyria refers to the Israelites who had been in captivity. The actual locations of Pathros (Upper Egypt), Elam (Persia), Shinar (Babylon's more ancient name), and Hamath (Northern Syria) were places where Israelites had lived. Yahweh declared that their new promised home would be to the west, which is in Europe. “But they shall fly upon the shoulders of the ships of the other tribes [Philistines] toward the west; they shall spoil them of the east together: they shall lay their hand upon Edom and Moab; and the children of Ammon shall obey them” Isaiah 11:14 KJV.

These Israelites were to end up in the west. That was their prophetic destiny. In some translations, “shoulders” is “ships.” The Philistines just mean other tribes. Then they “spoil the east.” What does that mean? History tells us. In time, Greece and Rome — both founded by dispersed Israelites — did rise up in military might and conquered many territories in the east. So the Israelites did “spoil the east.” Regardless, the Israelites weren't destined to live in the south or east. They were always destined to go north and west into Europe.

Later in Isaiah Chapter 41, Yahweh speaks to the dispersed Israelites living in the coastlands. First, He tells the Israelites to renew their strength. As dispersed people without a motherland, the migrating Israelites would indeed need to renew their strength. That would happen over the next few centuries as the Israelites grew strong and became the center of the civilized world in Greece and Rome. So Yahweh certainly did strengthen them. “Keep silence before me, O islands [coastlands]; and let the people renew their strength: let them come near; then let them speak: let us come near together to judgment” Isaiah 41:1. Then the prophecy declares that Christ, “the righteous man,” would be raised up in lands to the east of these coastlands. Palestine is to the east of Europe. “Who raised up the righteous man from the east, called him to his foot, gave the nations before him, and made him rule over kings? He gave them as the dust to his sword, and as driven stubble to his bow” Isaiah 41:2.

Ancient historical records affirm that the dispersed Israelites did indeed live in these coastlands. The Scythians populated the coastlands all around the Black Sea and Crimea after the Assyrian deportations. Other early migrations of the Israelites centered around the Aegean Sea and coasts of Medditeranean.

Hosea to the West



Hosea is one of the shorter minor prophets but he makes several definitive prophecies about where the Israelites would end up. He made it clear the Israelites were to the west, in Europe. In Chapter 11, Hosea prophesied that when Christ came, the Israelites would obey Yahweh's commandments. Christ would roar like a lion, and the children would tremble from the west. This can only be talking about the dispersed Israelites in Europe who heard Christ's gospel and once again came to fear Yahweh as their ancestors had done and to keep His commandments. They were the lost sheep of the house of Israel returning to the Shepherd's fold. From the perspective of Hosea, the west would be Europe. "They shall walk after the Lord: he shall roar like a lion: when he shall roar, then the children shall tremble from the west" Hosea 11:10 KJV.

Hosea mentions Egypt and Assyria, which are allegories for the enslavement and deportations of the Israelites. So these people in the west went through either one or both of the captivities, so it's clear they must be the Israelites. No other people went through these captivities. Yahweh promised to place the enslaved and deported in their own houses, meaning the chosen lands for the Israelites within Europe. "They shall tremble as a bird out of Egypt, and as a dove out of the land of Assyria: and I will place them in their houses..." Hosea 11:11 KJV. Yahweh included all the Israelites, those who had left the main body of Israelites around the Exodus period, and those dispersed in the Assyrian deportations. Yahweh did not forget any of them.

Esdras Land of Arsareth

We've shown three prophets making it clear that Europe was the destination of the Israelites. Now let's have a look at the Apocrypha, specifically 2nd Esdras. Esdras is a complicated book, but it's arguably the book that's clearest about the Israelites going to Europe. Esdras is actually a compilation of several books attributed to the prophet Esdras (also spelled Ezras). Different Bible translators and denominations have split up these books in different ways, some into four separate books of Esdras, some even up to six. Here we'll be focusing on the 2nd Esdras, as it is called in the KJV. The book numbering may add a layer of confusion

depending on which Bible version you use. The 2nd book of Esdras could be called 3rd, 4th, 5th, or even 6th Esdras in the various versions.

Originally, 2nd Esdras was included in the Bible throughout numerous medieval translations (11th-16th century). The King James Version came out in the early 17th century and “trimmed” Esdras, cutting it down to just one book (1st Esdras). In some translations, the 2nd Esdras which the KJV removed is called the 3rd or 4th Esdras. In this 2nd Esdras, an important account is given of the Israelites migrating to a new land called Arsareth.

“And whereas thou sawest that he gathered another peaceable multitude unto him; those are the ten tribes, which were carried away prisoners out of their own land in the time of Osea the king, whom Salmanasar the king of Assyria led away captive, and he carried them over the waters, and so came they into another land. But they took this counsel amongst themselves, that they would leave the multitude of the heathen, and go forth into a farther country, where never mankind dwelt, that they might there keep their statutes, which they never kept in their own land. And they entered the Euphrates by the narrow passages of the river. For the most High then shown signs for them, and held still the flood, till they were passed over. For through that country there was a great way to go, namely, of a year and a half: and the same region is called Arsareth” 2 Esdras 13:39-45.

Where is this region called Arsareth? On the plains of Hungary, there is a river called Sareth which flows from the Ukraine, through Romania, and into the Danube River, very close to the Danube Delta and the Black Sea. The River Sareth still bears that name to this day (the Siret in Romanian, Szeret in Hungarian, Ceper in Ukrainian). You’ll notice on the map that the River Sareth is next to a huge mountain range to the left. As we’ve mentioned before, Ar in Hebrew means “high-point, mountain, hill-top.” So the two words combined together “Ar-sareth” are likely referring to the mountain range by the River Sareth in modern Romania.



The river is named Siret, but in German it is still named the Sareth.

Ancient historical records recount that the first place the Cimmerians arrived in Europe, after going over the Caucasus Mountains, was the plains of Hungary. Once again we see that the historical accounts and biblical records match up. A portion of the dispersed Israelites did travel this route into Europe.

Furthermore, Esdras' account stated that the Israelites were migrating to an uninhabited place, where "no human beings had lived." Esdras would have written around 458 BC and we can compare his words to what Herodotus the historian wrote around 450 BC. Herodotus stated that north of the Danube was uninhabited at his time due to the severe cold in the winters (Arsareth/Hungary were north of the Danube). However, Herodotus did say that one tribe of people did live there, a recent colony from the cities of the Medes. Medes had been one of the primary locations the Israelites were deported to by the Assyrians, so this colony was likely Israelites. Other historians also noted that north of the Danube was far too cold in the winters. Interestingly, there seems to have been a general warming period from then on. It's almost as if Yahweh was keeping these lands in reserve for his people, the Israelites.

The Israelites had been deported across the Assyrian Empire, including the city of the Medes. Eventually, the Israelites overcame the Medes, and then in alliance with the Babylonians and Medes destroyed Nineveh, the capital city of Assyria, thus bringing down the Assyrian Empire. This is when some Israelites (called Cimmerians and Scythians) migrated west to Lydia and then into Greece, whilst others traveled over the Caucasus mountains to Arsareth. With wave after wave of migrating Israelites behind them, these people needed to keep moving because if they stayed in the Arserot area, there wouldn't be enough land for everyone. So many moved into what would become Poland and Germany.

For our purposes, it's significant that along the route from the Caucasus mountains to Hungary lie southern Ukraine and most notably the Crimea. The name Crimea originated from Cimmerians, who were called Cimmeria. Historians identify the Crimea as an early "Greco-Scythian" state, again showing that the Cimmerians and Scythians were the same people. It was an independent kingdom from around 500-100 BC. But later it was conquered by the Romans and incorporated into the Roman Empire. The area was renamed the Kingdom of the Cimmerian Bosphorus (Βασιλείον τοῦ Κιμμερικοῦ Βοσπόρου). This shows the Cimmerians did indeed travel along this route.

We can easily see why the 2nd Esdras was removed from the "official" Bible. Any European person reading this material would quickly realize that the Israelites really did migrate into Europe. It's obvious. This is not whitewashed history. It's not hate speech or vile racism. It's not a fairy tale. This is the account — the history — of what actually happened. History clearly matches up with the prophecies we've covered that the Israelites would be heading to the north and to the west, which is of course Europe.

So there you go. This is what the Bible and history tell us. We can know with all certainty that the Israelites became the white Christian Europeans. They did not go to Africa, the Himalayas, or the Americas. When confronted with the lie that the ancient Israelites disappeared from history, keep in mind that if we can show that both the Bible and history line up with the same narrative — that the Israelites went to Europe — then we have stopped the mouths of our critics. They will always try to deny and erase white history, but we will show that in doing so, they are denying the Bible as well. The Bible does not lie, but the enemies of God do. Do not let His enemies steal our history from you. The Israelites went to Europe and became Europeans and we, their descendants, are the true Israelites.

7) The Meaning of the Hebrew Word Adam



“So God created man in his own image, in the image of God created he him; male and female created he them” Genesis 1:27 KJV

Yahweh created man in His own image and likeness, says Genesis. That first man was named Adam, one of several Hebrew words for “man.” Upon close examination, we can see that the concepts of “man” and “whiteness” are actually encoded in the linguistic DNA of this Hebrew word Adam. Hence Adam’s identity and the identity of the white race are revealed in the first man’s name, the progenitor of the white race.

In the Bible, names reveal identity. Names tell us who we are. The name Adam is actually a combination of two words “aw-dam,” which when joined together have several meanings: “to show blood in the face,” “to flush or blush,” “to turn rosy” and “to be ruddy.” For simplicity, we can reduce that list to one word: ruddy. Adam and his descendants (mankind or Adamkind) are people who are ruddy of complexion. Our ability to blush or show blood in the face is due to the fact that blood or hemoglobin can show through only pale, white skin. This ruddiness is our inheritance from Adam and makes us Adamites. Other skin colors (black, brown, yellow, and red) are not ruddy and cannot show blood in the face. Certain members of other races who possess a high degree of white genetic admixture can sometimes show blood in the face to some small degree. But this is not a true nor a full blush. The less white genetic material present, the less ability to blush. Adam, as his name tells us, could blush and only the race that can blush is the Adamic race, the people descended from Adam.

In white societies, ruddiness (not the red nose and face associated with habitual overindulgence in alcohol) is usually associated with good physical health, whilst lack of ruddiness can signify poor health or illness. Lack of ruddiness would be paleness in the face with no red undertones. We’ve all seen our white family members or friends looking pale or white without

red undertones and instinctively known to ask, “Are you feeling OK?” We can also look to Scripture to confirm this principle. When the Prophet Samuel met King David (a young boy at the time), he remarked that David was a vibrant and healthy youth because he had a ruddy appearance.



Adam, the ruddy one, is the identifying name Yahweh gave the first man He created in His own image and likeness; or, in other words, His sons and daughters. He did not create the other races. Nowhere in Scripture can we find an account of His creating them. As with any truth in Scripture, the enemies of truth will try to undermine, distort, hide, obfuscate, and even invert that truth. This is particularly the case, what has been hidden and obfuscated is the meaning encoded in Adam’s name. If God’s enemies can block Adam’s true identity (and by extension, our identity) as revealed in his name, they’ve already won a victory in distorting the whole truth of God, undermining the Scriptures, and waging war against God’s creation.

If we want to reclaim our inheritance which has been stolen by the Father of Lies and his children, we need to begin by studying the Hebrew linguistics behind the name Adam. (And, no, you don’t need a college or seminary degree to do that; you just need a few solid reference books.) We don’t have to take by faith that Adam means ruddy. We can prove it. To start with, in Hebrew, one word can have different meanings, even though it remains the same word. This linguistic feature requires us to consider the context of a Hebrew word in order to assign the correct meaning to that word.

Thus a Hebrew lexicon is needed for serious Bible study. Many Hebrew lexicons have separate sections for a word with several meanings. Each shade of meaning is given its own section and, as a result, many words have multiple sections. Translators devised this functional and logical ordering as an effective way to deal with the variety of meanings of certain Hebrew words. But if a person is unaware of the methodology, it can give rise to confusion and disinformation, especially if that person assumes that each section translates a different word. More troubling and even sinister, a person attempting to deceive can present one meaning of a word as the only meaning, whilst being silent about the additional meanings. In other words, by obscuring the full linguistic meaning, a deceiver can skew or even reverse the true meaning.

With this background information, let's look closely at the word name Adam and its various meanings as listed in Strong's Concordance. As we look at the different sections, keep in mind that they all are describing different meanings of the same word and that the word "Adam" contains within itself all of these meanings:

H119 Adam – Verb: To show blood in the face; to blush or flush; to turn rosy.

H120 Adam – Noun: Adamkind; a man or woman descended from Adam and Eve.

H121 Adam – Proper Name: The first man Yahweh God created; the man, the person, the individual who was called Adam; the patriarch of our Adamic race.

H122 Adam – Adjective: A ruddy or red complexion.

From this list, we see that the word Adam can refer to the first man Yahweh created. Adam can also represent the race of Adamkind as a whole. It can mean an Adamic man or woman from the race of Adam. It can even be used as an adjective to describe a person who is ruddy (and thus looking like Adam) or to designate an object as having a blood-like (Adamic) color.

Furthermore, we should note that English can have separate words for these Hebraic meanings. For example, in English, we would say, "He looks ruddy." But Hebrew does not have a separate word for "ruddy." It has only Adam. So in Hebrew, we would say, "He looks Adam(ic)." In English, we'd say, "She is blushing" but in Hebrew, that same sentence would be "She is adam(ing)." Obviously, the name Adam tells us that the first man was a ruddy, white man (and so was his wife, Eve, who was made from his body). Thus how can we possibly imagine that Adam was anything but a white ruddy man who had the ability to blush? To believe anything else is to be ignorant — perhaps willfully ignorant — of the full truth about the name Adam and thus allow ourselves to be deceived.

Hebrew Word Forming

If we move on to examine the physical structure of the word Adam, we can see where the ruddy color and blood connections come from. Divide the word Adam into its two component parts, and we can quite literally see the picture. That's because each Hebrew letter was originally a pictograph with a unique meaning and sound. By combining these pictographs or letters (perhaps two, three, or even four letters), a root word was formed. These root words could then be combined with additional letters or even other root words to form longer and more complex words. This is likely how the Hebrew language evolved.

The word Adam is made up of three Hebrew letters: ADM. Note the absence of a vowel between the two consonants. This root word is believed to be pronounced "Aw-Dam" and is transliterated into English as Adam. The Hebrew letters are Aleph, Dalet, and Mem. The meanings of the letters are as follows:

Aleph: a pictograph of an ox, and it represents power and authority

Dalet: a pictograph of a door, and it represents a doorway or an opening

Mem: a pictograph of water, and it represents water or chaos

The Hebrew word “dam,” which is formed from the two letters DM (Dalet and Mem), represents the word “blood.” In this Hebrew construct, blood represents the “water” that is the “doorway” to life. This is certainly an accurate depiction of blood and its life-giving properties. Thus the word “blood” was formed by combining the two meanings of the letters Dalet and Mem to form one word, dam. This example also serves to demonstrate how the combination of pictographs and their meanings form root words.

As mentioned earlier, one way to determine the true intended meaning of a Hebrew word is to see how it is used in context. In other words, how is the Hebrew word “dam” generally translated in the Bible? Well, it’s translated as blood every time it’s used in the Old Testament. That’s three-hundred times. So critics who deny that the word Adam means “showing blood” or “ruddy” don’t have a leg to stand on. “Dam” is the root word from which Adam is formed, and “dam” means blood. It’s that simple.

If “dam” means “blood,” what happens when the letter “A” is added as a prefix? In Hebrew, the “A” is an Aleph. The pictograph for Aleph is an ox. The ox is an animal of great strength and is the leader of its kind. Thus, Aleph represents power and authority. In the word Adam, the concept of power and authority is combined with blood. When Yahweh gave Adam this name, He conferred His authority on Adam and the race that came from his Adamic blood. Thus, God-given leadership and authority are contained in Adam’s name and in his very blood (and genetics). Yahweh also explicitly commanded Adam and Eve to have authority over all the earth. “And God blessed them, and God said unto them, ‘Be fruitful, and multiply, and replenish the earth, and subdue it, and have dominion over the fish of the sea, over the fowl of the air, and over every living thing that moveth upon the earth’” Genesis 1:28.

As we can see, Bible names reveal identity. When Yahweh God conferred the name Adam on our forefather, Yahweh conferred authority based in blood, or genetics, on Adam and his descendants. Adam and his progeny were to have authority over all the earth, subdue it, and dominate it. They were to replenish the earth. To “replenish” indicated that they were to replace the races Yahweh did not create and replenish or fill the earth with Adamic people. This is Adamkind’s genetic inheritance. Since Eve (or womankind) was created from Adam and her blood is the same as his, she shares the same authority. Their children would inherit the same divine blessing. But if they mixed with non-Adamic nephilim and fallen angels, the blood of the resulting offspring would be corrupted. Since these polluted abominations no longer had pure Adamic blood flowing in their veins, they had no authority from God. Therefore, they have no authority at all.

In addition to the authority of blood, the word Adam is used interchangeably throughout the Bible to describe a ruddy appearance of both men and objects. Ruddiness in the face applies only to the white race, to the Adamites who descend from the ruddy and white Adam and Eve. Ruddiness is a white construct only and always. It doesn’t make sense and is actually unintelligible in the context of other races. Without the ruddiness of whites, non-Europeans wouldn’t know what ruddy is or means because they can’t see or experience ruddiness themselves. For all the others peoples in the world, they cannot be ruddy and ruddiness is outside of their experience and frame of reference. it is an alien concept which would never

appear in their writings describing themselves.

The children of Israel come from Adam, the ruddy one. Our white and ruddy lineage goes back to the creation of the first man through Jacob (Israel), Isaac, Abraham, Shem, and Noah, all the way back to Adam. If Adam and Eve were white (and we know without a doubt that they were, despite the lies of God's enemies and their current rewriting and corruption of history), then so were all their descendants, right down to you and me today as white Europeans. Kind follows kind. This is the law of the Creator God in Genesis. We do not get cats from dogs nor dogs from cats. One cannot derive a different species from another species, no matter how many attempts one made. Likewise we will always get European looking people from European looking people. Therefore since Adam was white and ruddy, then the Israelites (our ancient forefathers) who descend from Adam, were white and ruddy. It would be impossible for them to have the appearance or countenance of any other people, or anything in between. The Bible tells us kind begets kind, not one kind begets another kind.

The Adamic Race and Nations Were Originally White Until They Mixed

We've seen that Adam means ruddy and that ruddiness applies only to the Adamic race. Now we'll trace Adam's descendants, the Adamic race. Over time, many white nations or "branches" developed on the Adamic family tree. The Bible traces Adam's line to Noah and his three sons: Shem, Ham, and Japheth. Noah and his sons were white Adamic men, and after the flood, the white world was repopulated through them and their descendants. The nations that came from Noah were white because Noah was white. Noah was white because Adam was white. Since the Bible gives us an accurate history of these ancient beginnings, we can trace back all white Adamic nations to the sons of Noah.

The only rational Biblical worldview is that all Adamic nations started out white (we say "started out" because unfortunately, some Adamic nations miscegenated themselves into oblivion). Amazingly, modern Biblical scholars and churches try to deny the genetic reality that only white can come from white. They teach all races came from Noah's three sons! Whites from Japheth; another color from Shem; and another from Ham. This defies reality. How did all the peoples across the world, get to all the continents and have evidence they've been there for thousands of years? Who knows? More fanciful fairy tales would be difficult to dream up. Since when do parents of one race give birth to another race?

It's helpful to understand an error so we can better appreciate the truth. So let's explore how these false teachers came up with this nonsense. Mainstream Biblical teachers link Japheth and his son Javan with early white European nations, such as the Ionian Greeks. In this, they are correct. Sometimes they insist on labeling these nations "gentiles," which is Mainstream nonsense and the misuse of a Latin word; nevertheless, they are correct in identifying very early European nations as white Adamics. But these so-called Christian teachers and churches proclaim that all the nations of the world — every color and appearance — somehow against all genetic reality came from Noah and his three white sons!

Mainstream churches admit Japheth's descendants were white but claim that Ham's descendants were a different color and Shem's descendants were another color. How can that anomaly possibly be true? If Japheth's descendants were white (as the Ionian Greeks were), then Japheth himself would have been white. If Japheth was white, how could his two brothers, Ham and Shem, from the same parents, be a different color? If Noah's family gave rise to all peoples across the world (as mainstream Christianity teaches these days), what color was Noah? Some say that Japheth fathered both the white and other races. This is a blatant manipulation of reality. Unless we want to believe in fairy tales, we must insist that Noah's sons did not evolve into all different shades and colors. The sun did not change the color of their skin. This teaching that all races came from Noah is total and utter nonsense.

Noah's sons, being Adamic, gave rise to the Adamic races (as listed in Genesis 10), but tragically, a certain number of these races eventually miscegenated with non-Adamic races and as a result, many of them disappeared. By studying the Biblical accounts of the gradual decline of the Adamic nations, combined with historical accounts of non-Adamic invasions and events around the same time periods, we can see the big picture of what happened. Since the main focus of this Proof 7 is to demonstrate that Adam and the Adamic nations were white, we will focus just on that one aspect. But before we start, it would be helpful to examine a few examples of Adamic miscegenation in the Bible and its dire results.

Examples of Miscegenation

The Canaanites were a nation that amalgamated early on. Canaan the cursed grandson of Noah was their progenitor. Although Canaan was white Adamic, we see in Scripture that the lands of Canaan were filled with non-Adamic tribes such as the Kenites (the descendants of Cain who was half-Adamite from his mother, Eve, and half a fallen angel from the entity who fathered him; his wife was non-Adamic so all Cain's descendants were mixed non-Adamites), the nephlim (frequently mistranslated as giants), and other bastard pre-flood races resulting from the fallen angels. Remember that Yahweh did not create the non-Adamite races. The Bible records His creation of the Adamic race only. Whilst initially the Scriptures distinguished and listed all of the diverse tribes living in the land of Canaan, eventually, they were all lumped together under the name Canaanites. Due to miscegenation, it became impossible to trace people's ancestry. The Canaanites were an unholy mix: part multicultural Canaanite, descended from the cursed Canaan, son of incestuous Ham and his mother, grandson of Noah; part descended from Cain, the cursed seed of the fallen angel (serpent) and Eve; and part the seed of other nephilim. Perhaps now you can see why Yahweh commanded the Israelites to exterminate them from the land.

"When the LORD your God brings you into the land which you go to possess, and has cast out many nations before you, the Hittites and the Girgashites and the Amorites and the Canaanites and the Perizzites and the Hivites and the Jebusites, seven nations greater and mightier than you, and when the LORD your God delivers them over to you, you shall conquer them and utterly destroy them. You shall make no covenant with them nor show mercy to them. Nor shall you make marriages with them. You shall not give your daughter to their son, nor take their daughter for your son. For they will turn your sons away from

following Me, to serve other gods; so the anger of the LORD will be aroused against you and destroy you suddenly. But thus you shall deal with them: you shall destroy their altars, and break down their sacred pillars, and cut down their wooden images, and burn their carved images with fire. For you are a holy people to the LORD your God; the LORD your God has chosen you to be a people for Himself, a special treasure above all the peoples on the face of the earth” Deuteronomy 7:1-6.

Another example of destruction through miscegenation is the Philistines. The white Adamic Philistines descended from the Egyptians (both nations had the same patriarch, Mizraim, the second son of Ham). During the Assyrian deportations, the Philistines treacherously joined with other small surrounding nations in making an alliance with the Assyrians in exchange for protection and reward. Yahweh pronounced punishment on several of these nations. The Philistines’ punishment was that their pride would be cut off and their nation would be replaced with “bastards” (or in some translations, with a mixed-race).

“And a bastard shall dwell in Ashdod, and I will cut off the pride of the Philistines.” Zechariah 9:6 KJV.

“A mixed race shall settle in Ashdod, And I will cut off the pride of the Philistines. Zechariah 9:6 NKJV.

Consider for a moment the curiosity that modern churches interpret “bastard” solely as a person whose parents are not married. While this definition is correct, it is only partial. They ignore the fact that Scripture also considers miscegenated offspring to be bastards. When the interpretation of “bastard” is limited to the offspring of unmarried parents, Yahweh’s punishment of the Philistines is reduced to absurdity. Did hordes of fornicating unmarried couples invade the Philistine territory and produce a multitude of illegitimate children who overran the country? You can see how dogma that ignores what the Bible really teaches about race makes a mockery of God’s word. The reality of Yahweh’s punishment was that the country was overrun with non-Adamites and the white Philistines were miscegenated right out of existence.

Another example of fatal miscegenation is the Egyptians and Ethiopians. These two nations were the white descendants of the white Ham, son of the white Noah. In this particular case, the destruction of these two Adamic nations through miscegenation shows us how history corroborates the Biblical account. Around 700 BC, Egypt and Ethiopia were both invaded and overrun by Nubians from the south. Once the Nubians invaded successfully, the days of white Egypt and white Ethiopia were numbered. The historical pattern and inherent characteristic of non-Adamites, is that they can invade and destroy but they cannot build and maintain.

The Egyptians endured several decades under Nubian Pharaohs. As with every place under non-Adamite, the country began its slide into irreversible decline. Eventually, the native white Egyptians (Mizraim) rallied together and drove out the Nubians. But after several decades of Nubians in their lands, much of the population had become miscegenated. There is no going back to Adamic once miscegenation sets in. It is genetically impossible. From that point on,

Egypt, one of the world's greatest powers when it was Adamic, began to decline and never recovered from its Nubian problem. A few centuries later, what was left of Egypt could not resist the Macedonian and Greek invasions.

Being conquered by white Macedonians and Greeks in the late 4th century BC gave Egypt an infusion of Adamic blood into the ruling classes. This caused a bloom of greatness for several centuries under the Ptolemaic dynasty. Ptolemy's most famous descendant was Cleopatra VII, the queen of Egypt. She forged political alliances and became romantically involved with Roman military leaders Julius Caesar and Mark Antony. But even this infusion of Adamic blood could not save Egypt. Eventually, all Adamic blood became miscegenated and Egypt deteriorated into the state it is to this day.

The secular historical background helps us understand what we read in the Bible about that period. Around 700 BC, the Israelites often looked to Egypt for assistance in repelling the Assyrian invasions. But several of Yahweh's prophets warned the Israelites to repent for their sins instead of seeking military assistance. Egypt was aligned with weaker Ethiopia at this point, but both Ethiopia and Egypt were already far down the road of miscegenation with Nubians. As Biblical proof of that, the prophet Jeremiah mocked the Ethiopians for their miscegenation, saying that they could not change their skin (which was now a mixture of colors) just as a leopard cannot change his spots.

"Can an Ethiopian change his skin or a leopard its spots? Neither can you do good who are accustomed to doing evil." Jeremiah 13:23 NIV.

So the Bible gives us cautionary examples of the miscegenation Canaanites, Philistines, Egyptians, and Ethiopians. These once Adamic nations are examples of the disastrous results of miscegenation. Once we look at history with an unbiased eye, we discover that the Adamic Hamite nations of the Bible miscegenated and were the first Adamic nations to disappear into non-Adamic, dysfunctional masses. Other Adamic nations remained pure for longer, but eventually, they also succumbed to mating with non-Adamics. Eventually, every Adamic nation crumbled due to miscegenation themselves into oblivion. Some individual Adamics from these crumbled and failed nations may still be amongst us, but that's impossible to say with certainty. But one thing was for certain. Something had to be done.

Israel Chosen to Preserve the Adamic Race

Miscegenation is nothing new, but the great tragedy of our day is that it's praised as virtuous. That's because miscegenation has been weaponized by those who hate Christ and Christians and our European countries. We're told that diversity is our strength, and European people solely are encouraged to miscegenate. But the gullible Europeans who do are seemingly ignorant of the simple genetic fact that "once Adamic goes non-Adamic, there's no going back." Once the precious blood of Adam is mixed, it never becomes purely Adamic again. These are basic scientific facts. Miscegenation is essentially murder, the destruction of one's genetic seed.

Miscegenation destroys Adamic nations, irrevocably. Any Adamic nation that miscegenates will eventually “mix” itself out of existence. This happened to all the Adamic races except for the Israelites, who kept Yahweh’s law against miscegenation until recently. As each Adamic miscegenation generation passed, the once-Adamic population slowly became less and less Adamic, especially in the nations which were militarily invaded by non-Adamics. The Adamic nations disappeared through miscegenation and left non-Adamic bastard races to occupy their formerly Adamic (and functional) lands. Then these non-Adamics claimed the identity of the former Adamic lands (for example, Ethiopia) even though the civilization has never recovered from what it was thousands of years prior. The people living there now are not genetically the same as the original founders.

This is why there are practically no original Adamic nations left today. Small pockets of Adamics still exist here and there, but the pattern has always been that the Israelite Adamics would conquer and unite them. There were no independent non-Israelite Adamic nations. Ultimately only the Israelites have remained intact as white while the other Adamic nations have miscegenated themselves out of existence for the most part. Can you see the bigger picture here? This “erasing” of formerly Adamic nations would have continued indefinitely unless Yahweh had intervened. Unless He stopped miscegenation, His Adamic creation would have destroyed itself. In order to preserve our race, Yahweh chose one Adamic nation — which would be called Israel — and made a covenant with them so that the Adamic race would survive and fulfill the purpose for which He created us: to replenish the earth.

Abraham’s Family to be Preserved

Yahweh promised Abraham that he would become “the father of many nations” and that in Abraham all the (Adamic) nations would be blessed. Through Moses, Abraham’s descendants were given Yahweh’s Law, including the rite of circumcision which would hinder miscegenation (more on this in a moment). To stop the practice of miscegenation that was gradually beginning to take place on the other Adamic nations and was still in progress, Abraham and his descendants were explicitly commanded not to miscegenate. They were commanded to separate from the non-Adamic races and be set apart as a holy nation for Yahweh. The Law acted as a racial and moral barrier to miscegenation.

This commandment of Yahweh against miscegenation is the reason why Abraham and his descendants were so selective about their marriage partners. Above all, they needed to guarantee the ancestry of their spouses in order to preserve their (and our) white race. Indeed, we owe a debt of gratitude to them for their circumspection and obedience; if our patriarchs had miscegenated as the fornicator Esau (son of Isaac) did, our white race might not exist today. Abraham went to great trouble and expense to marry his son, Isaac, to a kinswoman from Abraham’s distant homeland when it would have been much easier to find a local Canaanite bride. In the next generation, when Isaac and Rebecca’s son Esau married two Canaanite women and an Ishmaelite woman, Rebecca’s distress was so great that she felt her life would be worthless if their other twin son, Jacob, also miscegenated. To prevent this, Isaac sternly sent Jacob back to Abraham’s homeland to find a wife amongst his kinfolk, specifically from the family of Laban (which means “white”), Abraham’s great-nephew and

Rebecca's brother.

With this larger perspective, we can now return to the subject of circumcision and understand better one of its purposes: to hinder miscegenation. Israelite women could only marry circumcised Israelite men. Hence, no man from a bastard race such as the Canaanites could pass himself off as an Israelite in order to get an Israelite bride. Whilst bastards may lie about their ancestry, self-circumcision as an adult is a step too far for most would-be deceivers and infiltrators.

However, there came a time of treachery and betrayal of Yahweh's law when the sign of circumcision no longer protected against miscegenation. Around two centuries before Christ, the Levitical High Priest John Hyrcanus began forcefully converting the surrounding peoples, particularly the Edomites and Canaanites to the religion and customs of the Israelites, which included circumcision. Thus the wolves were brought by force into the sheepfold! However, although an Edomite or Canaanite could be circumcised, he was not genetically an Israelite and never could be. By the time of Christ, the religious leadership was riddled with Edomites as surely as a decaying house is infested with termites. These false Israelites rejected and killed Christ because they were not His sheep (His people). This was the result of miscegenation.

We'll return to miscegenation in a later Proof, but for now, let's continue proving that like the first created man Adam, the ruddy one, all of the Adamic nations were white, at least at the beginning.

The Sons of Noah: Japheth, Shem, and Ham

Noah's flood was a real event, but it was not a worldwide event. The deluge did not destroy every living thing on the planet, and this is proven by the fact that races other than the white race (of whom Noah and his family were the remnants) survived the flood. We see records of them in the Bible. The flood was local to the Mesopotamian area where the Adamites lived. The purpose of this flood was to punish and wipe out the sinful and miscegenation Adamites. Yahweh chose Noah because he was pure in his lineage and faithful to Yahweh. Out of all the Adamites, Noah and his genetically pure family were chosen to survive the flood and start the white Adamic race anew. It's obvious from the Bible that various non-Adamites survived the flood because they were outside the flooded area. Amongst these non-Adamites were the Kenites, the Nephilim, and other races who had no ancestry from Noah and his sons.

This ancestry from Noah is recorded in Genesis 10. This account gives us a brief summary — a snapshot in time if you will — of the nations that descended from Noah's three sons. Whilst we cannot know the exact locations of their early settlements, we can find the civilizations that appeared later. We can trace these civilizations back further and further until we eventually locate the immediate descendants of Noah's three sons. So we can have a rough but nevertheless accurate idea of where the tribes from these three sons migrated to, what nations they eventually gave rise to, and what was the fate of these nations.

We shall cover the Adamic nations in greater detail in a later Proof. The important thing to

note here is that Scripture says that Noah was perfect in his generations. In other words, Noah's generations or genetic lineage had not been corrupted. It was perfect. Whatever race Adam had been, Noah still was. Therefore, Noah's descendants would also be of the race of Adam. The obvious question this leads to (a question that modern churches studiously ignore) is, What was Adam's race?

Adam was White, Adamic Nations Were White, the Israelites Were White

Since the name Adam means "ruddy," Adam indicates a white man. Adam and the Adamic race were the only people Scripture records as being created by Yahweh God. Yahweh did not create the race of Cain and the nephilim. This is why the protagonists in the Bible narrative were white and only white. The Bible is the story of the white race. The white Adamic race came down through Adam's son Seth and through Noah and his three white sons, Japheth, Shem, and Ham. After the flood (which was not world-wide but limited to the white "world" in the Middle East), this remnant gave rise to all the white Adamic nations. These nations can be traced from Genesis Chapter 10.

At first, only a few generations after Noah, the Adamic nations lived clustered together in the Middle East under the leadership of King Nimrod and they all spoke the same language. But under Nimrod, they sought to rebel against Yahweh by building the Tower of Babel. So Yahweh destroyed their tower, confused their tongues, and scattered them far and wide.

The Adamic nations all went their own way and gradually turned to paganism and began mixing with the non-Adamic races. To preserve His Adamic race, Yahweh made a covenant with Abraham and Sarah in order to form the Israelites, His Chosen People. The Israelites would replace, push aside, and absorb the other Adamic nations and form one holy nation set apart and dedicated to Him. This nation, who were forbidden to mix with other races not of Adamic origin, would ultimately produce Yahshua Christ. Christ, the Israelite Messiah, will eventually destroy the seed and lineage of Satan, as predicted in Genesis 3. This conquest will be covered in a later Proof.

What are we to make of all of this? We need to base our beliefs about race firmly in Scripture. We need to realize that without a doubt, Adam was white, the Adamic nations were white, and the Israelites were and are white. We can trace our white lineage all the way back to the white and ruddy Adam. To bring this history up to the present day, we white Europeans are the continuation of our white Israelite ancestors and are the last remaining Adamite people.

“This is the genealogy [race] of Noah. Noah was a just man, perfect in his [descent] generations. Noah walked with God” Genesis 6:9 KJV

When Noah stepped off the ark with his wife, their three sons, and three daughters-in-law, this small group of eight constituted all that was left of the Adamic race. Yahweh decreed that they and their descendants would restart Adamic civilization and that one day, great nations would come of them. It goes without question that if all these nations came from one man, Noah, then they all would share similar DNA and be distinct-looking people. If we can trace these nations back to Noah, then we can find out what Noah and his sons looked like. Since the Israelites also descended from Noah, we can also know what they looked like.

With that end in mind, let’s go through the sons of Noah one by one and trace the nations that came from them and what history tells us about their physical appearance. Noah’s sons were Japheth, Ham, and Shem.

Japheth

“The sons of Japheth; Gomer, and Magog, and Madai, and Javan, and Tubal, and Meshech, and Tiras” Genesis 10:2 KJV.

Noah’s son Japheth had seven sons. Best known to us today are Javan, Madai, and Tiras. Few if any historical records about the other four sons have survived. But if we can identify three out of seven of the sons as white, it would be logical to assume that the other four were also white.

In Genesis Chapter 10, verses 5, 20, and 31, the sons of Noah were assigned territories. The Japhethites were specifically given the “isles” or “coastlands.” So from the earliest times, the Japhethites were sea people. They lived along the waterways from the Caspian and Black Seas to as far west as Spain. Neither the Shemites nor the Hamites were given these areas, although the Hamitic Philistines also plied the waves. After a considerable length of time, these Japhethites were rivaled at sea by the Shemitic Israelite Phoenicians, who were also successful sea traders. Thus as Noah’s prophecy foretold, Japheth dwelt in the tents of Shem, meaning that Shem would rule Japheth and largely absorb the Japhethites.

The origins of these ancient (Japhethic) sea peoples puzzle modern anthropologists, archaeologists, and historians; these scholars mistakenly claim the sea people were Caucasians from the Aegean area who had invaded the Mediterranean around 3000 BC. But the true origin of the sea people is much more straightforward and is recorded in Genesis Chapter 10: the sea people were Japhethites, one of the white Adamite nations descended from Noah.

Most of the Greek history that has survived is from the Athenians (Ionians). All of their art and history depict them as white.

Javan



Javan (Yavana), son of Japheth, is the father of Ionian Greeks. Athens became the Ionian’s most populous city, although the Ionians also spread to the islands of the Mediterranean and the coasts of Spain. Their records, artwork, and historical writings clearly describe these people as white, frequently with blond hair. Most surviving Greek history was written by Athenian historians, including Homer, Thucydides, Plato, and Xenophon, who were most definitely white. Javan had four sons:

“And the sons of Javan; Elishah, and Tarshish, Kittim, and Dodanim. By these were the isles of the Gentiles [nations] divided in their lands; every one after his tongue, after their families, in their nations” Genesis 10:4-5 KJV.

The Bible records the civilizations that came from Javan's sons: Elishah, Tarshish, Kittim, and Dodanim. Elishah and Kittim can be identified with Cyprus. To this day, there is a city called Kittim in Cyprus. Tarshish was a seaport in Spain. It is frequently mentioned in the Scriptures, including the Psalms. King Solomon used Tarshish for supplies to build the temple. The prophet Jonah tried to jump into a ship to Tarshish to avoid going to warn the Assyrians. Dodanim is often mistranslated as Rhodium, and they can be identified with the Greeks of Rhode.



Javan is also mentioned numerous times as being connected to the tribe of Dan. For example in Ezekiel 27 (we shall explain this Ezekiel passage in a later Proof) Yahweh speaks against Tyre, giving a lengthy discourse condemning their international trade. In verse 19: "Dan also and Javan going to and fro occupied in thy fairs: bright iron, cassia, and calamus, were in thy market." So we see Javan and Dan mentioned together. Understanding that they are Ionian Greeks and Danaan Greeks respectively, it becomes clear why they are listed together; they lived in the same region and became culturally interwoven. Javan's descendants became the Ionian Greeks, perhaps the oldest of the Greek tribes. The Danaan Greeks arrived later when a large number of Israelites broke away from those who followed Moses into the desert after the Exodus from Egypt. This break-away group was largely from the tribe of Dan. They set sail for Greece and settled there.

Madai

Madai, another son of Japheth, was the father of the Medes. The Medes were the only Japhethite tribe located in the Middle East, where they were neighbors to Elam (Persia). The Persians were Shemites, from Elam, the oldest son of Noah's son Shem. The Medes and the Persians eventually became allies. At first, the Medes were the dominant partner, but that changed by the time of Cyrus the Great who was the son of a governor from Persia and a princess of the Medes. Under Cyrus, the Medo-Persian empire arose (the second Beast Empire of Daniel's prophecy) and replaced the Babylonian Empire.

The Medes were the first nation to call themselves Aryans. Linguistically, it's likely that Aryan

is derived from two Hebrew words: “Ar” meaning mountain, and “Yah” which is a shortened form of Yahweh. Thus Aryah (Aryan) means “the mountain of Yahweh.” This mountain isn’t necessarily a physical mountain because the children of Israel are the true mountain of Yahweh. This name appeared about 300 BC, around the time when the Israelite “Lost Tribes” began to take control of the Japhethite tribes. The Assyrians had deported the Israelites to regions close to the Medes. In time, the Israelites came to dominate the Medes. Thus this very Hebrew name most likely originated with the Israelites rather than from the Medes, despite the fact that historians at the time mistakenly accredited the Aryan name to the Medes.

The Greek historians were very familiar with the Medo-Persian Empire. Homer referred to King Cyrus as a “mule” because Cyrus was half Mede and half Persian. Homer’s attitude shows us that mixing different tribes was considered unusual and was held in a certain amount of contempt. Nevertheless, the historians made no mention of black, Arab, or dark people in the Medo-Persian Empire. Xenophon the Athenian general fought in Persia against the Medo-Persian, and he never mentioned non-white people amongst them.

Tiras

The Kingdom of Thrace, a massive landmass of Thracians. Their location put them between the Greeks and Middle East Empires.

Tiras, another son of Japheth, is the ancestor of the ancient Thracians. The Thracian lands were massive and included the Balkans and modern-day Romania and Bulgaria. The Thracians grew to be incredibly numerous and were considered “barbarians” by the Greeks and Romans. Herodotus called them one of the most numerous people in the world. Their vast numbers fulfill the prophecy that Yahweh would enlarge Japheth.

Since Thrace was geographically near to Greece and the Middle East, the Thracians were heavily involved in wars. They were frequently hired as mercenaries in the battles between the Athenians and the Spartans, as well as between the Macedonians and the Persians. After Alexander the Great’s death, his general Lysimachus inherited Macedonia, Thrace, and Asia Minor. Eventually, the masses of Israelite Scythian/Germanic tribes migrated into Europe and overran Thrace. The Scythians enslaved many of the Thracians and took them along as they spread farther in Europe. These Thracian slaves were called “thralls,” which is a name that appears often in old Germanic tales. Descendants of the Thracians have lived among us for many centuries and probably still live amongst us today.

The Thracians were not the only Japhetite tribe to lose their identity and be forcibly swept along with the Israelite Germanic tribes as they moved across Europe. We will describe other Japhetite tribes shortly, but first, we must reaffirm the truth that Europe has always been white and only white until the recent third-world mass migration invasions. We can find no mention of black, dark, or swarthy people being with the Germanic tribes anywhere in history no matter how hard we look. Even their slaves were white. How then could the Thracians — or any of the Japhethite tribes who descended from white Noah — not have been white?

Tubal and Meshech

Tubal and Meshech, also sons of Japheth, settled above the Caucasus Mountains. There is hardly any surviving recorded history of them. However, when the Israelite Germanic tribes migrated over the Caucasus after the Assyrian deportation, these Germanics encountered tribes descended from Tubal and Meshech and displaced them farther north into the land we call Russia today. One of the tribes was called the Moski which is likely derived from Meshech. Moski is where the name Moscow comes from. Russian also has a city named Tubal. Thus we see the remnants of the Japhetite tribes in modern Russia.

Much later around 900 AD, the region that would be called Russia was populated by many tribes of Japhetite origin, including Tubal and Meshech. Then another Israelite Germanic tribe known as the Rus migrated from Scandinavia, conquered these tribes, and formed a loose federation. The Rus became the identifying name of the region, and Rus is where we get the name Russia. The Russians are just as white as the English, Americans, Germans, and other white nations. Therefore if the Rus conquered and intermixed with Tubal and Meshech, then these Japhetite tribes must have been white. If they weren't, then white Russians would not be white today.

Gomer and Magog

Gomer and Magog were Japhethite tribes located in the lands above Greece, but Greek history has few records of them. Then there's the little matter of the invading Germanic hordes who swept away everything in their path, including the tribes of Gomer and Magog. Thus it is difficult to find solid traces of these two tribes; however, very likely the Slavs who became so populous in the East of Europe were remnants of Gomer and Magog.

The Slavs were made up of European Japhetite tribes conquered by the Germanic tribes plus the slaves those Germanic hordes brought with them (Assyrians, Medes, and others). The name Slav is derived from the word "slave." Later, these Slavs absorbed the last of the Adamic whites migrating north out of the Middle East. Between the fifth and tenth centuries BC, the remnants of Adamic people in the Middle East began migrating north, possibly due to the Middle East's gradual transformation into an Abrabic mass. These Adamics made their way over the Caucasus Mountains just as the Germanic tribes had done centuries before. They mixed with the Slavs in East Europe and also became known as Slavs. Over the centuries, various Germanic tribes conquered the Slavs. All these Adamic peoples intermixed. Interestingly enough, although the Israelite Germanics ruled the Adamic peoples, the Slavic language prevailed in those regions. We will discuss the Slavs in greater depth in a later Proof.

But right now, let's take a look at these migrations from the angle of genetics. Since the Germanic tribes mixed with the Slavs and their descendants did not turn dark, brown, and swarthy, but remained white, just as white as any other European nation, then these Slavs, which include Gomer and Magog, must have been white, just as the Germanic tribes were white. Whilst there are clearly a few different and distinct characteristics between West and

East Europeans, there is no mistaking that the typical native East European is a white man or woman.

Ham

Today, one falsehood commonly promulgated and unfortunately accepted is that Ham's descendants were black. This is yet another impossible, implausible piece of nonsense. As we've already mentioned, it is a benighted and fallacious effort to attempt to attribute all races to Noah and his three white sons. The ultimate purpose of this deception of designating Noah as the progenitor of the dark races is to steal the white identity of the true Israelites. However, while neither Ham nor his sons were black, it is true that the descendants of Ham were the first to disappear from history due to miscegenation with non-Adamics.

"And the sons of Ham; Cush, and Mizraim, and Phut, and Canaan" Genesis 10:6 KJV.

Cush

Cush, son of Ham, is the ancestor of the Cushites. Cush is noted for being the grandfather of Nimrod, the king or tyrant who founded the first Adamic empire — the Cushite Empire — and rebelled against Yahweh by building the Tower of Babel. Nimrod's Cushite Empire included the city of Babel and surrounding cities such as Nineveh (which later would be the capital of the Assyrian Empire) and Akkad and Assur. We can determine the location of Nimrod's Babylon because thousands of years later King Nebuchadnezzar (a Shemite) rebuilt Babylon. Nimrod's empire, which ended with Yahweh's destruction of the Tower of Babel, was likely around 2900 to 2800 BC or it could have been even earlier, around 3000 BC. Whatever the date, the Cushite Empire was very early in the history of the Adamic nations, only two generations after Noah's Flood when the Adamic tribes lived in close proximity in the Middle East. After the Tower of Babel rebellion, Yahweh scattered the Adamic nations and confused their languages. This occasioned the collapse of the Cushite Empire.

By the time of Abraham (2000 BC), all that remained of Cush were the lands now known as Saudia Arabia and Ethiopia. After Nimrod's empire fell and other Adamic nations began to rise up and compete with each other, the Cushites must have drifted farther south geographically. The Red Sea between Saudia Arabia and Ethiopia is at its narrowest point only thirty-three miles wide. It's easy to see how the Cushites got their start in Saudia Arabia and later sailed west to colonize Ethiopia.

Thus developed Cush of the East (Saudi Arabia) and Cush of the West (Ethiopia). Unfortunately, when the Bible mentions Cush, it never explicitly indicates which Cush. This omission can lead to confusion, but most of the time, we can figure things out. For example, after Moses fled Egypt, he traveled east to Cush where he found a wife. Since he traveled east, this was the Cush of the East (Saudi Arabia) and not the Cush of the West (Ethiopia). Although many modern Bible teachers think that Cush was filled with blacks, both Cush lands were originally white Adamics. Moses certainly did marry a white woman.

One witness that the Cushites were white can be found in the name Ethiopia. The Greeks gave the name Ethiopia to the Cush of the West, and that name has remained to this day. (Empires often gave names to lands under their control.) The Greeks understood that both Cush lands were the same culture and people; thus they called the two regions West Ethiopia and East Ethiopia. What is most fascinating is that the word Ethiopia literally means “sunburnt face” or “shining face” or “glowing face,” and that description only fits white people living in the scorching heat of those regions. Blacks don’t get sunburnt faces. In hot climates, they simply grow blacker. The Ethiopians were originally white. Why else would the Greeks have given them a name that meant sunburned face?



But it's not just the meaning of the name Ethiopia that witnesses to the original whiteness of the Cushites. We can also draw on historical records. Greek historians frequently mentioned men from Ethiopia, and they always described these people as white. In the oldest epic stories, such as the Trojan Wars (1250 BC) onwards, no blacks or Arabs are ever mentioned. Only around 700 BC, do we begin to see darker races entering the picture, although initially, they were merely curiosities on the far fringes of the white civilizations.

We can also find a witness to whiteness in what is left unsaid (or what is so obvious that there is no need to mention it). How often is it necessary to mention that snow is white or water is wet? In the Trojan Wars, King Priam of the Trojans, after his son Hector was slain by Achilles was sent to procure aid from King Memnon the Ethiopian ruler. Priam was supplied with an army of Ethiopians. He fought the great Achilles, even wounding him but Priam was ultimately slain. In the historical records, no mention is ever made that the Ethiopians were black. The presence of blacks amongst the white warriors would have been noteworthy enough to mention. But on this matter, the records and literature are silent.

Then there is the explicit witness. In the first century BC, historian Diodorus Siculus wrote in his *Bibliotheca Historica* (which is largely about geography) about two types of people living in Ethiopia. Diodorus draws from much earlier historians (as was his habit) to describe the various peoples of African Ethiopia, and it is evident that those tribes contrast with one another quite starkly.

The first Ethiopians he described were cultured and educated. They honored the gods, Siculus noted. They quoted Homer. They recounted unsuccessful invasions into their country by Cambyses and Semiramis. They claimed that Egyptians led by Osiris first colonized Ethiopia. They boasted they had two types of writing, as the Egyptians did: one popular or demotic; the other sacred or hieroglyphic. Their priests were much like Egyptian priests. The Ethiopians believed their kings gained sovereignty by Divine Providence. Their laws and punishments came from custom. They practiced the same “flight of refuge” as the Greeks, similar to the Hebrew Levitical “cities of refuge.” One Ethiopian king under Ptolemy was educated in Greece and studied philosophy. Aside from a few odd customs, Diodorus Siculus concluded, there was no reason to consider these Ethiopians (whose physical characteristics he never mentions, perhaps because they were similar to his) to be different from the rest of the civilized white world.

In stark contrast, Diodorus described other inhabitants of the country: “But there are also a great many other tribes of the Ethiopians, some of them dwelling in the land lying on both banks of the Nile and on the islands in the river, others inhabiting the neighboring country of Arabia. The majority of them, and especially those who dwell along the river, are black in color and have flat noses and wooly hair. As for their spirit, they are entirely savage and display the nature of a wild beast...and are as far removed as possible from human kindness to one another...and cultivating none of the practices of civilized life...they present a striking contrast when considered in the light of our own customs” Library of History (3.8.1).

Obviously, Diodorus was describing the Nubians and other wandering tribes of the region. Besides confirming through contrast that the founding Ethiopians were white, this other presence in the land foreshadowed the demise of white Ethiopia. In Scripture, Yahweh declares that He gave up Ethiopia. But to whom? To His friends? Or His enemies? History shows that around 700 BC, Ethiopia and her ally Egypt were overrun by those Nubian tribes. Before long, both nations were miscegenated out of existence.



Above are the remains of numerous ancient Pharaohs found in their tombs. Note the overwhelming evidence of blond and red hair, white skin, and white features.

We could ask why did Yahweh abandon Egypt and Ethiopia to the hordes? Since both Adamic nations had long since turned to paganism, Yahweh had simply given them up to their own ways. All Adamic nations, in fact, turned to paganism (even Israel) but only Israel had been given a covenant and the promise of a Saviour. Yahweh would preserve Israel from the plague of miscegenation and bring her back from paganism through chastisement. Hence when Israel refused to repent and instead turned to Egypt for military assistance against the Assyrians, Yahweh removed Egypt as an effective military aid. No longer was Egypt a powerful military nation due to its self-inflicted Nubian problem. So Egypt and her ally Ethiopia were abandoned to their suicidal miscegenation, and Israel was delivered to the punishment of deportation.

“For I am the Lord thy God, the Holy One of Israel, thy Saviour: I gave Egypt for thy ransom, Ethiopia and Seba for thee” Isaiah 43.3.

Mizraim

Mizraim, son of Ham, is the forefather of the Egyptians. Whenever the Scripture talks about Egyptians, it refers to them as Mizraim. No other race has been surrounded by so much confusion and contention regarding their appearance, racial origins, and skin color as the ancient Egyptians. But this confusion is a modern, deliberately generated confusion. It is, in fact, antichrist propaganda to promote the deception and idolatry of Afrocentrism.

There's no denying the current agenda to make the ancient Egyptians black. But for what purpose? Basically, it's a simple switcheroo or sleight-of-hand. If the Egyptians were black, then the Israelites were black. If the Israelites were black, then whites cannot be the true Israelites. It's all part of the antichrist theft of our identity, and we need to counter this deception with the truth. As we read the Bible, it becomes obvious that the Egyptians and the Israelites belonged to the same racial group and must have been indistinguishable in appearance. Moses, for example, was raised by Pharaoh's daughter. Can we imagine that Moses was of a different race and color than the royal household? And that this went unmentioned? The truth is both the Egyptians and Israelites were white.

Fortunately for the cause of truth, the remains of many mummified pharaohs and Egyptian royalty have been dug up, and most of them have fair or reddish hair and blue eyes. Their facial features and especially their skull shape prove they were white. Egyptian artwork clearly depicts the native Egyptian males as white with golden/bronze tans, and the native Egyptian women as pale white. Men often worked outside in the heat, and being white and wearing minimal clothing, they tanned. The women were fully clothed and sheltered inside and thus remained pale. On the odd occasion, the artwork depicted foreign slaves and some of them were black. The Egyptians had begun traveling down to sub-Saharan Africa to bring back black slaves. This importing of non-white blood was ultimately the downfall of white Egypt, heralding that unfortunate country being completely overrun by dark races many centuries later. As a non-white nation, Egypt never regained its former glory and importance, not to this day.

The Bible not only tells us about the decline of Ethiopia but also of Egypt. “I gave Egypt for thy ransom, Ethiopia and Seba for thee” Isaiah 43:3. Numerous verses indicated that the glories of Egypt were over and the civilization was collapsing. Jeremiah tells us that the Pharaohs were finished, “They cried there, ‘Pharaoh, king of Egypt, is but a noise. He has passed by the appointed time!’” Jeremiah 46:17. In Isaiah 19:4 we read: “And I will deliver Egypt into the hands of harsh lords and kings who will rule over them....” The lesson is clear: once a white Adamic nation goes black, it never comes back.

The Philistines were in the line of Ham, son of Noah. They were descendants of Mizraim (also known as Egypt) through his son Casluhim. Therefore, the Philistines were an offshoot Adamic nation from the white Egyptians. Although the Philistines were not one of the original tribes directly from the sons of Noah, they played a large role in the Biblical narrative.

“And Mizraim begat Ludim, and Anamim, and Lehabim, and Naphtuhim, And Pathrusim, and Casluhim, (out of whom came Philistim,) and Caphtorim” Genesis 10:14-14.

These Philistines colonized lands just south of Canaan and consequently, they are frequently mentioned in the Bible. When the Israelites moved in and conquered Canaan, the strife between the Israelites and the Philistines was constant. Sometimes the Israelites had the upper hand; sometimes, the Philistines. During the period of the Judges (four hundred years), the Philistines had the upper hand and even banned the Israelites from possessing weapons.

Another major ruse to steal the identity of white Israelites is falsifying the Philistines’ origins. The deception consists of two planks. One plank is to claim that the Philistines were a race of giants due to being related to the Kenites. This assertion is based on the fact that the Philistines employed the giant Goliath to fight against the Israelites. This was the Goliath whom King David slew when he was still a boy. However, Goliath was not a Philistine. He was a mercenary hired into their army. The surrounding Canaanite lands were filled with bastard nations descended from the Kenites, Rephaim, and others. There the Philistines could easily find mercenaries, including giants, willing to fight the Israelites.

The other plank of the deception revolves around the Philistines’ status as sea traders and claims they were not white. This is a more insidious deception than the disinformation about Goliath. The Philistines and the Ionian Greeks were sea-farers who established colonies around the Mediterranean. Later, they were both surpassed by the mighty Phoenicians, who also created colonies far and wide. Here’s the crucial detail that leads us back to solid truth (rather than politically correct speculation of deception and propaganda): We know that all of the colonies created by these sea-faring tribes were white. If these colonies were white, then the people who spawned them must have been white. This is basic logic and genetics. Hence it is safe to conclude that the Egyptians (the ancestors of the Philistines and the other Hamite nations) were white.

Since those evil forces who push the antichrist narrative that the ancient Egyptians were black cannot refute this mountain of evidence, they ignore it. They also lie and claim that the Phoenicians were Canaanites (and thus were not white). In a similar move, they say the origins of the Philistines are unknown, or perhaps they also were Canaanites. Yet the Bible

clearly states that the Philistines descended from Ham through his son Mizraim, or Egypt. Thus we can rest assured that the Philistines were white.

Phut

Phut was also a son of Ham. His descendants came to be known as the Libyans. Phut was located to the west of Egypt but his land was overshadowed in strength and size by both Egypt and Ethiopia. The Greeks generally divided Africa into three parts, Egypt, Ethiopia, and Libya. Josephus tells us that we get the name Libya from a son of Mizraim.

“Phut also was the founder of Libya, and called the inhabitants Phutites, from himself: there is also a river in the country of Moors which bears that name; whence it is that we may see the greatest part of the Grecian historiographers mention that river and the adjoining country by the appellation of Phut: but the name it has now has been by change given it from one of the sons of Mesraim, who was called Lybyos” (Antiquities 1.6.2).

Canaan

Canaan, the last son of Ham, became father to the ancient Canaanites, who lived in Canaan, the lands the Israelites later conquered. Canaan was cursed by his grandfather Noah to be the servant to Shem and Japheth. Because of the curse, it was likely that other Adamic tribes shunned intermarriage with the Canaanites as nobody would want to inherit the curse through marriage. Noah cursed Canaan and his line because Canaan was the result of Noah’s son Ham committing incest with his mother, Noah’s wife. We’ll go into this curse in a later Proof, but for now, you could compare Genesis 9.20-27 with Leviticus 18.7-8 and 20.11.

Like all the Adamic nations, the Canaanites were originally white. Despite the unfortunate circumstances of Canaan’s conception, he was part of Noah’s white genetic line. Canaan had many sons who spread abroad into many lands. By noting the names of the lands they came to possess, we get a picture of the miscegenation that the Canaanites indulged in:

“And Canaan begat Sidon his first born, and Heth, And the Jebusite, and the Amorite, and the Girgashite, And the Hivite, and the Arkite, and the Sinite, And the Arvadite, and the Zemarite, and the Hamathite: and afterward were the families of the Canaanites spread abroad. And the border of the Canaanites was from Sidon, as thou comest to Gerar, unto Gaza; as thou goest, unto Sodom, and Gomorrah, and Admah, and Zeboim, even unto Lasha” Genesis 10:15-19 KJV.

Through their interbreeding with non-Adamic races, the Canaanites became a nation of bastards. The accursed peoples in the lands they entered had no problem intermarrying with the cursed Canaanites. The Canaanite territories included Sodom and Gomorrah, those ancient cities renown for sodomy and sexual perversion which Yahweh destroyed with fire and brimstone as punishment and warning to others. Thus the Canaanites became completely mixed (with many tribal names but known collectively as Canaanites) and thoroughly corrupted genetically and lost their white Adamic identity. Knowing this, we can understand

why when Joshua led the Israelites into the land of Canaan, Yahweh commanded that no Canaanite be spared.

“When the Lord your God brings you into the land which you go to possess, and has cast out many nations before you, the Hittites and the Girgashites and the Amorites and the Canaanites and the Perizzites and the Hivites and the Jebusites, seven nations greater and mightier than you, and when the Lord your God delivers them over to you, you shall conquer them and utterly destroy them. You shall make no covenant with them nor show mercy to them“ Deuteronomy 7:1-2 KJV.

But the Israelites disobeyed Yahweh; although they defeated and destroyed many Canaanite nations and tribes, they did not exterminate every one of them — man, woman, and child — as Yahweh had ordered. The surviving Canaanites dwelt amongst the Israelites and influenced them for evil. As Yahweh had warned, the Canaanites continually corrupted the society and enticed the Israelites into sin. This included idolatry, sacrificing their children to their god Moloch, and other abominations.

Intermarriage and being able to distinguish between Israelites and Canaanites also became a problem, as the Canaanites had some admixture of white genes and to some degree must have looked like Israelites. However, ancient artwork depicting Canaanites and other tribes from Canaan, such as the Hittites, show their distinctive facial features. They appear white but have notable hooked noses, sloped skulls, and other non-white features that clearly show bastardization. These features can be seen in the modern descendants of these Canaanites who live in our white societies to this day. Because of ancient Israel’s disobedience, these Canaanites — many of whom look white — remain with us, infiltrating our white societies, running and ruining our governments, banks, financial systems, corporations, churches, academic institutions, entertainment empires, news and media businesses, and much more. As is their nature, they continue to work to corrupt our white Christian societies and tempt us into sin.

Shem

Shem, son of Noah, had five sons. The Shemites, for the most part, settled in what we now call the Middle East. Many modern scholars and today’s churches present the Shemites as dark, swarthy Arab-looking people (despite the fact that Shem was a white son of white Noah). This fabrication is more obfuscation to pass off Arabs and modern Jews as Shemites and the Jews as the true Israelites. This is a fantasy. Arabs are not white Shemites; modern Jews are not white Shemitic Israelites. In reality, both Arabs and Jews are the result of miscegenation and can no longer be identified with any Adamic tribe or nation, including the Shemites. Although miscegenation occurred throughout the centuries, the Muslim conquest of those regions, around 700 AD, greatly accelerated it. Islam resulted in the entire Middle East becoming “brown” in a short period of time. The Muslims also brought masses of Negro slaves into their lands. This resulted in even more “darkening” over subsequent generations.

“The sons of Shem were Elam, Asshur, Arphaxad, Lud, and Aram” Genesis 10:22 KJV.

Elam

Elam, son of Shem, was the progenitor of the ancient Persians. In the Bible, when prophecies clearly relate to the Persians, they are called Elam. In Greek legends, Perseus is an ancient legendary figure (the Greek hero who beheaded Medusa) who was said to have lived around the same time period as Dardanus and Cadmus (see Proof 4), who were the leaders of the Israelites who left for Europe right after the Exodus (not all the Israelites followed Moses into the Sinai Desert). The Greeks believed the Persians descended from this mythical Perseus, but once again, these historians did not have the complete story. Thus the Greeks called the Elamites “Persian,” and we have a similar situation to how linguistically Mizraim became Egypt and Cush became Ethiopia.

The Shemitic Persians under Cyrus the Great (c. 600 BC) conquered the Babylonian Empire (who were Chaldeans, likely descendants of Aram, another son of Shem) and later invaded Greece twice, unsuccessfully. They were the last white non-Israelite Adamic people to have a significant empire and rule the Middle East before Alexander the Great’s successful invasion. From Alexander’s time on, the white Israelites ruled the Middle East under the Seleucids and then Parthians, until the Arab conquest and subsequent mongrelization took place.

History describes the Persians as white. Darius the Great, a late Persian King, depicted on a famous vase known as the Darius Vase, had blond hair and pale skin. The Greeks fought the Persians several times in the Greco-Persian Wars, but the Greek historians never described them as dark and swarthy. Rather, the Greeks mocked them for wearing “women’s clothing” because the Persians covered themselves completely to protect themselves from the sun, causing their skin to be very pale. The Greek men, on the other hand, commonly worked and fought in the nude.

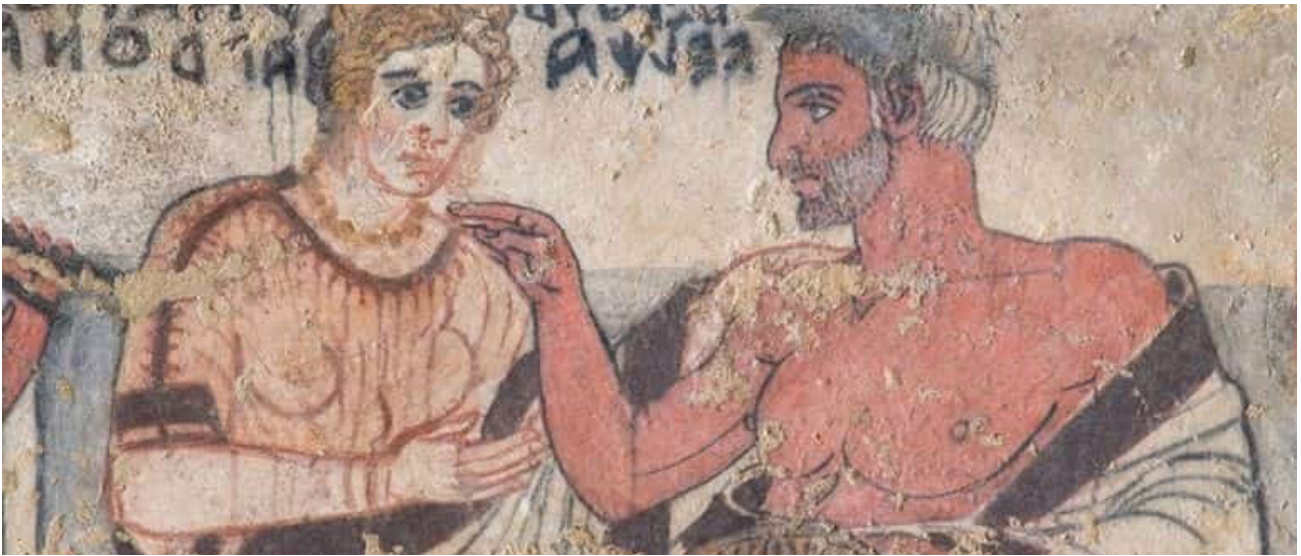
Asshur

Asshur, son of Shem, is the father of the Assyrians. These white Assyrians worshipped many pagan gods, one of whom was named Assur. Obviously, over the generations, the tribe had forgotten their knowledge of the one true God and turned their original patriarch Asshur into a god (which they spelled Assur, dropping the “h”). The Shemitic Assyrians spread out all over the Middle East, below the Caucasus Mountains. They grew into a formidable empire, which encompassed most of the white Adamic world at that time. In fact, Yahweh used the Assyrians as a tool to punish the Israelites when they transgressed against Him.

Lud

Lud, son of Shem, was the father of the Lydians who settled in Anatolia (West Turkey) in Europe. These Shemitic Lydians were the only non-Japethite tribe to settle on a large scale this early in Europe. They are most noted for having an alliance and even intermarriages with the Trojans who arrived many centuries later. The Israelite Dardanus arrived in Anatolia (see Proof 4) and is said to have married a princess, a Lydian daughter of the Lydian king. Since

the arrival of the Israelites and Dardanus was around 1400 BC — still early in the dispersion of the tribes — both the Dardanians and Lydians may have still been aware of their common Shemite lineage. The Etruscans in Italy, located above Rome, were a Lydian colony. Thus we can see how the later Romans, who had descended from the Trojans, formed an alliance with their old trusted allies, the Etruscans, since both tribes were Shemites.



Above is an ancient Etruscan Mosaic discovered in Italy. Notice the woman is pale, whilst the man heavily tanned. Woman typically remained indoors and covered themselves, whilst the men worked the land in the Mediterranean sun.

Since the Etruscans like the Romans lived in white Italy, modern historians don't try to claim they weren't white. Instead, the rewriters of history take a different tactic. They try to obscure the origins of the Etruscans. But Greek historian Strabo, who wrote during the transitional period from the Roman Republic to the Roman Empire, clearly traced the Etruscans to the Lydians of Anatolia. And surely, the Romans knew where their neighbors and allies, the Etruscans, came from. Since the Etruscans were white, their Lydian ancestors and the Shemites were all white.

Aram

Aram, son of Shem, was the father of the Arameans who lived in the Middle East above the lands of Canaan. Whenever the lands of Aram or the Arameans are mentioned in the Bible, it is generally translated as Syria and Syrians. Syria was the Roman name given to the region. Abraham, our forefather, was called out of Paddan-Aram, which means Planes of Aram. So Abraham was living there with his father and family before Yahweh called him to leave and go south to the lands of Canaan.

The language of Arameans, called Aramaic, was used prolifically throughout the Middle East until the rise of the Assyrian Empire when Akkadian became the lingua franca. From the Aram nation came the Chaldeans. King Nebuchadnezzar and the Chaldeans replaced the Assyrian Empire and rebuilt Babylon. Thus the second Babylon was a Shemitic empire. as opposed to the first Babylon, under Nimrod the Cushite, which was a Hamitic empire.

Interestingly, we can see that each Shemite tribe had its heyday, its reign, and its rule over large swaths of the white Adamic world. First, the Assyrians (Asshur) with the Assyrian Empire; then the Chaldeans (Aram) with the Babylonian Empire; the Persians (Elam) with the Persian Empire; and even the Etruscans (Lud), since they largely intermarried with the Romans and the Romans ruled the world and the Etruscans played a large part with them. However, history shows that all of these empires failed and eventually crumbled. But the Israelite nations formed from the Germanic tribes who became Christian are the only white Adamic nations that have survived unadulterated to this day.

Arphaxad

Arphaxad, son of Shem, is the last Shemite patriarch. He was the father of Eber, and from Eber, we get the name Hebrew. Eber was the forefather of Abraham and the Israelites. Interestingly, no records survive of any peoples being named after Arphaxad or any lands bearing his name. Evidently, at some point, these people must have been displaced; therefore, they were the least of all the Adamic nations named in Genesis Chapter 10. The people of Arphaxad had no great history, no great heritage, and no lands called after themselves.

This explains why Abraham (who descended from Arphaxad) dwelt in the lands of Aram as opposed to his own patriarch's lands. There were no lands of Arphaxad. This gives the context to Yahweh's statement that He chose the least of all the (Adamic) nations to be His people. "The LORD did not set His love on you nor choose you because you were more in number than any other people, for you were the least of all peoples" Deut 7:7 KJV. When compared to the exceedingly great Adamic nations and even empires, Abraham and his family were nobodies. Nevertheless, Yahweh chose Abraham and his Shemitic Israelite descendants and made them great and as numerous as the stars. The Israelites have survived to this day and are the modern European people.

Arphaxad the Shemite did have two other descendants we should mention. Arphaxad's son Eber had two sons, Peleg and Joktan. Peleg's line led to Abraham and the Israelites. His brother Joktan and his descendants settled in the land we today call Arabia, and they likely identified themselves as Hebrews. Their cousins the Israelites had extensive laws that prevented miscegenation, and Yahweh continuously chastised them when they forsook His law. On the other hand, the descendants of Joktan did not have Yahweh's law and correction; thus through mixing, they quickly lost their tribal identity. By King Solomon's time, Joktan's land was called Arabia, which means "mixed" or "to darken." Thus Joktan's line miscegenated themselves into oblivion fairly early on, which must have been a stern lesson to their cousin Israelites who went on to become the many nations of Europe.

The Adamic Nations

So now you can see that it is entirely possible to trace the history of Noah and his sons and the nations they gave rise to. The beginnings of our race are not hopelessly lost in time. Yahweh preserved our history in the Bible right from when Noah stepped off the ark with God's commission to restart the white Adamic race. Great Adamic nations came from Noah's

sons, Japheth, Ham, and Shem. We know the names of these nations, their locations, and their histories. We know that the Israelites came from the line of Shem. The Israelites were the white descendants of Shem, who was the white son of the white Noah. So of course we know what the Israelites looked like in the past and look like today. They look as white as any white European man or woman.

9) Christ Came Only for the Lost Sheep of the House of Israel



“But he answered and said, I am not sent but unto the lost sheep of the house of Israel” (Matthew 15:24).

Christ did not come for everyone. In fact, Jesus (Yahshua) Christ specifically instructed His apostles to go only to one group of people: the lost sheep of Israel. Does that come as a surprise? Nor did He ever change or revise that instruction. Christ was not a “universalist” in that He never commanded His Gospel to be preached to every nation under the sun, to each and every hominid that walks the earth. That universalism came later as a politically motivated development of post-Apostolic Christianity (or, better, Churchianity). Not one scrap of evidence can be found in Scripture and the salvation history of Israel to support this notion of universalism. When Christ said to “make disciples of all the nations” (Matthew 28:19 NKJV), He was talking about all Adamic nations and only Adamic nations.

Yes, there is a form of universal salvation, but it’s only for Yahweh’s creation, the white Adamic race. Why is that? Simply put, Yahweh did not create the other races and He promised salvation only to His own creation. He favored only His own. We have examples of that principle in everyday life. For example, imagine the father of a family — let’s call him Mr. Murphy — left his property to the members of his family in his last will and testament. He may use words such as “all” and “everyone” but that “all” and “everyone” applies only to people within the Murphy family. It does not include every person in the town or country. No random person can walk in off the street or from the other side of the world and claim part of the Murphy inheritance.

Perhaps you’re not convinced? Please read on and weigh the evidence we present with an open mind and a prayerful heart. In light of the Scriptures we cite, consider the possibility that perhaps some of your assumptions about Christianity may be false, misinformed, or only

partially true. If that is the case, then your task is to square your beliefs with what Apostolic Christianity actually taught and the Bible still teaches. This responsibility is yours and yours alone.

In the decades after Christ's resurrection and ascension, the Gospel spread out from Palestine into the surrounding regions. Paul of Tarsus spearheaded the mission to bring the Gospel into Europe. Paul's journeys are mapped out for us in the Bible. If universalism were true, we should ask — perhaps with indignation — why didn't Paul and the other early Christian missionaries go to India or the far East or sub-Saharan Africa? But they didn't. Since they didn't, we need to ask if they failed in their mission. Did they misunderstand Christ's instructions? Could it be that they went to the wrong place? And if Christianity is for every nation in the world, why did Paul and the other apostles not write letters of instruction (epistles) to the other non-European peoples of the world, and all the other races? But Scripture records that they wrote only to white Europeans.

Paul knew that the children of Israel had dispersed into Europe and that Europe was where the lost sheep of the house of Israel were to be found. Huge numbers of ancient Israelites had been scattered into Europe during the Assyrian and Babylonian deportations, and lesser numbers centuries earlier around the time of the Exodus from Egypt. Paul was a learned man and could have determined these facts from the writings of antiquity (in fact, Paul had access to much more history from antiquity than is extant to us now) as well as the Scriptures and direct inspiration from Christ who had called him to this ministry on the road to Damascus.

So while Peter and James focused on bringing the Gospel to the circumcised Hebrews in Palestine and nearby areas, Paul and his companions went to those “lost sheep” Israelites who had long since forgotten their Hebrew roots and at that time constituted the kings and peoples of white Europe. Some churches claim that certain apostles went to non-Israelites nations; for example, Thomas to India and Mark to Egypt (which by that time had long ago suffered miscegenation and was no longer the Egyptians of old), but there is no reliable historical evidence for any of these early missionary ventures to non-whites. Such claims that lack historical evidence should be viewed as fables, not facts.

To more fully understand Christ's command to “go only to the lost sheep of the house of Israel,” we must understand His mission. What message were the apostles to bring to these lost sheep? Why did Christ come? Why did He die? What was He trying to accomplish? Why would Christianity be only for Israel? These are far-reaching questions and to grasp the answers, we first need some backstory from the Old Testament. In later Proofs, we'll focus more closely on several serious mistranslations in the New Testament that have misled Christians to believe that the Gospel is for all nations and all people — anyone and everyone — and not just the lost sheep of the house of Israel, as Christ had stated.

The Old Testament promised a Saviour who would redeem Israel and stated that Yahweh Himself would be that Saviour. Let's pause here for a moment. We tend to assume that we know what these terms mean, but do we really? It can happen that we hear certain words so frequently (such as “Saviour” and “redeem”) that we think we know what they mean when we really don't. Or we have only a surface-level understanding. So let's take a closer look.

What is a “Saviour” and why did Israel need saving? What did Israel need deliverance from? Today’s churches focus on the salvation of an individual person’s soul, but that’s only part of the picture. Israel will also be saved as a whole: “And in that manner all of Israel shall be delivered; just as it is written, ‘From out of Zion shall come the Deliverer, and He shall turn away impiety from Jakob’” Romans 11:26 CNT. And Isaiah 45:17 KJV says, “But Israel shall be saved in the LORD with an everlasting salvation....”

Here’s the bottom line: Eternal salvation is a racial message; your racial origin determines your destiny. Yahweh created Adam (and white Adamkind) in His own image. Into Adam, He breathed His own eternal Spirit. Adamic man is eternal because he has the Spirit of God within him. “God created man for immortality and made him an image of His own eternity. But death entered the world by the envy of the devil, and those of his portion tempt it” Wisdom of Solomon 2:23-24 LXX (Septuagint). Hence, all of Adamkind is already “saved” eternally. Paul of Tarsus says that the Spirit of God is sown in a natural body but will be raised a spiritual body (see I Corinthians 15). Adamkind will be resurrected and live forever.

This plan for eternal Adamic salvation came to fulfillment through Christ’s death and resurrection. (Until the time of Christ, the spirits of Adamic men waited in a place referred to as Hades, as spoken about in the Second Epistle of Peter.) Scripture tells us that Christ came into the world to undo the works of the devil: “He who sins is of the devil, for the devil sinneth from the beginning. For this purpose the Son of God was manifested, that he might destroy the works of the devil” I John 3:8 KJV. But what exactly are these works? The devil brought physical death into the world (because of envy, says Solomon) by seducing Eve and fathering Cain. In this way, Satan, a fallen angel, corrupted the Adamic creation, thus bringing death. But Christ overcame this physical death (delivering or saving His people from the works of the devil) and ultimately He will restore all Adamites to immortality, each Adamite man and woman being resurrected as He was. Then Christ will complete His destruction of the works of the devil by destroying all the offspring — the corruptions of His creation — which the devil brought into the world. What Israel failed to do in Canaan (exterminate the demon races; more on this in a minute), Christ will do at the end of time.

But, you might ask, if all Israel is to be saved, why wasn’t she saved from the suffering of being conquered, deported, and having the temple destroyed? Here it’s important to differentiate between eternal salvation and temporal salvation. Eternal salvation is in the next life; temporal salvation is “preservation” in this life. Temporal salvation is when Yahweh delivers or saves Israel from the hand of the enemy and preserves, prospers, and blesses her. Who is this enemy from whom Yahweh is preserving an obedient Israel in this life? Knowing the identity is the key to understanding Scripture. In Genesis, Yahweh decreed that He would put enmity between the seed (or lineage) of the serpent and the seed (or lineage) of the woman (or Eve with her husband, Adam). “And I will put enmity between thee and the woman, and between thy seed and her seed...” Genesis 3:15.

This enmity is between the lineage of Cain, who was fathered by Satan, and the white Adamic lineage born of Adam and Eve, which lineage began with Seth since Cain had murdered Abel. Throughout history, this enemy seedline of Cain has tried to destroy and kill Yahweh’s Adamic race. Yahweh’s deliverance of Israel from this destruction is temporal salvation (or salvation

in this life). This is the blessing that Yahweh promised to Abraham and was enunciated by Zachariah, the father of John the Baptist: “The oath which he swore to our father Abraham, that he would grant unto us, that we being delivered out of the hand of our enemies might serve him without fear, in holiness and righteousness before him, all the days of our life” Luke 1:73-76. Yahweh blesses Israel with temporal salvation so that she can serve Him and be the holy people He created and called her to be.

To recap thus far: All Israel will be saved eternally. Despite what churches teach, eternal salvation is not conditional on belief or baptism or anything else we do. Rather, it is guaranteed to the Adamic race as a whole. But there are eternal things and there are temporal things. Temporal salvation — or preservation and blessing in this life — is dependent on Israel’s obedience to Yahweh. Obedience is rewarded in this life. Disobedience is punished for the purpose of the correction of Yahweh’s people. Since this is the case, it is essential that we always strive to keep Yahweh’s laws.

Israel’s obedience is her response to the covenant relationship she has with Yahweh. This relationship is described as a marriage. Yahweh’s marriage to Israel could be called “the greatest love story ever told.” (This phrase is the title of a series of essays by Clifton Emahiser in his Watchman’s Teaching Letters, beginning with #137, <https://emahiser.christogenea.org/watchman-s-teaching-letter-137-september-2009>.) It is tragic that Yahweh’s marriage to the race of Israel has been all but forgotten, is poorly and incorrectly understood, is distorted and denied in order to include other races, and is barely mentioned in modern churches. Nevertheless, Yahweh’s marriage to Israel is the basic motif that runs throughout the entire Scripture. It is, you might say, the backbone of the Bible.

Israel’s Marriage and Divorce

The story of Israel’s marriage begins with Moses leading our ancestors out of Egypt. When they reached Mount Sinai, Yahweh revealed His Law to them through Moses. This Law was in essence a covenantal marriage contract and was regarded as such. It’s called the Sinai Covenant or the Mosaic Covenant. We should note here that Christian Identity is based on covenant theology and not replacement theology. Replacement theology teaches that Israel was “replaced” by “the gentiles” who are now “spiritual Israel” through becoming “believers in Christ.” In essence, replacement theology teaches that Yahweh broke His original covenant with Israel. In later Proofs, we’ll clear up the mistranslation of the term “gentiles” and address the universalist heresy of spiritualizing Israel to mean any believer in Jesus Christ.

At Sinai, our ancestors swore to obey Yahweh’s Law. When they proclaimed, “All that the LORD has spoken we will do” (see Exodus 19:8), they were saying their “I do” marriage vows. In turn, Yahweh promised to be a Husband to His bride, Israel. He made a covenant with them. This marriage covenant was forever, and it included all the descendants of Israel right up to this day. “For thy Maker is thine husband; the LORD of hosts is his name; and thy Redeemer the Holy One of Israel...” says the prophet Isaiah (Isaiah 54:5 KJV). As our Husband, Yahweh promised to bless the Israelites, save us in this life and the next, protect us, bless us, and make us great. We are His chosen people. “For you are a holy people to

the LORD your God, and the LORD has chosen you to be a people for Himself, a special treasure above all the people who are on the face of the earth” Deuteronomy 14:2 NKJV. Israel and none other was given the covenant as Yahweh’s bride. We are eternally bound to Him.

The Israelites learned more about Yahweh’s Law from Moses as they journeyed through the desert toward the Promised Land. At times, they rebelled and broke God’s Law, but God patiently brought them along and taught them His ways. When they reached the land of Canaan, Yahweh specifically commanded them to exterminate all the Canaanites, those demonic people living in the land who would lead them into idolatry (or, to use the language of marriage, would lead them into adultery). “When the LORD thy God shall bring thee into the land whither thou goest to possess it, and hath cast out many nations before thee, the Hittites, and the Girgashites, and the Amorites, and the Canaanites, and the Perizzites, and the Hivites, and the Jebusites, seven nations greater and mightier than thou; And when the LORD thy God shall deliver them before thee; thou shalt smite them, and utterly destroy them; thou shalt make no covenant with them, nor shew mercy onto them: Neither shalt thou make marriages with them; thy daughter thou shalt not give unto his son, nor his daughter shalt thou take unto thy son. For they will turn away thy son from following me, that they may serve other gods: so will the anger of the LORD be kindled against you, and destroy thee suddenly. But thus shall ye deal with them; ye shall destroy their altars, and break down their images, and cut down their groves, and burn their graven images with fire. For thou art an holy people unto the LORD thy God: the LORD hath chosen thee to be a special people unto himself, above all people that are upon the face of the earth” Deuteronomy 7: 1-6 KJV.

But although the Israelites conquered the Canaanites, they did not fully exterminate or “utterly destroy” them, and thus, as Yahweh had warned, the Canaanites and the other nations in the land corrupted the Israelites. “They did not destroy the nations, concerning whom the LORD commanded them: But were mingled among the heathen, and learned their works. And they served their idols: which were a snare unto them. Yea, they sacrificed their sons and their daughters unto devils, And shed innocent blood, even the blood of their sons and of their daughters, whom they sacrificed unto the idols of Canaan: and the land was polluted with blood” Psalm 106:34-38 KJV.

Thus the Scripture records that because the Israelites did not obey Yahweh’s commandment to exterminate the Canaanites, the disobedient Israelites miscegenated with these forbidden people and began worshipping their false gods (miscegenation always leads to idolatry). They emulated the ways of the Canaanites, which were grievously sinful. Yahweh sent prophets to warn His bride to repent. He chastened and corrected His people. The Israelites would repent for a while and then fall back into sin. This went on for hundreds of years.

Because Israel persisted in her idolatry and disobedience, Yahweh took the final step: He divorced her. Through the prophets, He issued her a bill of divorce (see Jeremiah 3:8). By means of the Assyrian deportations, He cast out Israel from the land He’d given them. Thus, Israel became “lost sheep” separated from their Shepherd. But in His great love for His bride, Yahweh promised that at a later time, He would reconcile Israel to Himself, essentially marrying her again through a New Covenant. “But this is the covenant I will make with the

house of Israel after those days, declares the LORD. I will put My law in their minds and inscribe it on their hearts. And I will be their God, and they will be My people” Jeremiah 31:33 Berean Study Bible.

Here we might consider how great Yahweh’s love for Israel must be for Him to make this promise of reconciliation to His unfaithful wife through a New Covenant. He was punishing her in order to correct her. However, we should note that Yahweh did not extend mercy to the surrounding nations with whom Israel had committed adultery. They did not know Yahweh. He had made no promise to save or preserve them, and His own Law condemned both the adulterous wife and her paramours to death. He destroyed them, but He spared His bride, although He chastened her severely.

To properly understand this marriage, divorce, and remarriage scenario, we need to know a few basic facts about the Old Testament laws regarding marriage. When an Israelite man married a woman, she became his property and owed him obedience and faithfulness. In return, he was responsible for supporting and protecting her and their children. If a wife committed adultery (which is included in the term “uncleanness” in Deuteronomy 24:1-4 which follows), both she and the guilty man were put to death. A husband could divorce his wife (but a wife could not divorce her husband). If a man divorced his wife, the Law required him to give her a bill of divorce, a written document. This document protected the divorced wife if she were to marry again. It proved that she was free from her marriage to her first husband. Without the bill of divorce, she and her new husband could be accused of adultery, thus putting them both in danger of being stoned to death. These laws were designed to keep sin from the land and preserve Israel as a holy people consecrated to God.

The marriage and divorce laws explain why Yahweh asked the Israelites this rhetorical question: “Where is your bill of divorce?” (see Isaiah 50:1). Yahweh had not given His wife a bill of divorce (but He would in Jeremiah 3:8). Israel was an adulterous wife, still married to Yahweh but playing the harlot by worshipping false gods, falling into grievous sins and crimes, and disregarding the Law. Thus as a collective adulterous wife (just as with an individual adulterous wife), Israel was condemned by law to the death penalty. Although Yahweh chastened Israel with divorce — in other words, He put her away — through military defeats and deportations, He promised to save her from death. He promised to redeem her, save her, and marry her again. But there was a formidable problem: His own Law forbade a husband to remarry a cheating, adulterous wife. Such remarriage was considered an abomination. The situation seemed hopeless, but this is where Christ’s mission (which included His death) to the lost sheep of the house of Israel comes in.

“When a man takes a wife and marries her, and it happens that she finds no favor in his eyes because he has found some uncleanness in her, and he writes her a certificate of divorce, puts it in her hand, and sends her out of his house, when she has departed from his house, and goes and becomes another man’s wife, if the latter husband detests her and writes her a certificate of divorce, puts it in her hand, and sends her out of his house, or if the latter husband dies who took her as his wife, then her former husband who divorced her must not take her back to be his wife after she has been defiled; for that is an abomination before the LORD, and you shall not bring sin on the land which the LORD your God is giving you as an

inheritance” Deuteronomy 24:1-4 NKJV.

Because Yahweh cannot lie, He never violates His own promises or His own Law. So how was He to fulfill His promise of remarriage to adulterous Israel when such remarriage is against the Law? Adultery (which includes not only sexual misdeeds but also miscegenation or “adulteration” of the bloodline) is a grave crime. Since Israel was an unfaithful wife, she was under the penalty of death. This was not eternal death (since all Israel shall be saved) but rather a temporal destruction. Without Christ’s redeeming death, Israel should by law have been destroyed and not have lived on to eventually give birth to you and me today. To be freed — or saved — from condemnation, temporal ruination, and the death penalty, she needed a Saviour. Yahweh promised to come as her Saviour (more on how He saved her in a minute) but in order to fulfill His promise to remarry His redeemed bride, He as the Husband had to die.

To recap thus far: As we see in the passage from Deuteronomy 24, a divorced wife was forbidden from remarrying the husband who had divorced her. But if he were dead, she was freed from her marriage to him and from the laws governing that marriage, including the death penalty for her adultery and the law against her remarrying him.

What are we to make of this?

God’s solution transcends our earthly logic. Let’s walk through this scenario, keeping in mind that the scenario is not only hypothetical but also humanly impossible. According to the Law, for an adulterous wife to legally remarry her original husband, he had to die. Of course, it’s quite impossible for her to remarry a dead husband, but legally that would be the only way she could remarry him. That’s because only the death of her husband could free the wife from the laws governing her original marriage to him, including the prohibition against remarrying him. In human terms, this is contradictory and impossible. But we’re talking God’s terms here, and with God, nothing is impossible.

Yahweh does not transgress His own Law. Instead, He gave us a transcendent plan for our salvation and remarriage to Him in the life and death of Jesus (Yahshua) Christ, our Saviour and Redeemer, Yahweh come in the flesh. When Christ died, not only were Israel’s sins forgiven, but Israel was freed from her original marriage to Yahweh at Sinai (also called the Mosaic Covenant) which she had violated. In other words, God transcended His own Law whilst still keeping it. To fulfill His promises to the patriarchs — Abraham, Isaac, and Jacob — and His covenant of marriage to Israel at Sinai, He would release Israel from the penalty of death and through His death as her Husband, make remarriage possible through the New Covenant in Christ.

This remarriage is probably the most misunderstood message of Scripture; nevertheless, it’s at the heart of the Bible. Yahweh Himself is both the Husband and the Redeemer. Throughout the Old Testament, many prophecies state that a Saviour would come to save His people and make things right. Our people were under the penalty of death and needed a Saviour. Yahweh explicitly said that He Himself would be that Saviour and that there is no other

Saviour besides Him (see Isaiah 45:15). He would come in the flesh as a man (an Adamic, Israelite man descended from David) and redeem His people, the children of Israel. These promises and prophecies were fulfilled by Yahshua Christ, who was Yahweh God in the flesh.

“I, even I, am the LORD; and beside me there is no saviour” Isaiah 43:11 KJV.

Israel’s sins were deserving of death, but Yahweh promised to save her. How could her sins be cleansed so that she could be redeemed? According to the Law, the only way sins could be cleansed and forgiven was by means of a sacrifice, or a propitiation. Typically, this sacrifice had to be an unblemished lamb sacrificed on the altar. These temple sacrifices foreshowed Yahshua Christ, the true Lamb of God who would take away the sins of the Adamic world in the New Covenant of His blood (see Luke 22:20 and Matthew 26:28). The old Mosaic Covenant has come and gone. We failed to keep it. But Yahweh did not fail us and we now have Christ.

The New Covenant in Christ is based on God’s original covenant with Abraham, the Abrahamic Covenant, which was not conditional on obedience. The Mosaic Covenant was voided but the Abrahamic Covenant continues. This New Covenant is with the same people, the children of Abraham, Isaac, and Jacob (Israel), and represents Yahweh’s remarriage of Israel. We are Abraham’s descendants, redeemed by Christ in His New Covenant. We are not under the old covenant of the law anymore, although we do keep the moral law.

John the Baptist announced that Christ was this Lamb of God. “The next day John saw Jesus coming toward him, and said, ‘Behold! The Lamb of God who takes away the sin of the world!’” John 1:29 NKJV. (Remember that “world” refers to Israelites and the white Adamic people as the only race created by Yahweh, not to all hominid inhabitants of the globe.) To redeem His condemned wife, Yahweh Himself would be the sacrificial lamb who would cleanse her sins according to the Law. Yahshua Christ is Yahweh in the flesh (see Isaiah 9:6 where the promised Saviour is called the “Mighty God” and “Everlasting Father”), and He is the unblemished Lamb because He is holy, having never sinned. He is the propitiation for our sins. He died to fulfill the Law: to cleanse us His people from our sins through His death as the Lamb; and through His death as the Husband, make it lawfully possible to be reconciled with His cleansed bride, Israel, and to take us back as His wife. Now perhaps you can see what is meant by the phrase “the greatest love story ever told.”

It should be noted that today’s churches preach that Christ died for everyone’s sins. This is the false teaching of universalism. Remember that sin is the transgression of the Law, and only the children of Israel were ever given the Law (see Psalm 147:19-20). Hence no other race or nation was expected to keep Yahweh’s Law. In fact, the Law had nothing to do with them.

Christ referred to Himself as the Bridegroom during His ministry (see Matthew 9:15). His forerunner, John the Baptist, testified that Yahshua was the Bridegroom (see John 3:29). Christ was (and is) Yahweh; the same God who married His people Israel at Mount Sinai; the same God who rebuked and chastened Israel for her sins and idolatry; the same God who finally divorced Israel for her adulteries and scattered her across the nations; the same

God who promised to redeem and remarry His own wife. Yahshua Christ is the Husband who would remarry His people, who had promised: “So I will betroth you to Me forever; I will betroth you in righteousness and justice, in loving devotion and compassion. And I will betroth you in faithfulness, and you will know the LORD” Hosea 2:19 Berean Study Bible.

We should note that Christ God is not a polygamist. He does not have multiple wives. He has only one wife: the people of Israel, the unmixed descendants of Jacob. He married only Israel at Sinai when He gave her His Law as the marriage covenant. As David said in the Psalms, He did not give His Law to any other people. “He declares His word to Jacob, His statutes and His judgments to Israel. He had not dealt thus with any nation; and as for His judgments, they have not known them. Praise the LORD” Psalm 147:19-20 NKJV. That is why Yahweh God came in Christ for the lost sheep of the house of Israel only. We white Europeans are the Israelites, His chosen people — and the only people — who are destined to remarry Yahweh through the New Covenant in Christ because we are the only people who married Yahweh at Sinai in the first place

The Lost Sheep of the House of Israel

To return to the question we asked at the beginning: Why did Christ’s apostles travel only to Europe to spread the Gospel and not to other lands, such as Africa or the Far East? Why did they restrict their missionary journeys to the Roman world of their time? Quite simply, they were obeying Christ’s instructions. They sought the lost Israelites who had long since dispersed into the European lands and built their own nations there. These descendants of Israel were lost sheep without their Shepherd. As Christ had stated when He was in Palestine, “And other sheep I have which are not of this fold; them also I must bring, and they will hear My voice; and there will be one flock and one shepherd” John 10:16 NKJV. Christ’s mission was to regather His sheep not only in Palestine but also from wherever they had wandered. For that reason, He stated clearly that He had come for only one people, the lost sheep of the house of Israel, the entire race of people who were and are genetically biological Israel.

Throughout the Bible, Yahweh often refers to His people as His sheep, as in Psalm 95:7: “For He is our God, and we are the people of His pasture, and the sheep of His hand....” Yahshua Christ is not only the Lamb of God who takes away the sins of the world; He is also the Good Shepherd: “I am the good shepherd; and I know My own, and My own know me,” John 10:14 NKJV. Even the most casual Bible reader is familiar with Psalm 23 that begins, “The LORD is my shepherd; I shall not want.”

We are His sheep, but let’s take a closer look at the phrase “lost sheep.” What does “lost” mean in this case? Lost geographically? Lost in the sense of being doomed? Lost because God had misplaced them? And most importantly, why were they lost? Just as Israel’s sin brought about her divorce and deportations, so Israel’s sin and constant disobedience caused Yahweh to scatter His sheep. Thus Israel became “lost” in that they were sheep separated from their Shepherd. Without their shepherd, sheep are lost and they wander. The ancient Israelites wanted to worship false gods, and God let them. They became lost sheep because they were hellbent on idolatry and following false shepherds. But even so, Yahweh’s mercy

followed them. The prophet Ezekiel, speaking for Yahweh, said, "As a shepherd seeks out his flock on the day he is among his scattered sheep, so I will seek out My sheep and deliver them from all the places where they were scattered on a cloudy and dark day" Ezekiel 34:12 NKJV.









































Our ancestors were scattered and gradually spread across Europe over the centuries following the deportations (and to a lesser degree, before the Assyrian and Babylonian deportations). Christ the Good Shepherd's ministry was to redeem and reunite His scattered flock. He stated in no uncertain terms that His sheep would hear His voice and become one flock. The small number of Israelites in Judea at the time of Christ was but a tiny portion of this flock. The rest were spread over Europe. The mission of regathering them was given to the apostles and the subsequent generations of Christians who continued spreading the Gospel. Over hundreds of years, Europe and the white Adamic world converted from paganism and became the only Christian race. This was Yahweh's regathering of His people, His lost sheep, as He had promised. He became their Shepherd again.

To sum up why Christ came for the lost sheep of the house of Israel only: In order to fulfill His covenant with Israel, Yahweh came down as a man, Yahshua (Jesus) Christ, and died on the cross for His wayward bride. By His sacrificial death as the Lamb of God, He released His wife from the penalty of death for her sins. By being resurrected from the dead, He could lawfully remarry His bride. He sent His apostles to seek and find His lost people who had long since been scattered across the European lands. These white Europeans were the multitude of nations and kings promised to come from Abraham and Sarah (see Genesis 17:6 and 16). Thus were Yahweh's Chosen People regathered in Christ.

Now, as His regathered people, we await the complete and final collective reconciliation of the Marriage Supper of the Lamb and the final destruction of the enemies of God. This vision of the Marriage Supper was given to the Apostle John: "And I heard a sound like the roar of a great multitude, like the rushing of many waters, and like a mighty rumbling of thunder, crying out: 'Hallelujah! For the Lord our God the Almighty reigns. Let us rejoice and be glad and give Him the glory. For the marriage of the Lamb has come and His bride has made herself ready. She was given clothing of fine linen, bright and pure.' For the fine linen she wears is the righteous acts of the saints. Then the angel told me to write, 'Blessed are those who are invited to the marriage supper of the Lamb.' And he said to me, 'These are the true words of God'" Revelations 19:6-9 Berean Study Bible.

John's vision is of the culmination of the New Covenant, Yahweh's new marriage to His people. His people are the descendants of Abraham, Isaac, and Jacob, the regathered lost sheep of the house of Israel. This is why Yahshua came only for the lost sheep of the house of Israel.

10) The Bible Prophesied Israel would have a New Language

By far, the most popular Bible versions today, are all in English. Be it Americanized English or British English.

Thousands of years ago, the Bible prophesied that the ancient Hebrew language of our forefather Abraham and his descendants, the twelve tribes of Israel, would die out permanently. Hebrew was to become a dead language, never to be revived. In its place, Yahweh would give a new language to the children of Israel. This new language would be a purer language, or a “better” language, one in which we would call upon His name, Jesus Christ. Just as the Promised Land was not the final destination for God’s people, neither was Hebrew to be our people’s final language. Yahweh had bigger plans for both our land and language.

“For then will I turn to the people a pure language, that they may all call upon the name of the Lord, to serve him with one consent” (Zeph. 3:9).

The prophet Isaiah also foretold that Yahweh would speak to Israel in a new language, which was described as “stammering lips” and “another tongue.” We may wonder what these descriptions mean. In order to gain understanding, we need to view this prophecy and its idioms from the perspective of the people in Isaiah’s time. If our ancient Israelite ancestors from thousands of years ago were to hear us speaking modern English, our language would certainly sound like stammering lips and another tongue to them. “Stammering lips” would be speech hard to understand, and “tongue” simply means a language.

“For with stammering lips and another tongue will He speak to this people” (Isaiah 28:11).

This is an important prophecy because a people’s language is related to their identity. Since Yahweh promised that His people would have a new language, we should ask, “What is this

new language? Do we speak it today?” If we white Europeans are the true descendants of Abraham — and we certainly are — surely we speak this new language? Well, of course we do! The “new language” is English. Think about it. English is the first language of the UK, America, Canada, Australia, New Zealand, and other native white countries. In addition, a huge portion of the native European people speak English fluently as their second language. In fact, English is the “lingua franca” or common language of white people and white civilization the world over. It is the “new language” of the Israelite people.

Almost every white person alive today (especially the younger generations) speaks or at least understands English. The most recognized Bible translation in the world is the King James Bible, an English translation, as well as other popular translations such as the New International Version, the American Standard Version, and many more. Since the Israelites were white and this promise of a new language was given to them, then only English — the language of white people — can be the new language of the children of Israel. Or, to put it another way, the identity of a people is related to their common language. English is ubiquitous amongst whites, the true Israelites, so we can say with certainty that the promised new language is English. What other language could it be?

Knowing this, what are we to think about the people who claim to have revived ancient Hebrew? Reviving a language that according to Yahweh’s plan was to die out? Are these people not denying the reality of God and His prophecy and calling Him a liar? To deny prophecy is to call God a liar. Denying, ignoring, or obfuscating prophecy is no small thing. In fact, it is blasphemy. The truth is that all modern so-called revived “Hebrew” languages are nothing like the ancient Hebrew our forefathers spoke. These reconstructed languages are merely pale shadows and bastardized versions of real Hebrew. Only pretend Israelites would go through the farce of speaking pretend Hebrew. But this is exactly what is happening today.

One reason why fake Israelites get away with their deception of “revived” Hebrew is largely because our people are unaware that English and all modern European languages have their roots in ancient Hebrew. In fact, the Hebrew alphabet is the mother alphabet of all our white European languages. With a little study, it’s possible to trace how this is so. History shows us that during the ancient dispersions of the Israelites, the Phoenicians brought their Hebrew/Phoenician alphabet (these alphabets were identical) with them to Greece. As a result, the Greek alphabet derived from Hebrew. The Romans took the Greek alphabet and used it to form their Latin alphabet. Latin, in turn, heavily influenced all of our modern European languages, such as English, French, German, Dutch, Spanish, and so on. All the Germanic tribes were easily able to match the phonic sounds of their dialects to the Latin alphabet. Since all Europeans came from the same racial stock who originally spoke the same language (ancient Hebrew), we would expect them to adopt a Hebrew-based alphabet with ease. Thus, step by step, we can trace our European languages back to Hebrew. Isaiah’s prophecy of a new language for the Israelites has been fulfilled. We are using variations of the ancient Hebrew alphabet our Israelite ancestors used, just with a “new tongue” or a “purer language,” as the Bible states.

Phoenician is Hebrew

But certain modern deceivers twist and deny these historical linguistic facts by proclaiming that Hebrew and Phoenician are different and separate languages; that the Phoenician alphabet originated with the Canaanites; and that “modern Hebrew” is the real and original Hebrew language revived. All these claims are complete lies. Other frauds and deceivers — often academics — claim that ancient Hebrew was actually a Canaanite language that the Israelites adopted when they settled in the lands of Canaan. What they’re really saying is that the ancient Hebrews had no language of their own. That’s also a lie.

To counter these deceptions, we need only look at archeological findings. First of all, it can be proven that the Canaanites used cuneiform, a completely different writing system from Hebrew. Cuneiform was related to the Babylonian language. When the Israelites invaded the lands of Canaan and conquered them, the Canaanites sent multiple letters (documents called the Amarna Letters) to Egypt requesting military assistance. These clay tablet documents have been dug up out of the ground, and it can be plainly seen they were written in cuneiform. Since the Egyptians used hieroglyphics, there was no reason the Canaanites would write letters to them in cuneiform style unless cuneiform was the Canaanites’ own writing system.

Secondly, it can be easily proven that the original Hebrew alphabet was identical to the early Phoenician alphabet. In fact, as we’ve covered in earlier Proofs, the Phoenicians were Israelites and both groups spoke the same language. This is shown by the numerous ancient clay tablets and inscriptions that have been unearthed across Palestine. These tablets span many centuries throughout the Kingdom period, and they are written in the Hebrew/Phoenician alphabet. But most importantly, this language only appeared in history after the Israelites had conquered the lands of Canaan. Before that time, there are no written records of it. The only conclusion we can derive, if we’re honest, is that at that time in history, the Israelites were the only people who used the Hebrew/Phoenician alphabet and language and they brought it with them wherever they went (including to Europe).

But to fully understand how “modern Hebrew” differs from the ancient Hebrew/Phoenician language, we must examine the history of the Kingdom of Israel a bit closer. When the Israelites were deported (the Northern Kingdom and portions of the Southern Kingdom) in 722 BC, they were relocated across the Assyrian Empire, as we’ve explained in prior Proofs. A small remnant of Israelites was left in and surrounding Jerusalem in the Southern Kingdom, but about a hundred years later, they were deported by the Babylonians and taken to Babylonia. Here’s the important part: the larger group of Israelites deported by the Assyrians never returned to Palestine. Instead, they migrated to Europe in successive waves. However, from the smaller number of Israelites in Babylon, a few thousand did return. But during their time in Babylon (about seventy years), their alphabet, script, and language had been heavily influenced by the Babylonian language. This is largely where “modern Hebrew” comes from. Basically, modern Hebrew is a Babylonian corruption of ancient Hebrew amalgamated with a mish-mash of words pilfered through the centuries from other cultures by the wandering Canaanite merchants. But we’ll get back to that in a minute.

Hebrew words in European languages

On the other hand, our European languages were influenced heavily by pure ancient Hebrew as spoken by the patriarchs. There was no Babylonian corruption and no linguistic contributions from wandering “Jewish” merchants. Over the centuries, many learned men have proven these Hebraic linguistic roots. One such man was the Welsh Puritan cleric Charles Edwards who in 1676 published his findings on the close connection between Hebrew and Welsh. However, for the most part, studies such as these have been ignored, ridiculed, and even silenced. We would be wise to question this hostility.

It was found that the oldest European languages such as Welsh, Irish, and other ancient Gaelic and Celtic languages bear the closest resemblance to ancient Hebrew. This is only to be expected since we know that very early on, long before the deportations, the Phoenician Israelites reached as far north as the British Isles where they set up colonies. Since these older languages weren’t “cross-contaminated” as much as other European languages, it’s logical that they would remain closer to their original roots. These languages still survive to this day, and we can easily see that they are closer to ancient Hebrew than the so-called “modern Hebrew.”

On the other hand, the Germanic languages originated with the Israelites who were deported and relocated across Assyria much later. These Israelites made the long arduous migration to Europe over many centuries. Along the way, their contact and mingling with other Adamic and Israelite peoples, particularly the Assyrians and Persians, influenced their language. In fact, a few English words still used today such as paradise, assassin, and bazaar were once Persian words.

In Greece, the Israelite Danaan Greeks mixed their culture with the Israelite Ionians who were already living there. So Greek would naturally have evolved to be partly Hebrew and partly Ionian dialects and languages. In a similar way, the Romans would have brought the Greek language with them (since they originally came from Troy) and mixed linguistically with the cultures in Italy (the Etruscans being Lydians descended from Lud). Thus we can also see how both Greek and Latin had their actual origins in Hebrew.

When we realize that the Franks, who originally spoke a Germanic language, conquered what is called France and mingled with the Gauls already living there (who had been Romanized and spoke a dialect of Latin), then we’d naturally expect the French language to be a blend of Germanic and Latin, which is certainly the case. The same linguistic evolutionary pattern unfolded with the Goths who conquered the Iberian tribes in Spain, and with the other Germanic tribes who conquered all of Europe and absorbed their languages.

So we see from history why all the European languages use derivatives of the Hebrew/Phoenician alphabet even to this day, although reconfigured into different languages. The fact is that languages are continuously evolving. Even very ancient Hebrew evolved from pictographs to letters. We can also see why English evolved to be the “largest” language with the most extensive vocabulary in the world due to portions of nearly every white European tribe having settled in England and, to a lesser extent, the British Isles, at one time or another. Thus the English language reflects the greatest diversity of Hebraic-based

European languages.

Modern Hebrew is not Hebrew

Since English is the new language promised by Yahweh to the true Israelites, let's take a closer look at the counterfeit language that is peddled as Modern Hebrew. If a group of non-Israelite people were to pretend to be the historical Israelites, apart from pretending to follow their customs, it would also make sense to pretend to be speaking the ancient original Hebrew.

Modern Hebrew, the official language of modern Israel, is primarily an amalgamation of words from possibly hundreds of languages, all fused together with remnants of corrupted Babylonian Hebrew and seasoned with a few genuine Biblical Hebrew words. In other words, it's a mish-mash stew flavored with a sprinkling of real Hebrew (as preserved in the Bible) to give the impression of ancient Hebrew. Since for centuries the roaming Canaanite merchants (not true Israelites but Edomites) had lived in almost every culture, continuously moving among host nations, it would make sense that their language consisted of bits and pieces they had picked up here and there. This linguistic pick-pocketing was added to the bastardized Babylonian-influenced "Hebrew" and some Biblical Hebrew and grew into a language of its own called Modern Hebrew.

As we trace the evolution of true Hebrew and false Hebrew, it's vital to have proper historical context. Remember that the true Israelites were deported by the Assyrians and these Israelites later migrated to Europe. About a hundred years after the Assyrian deportations, the remaining Israelites were deported by the Babylonians. Some seventy years later, around 40,000 Israelites returned to Jerusalem and continued practicing the Hebrew religion. But about 150 BC, power-hungry high priests, beginning with John Hyrcanus, began forcibly converting the surrounding Edomites, although this was explicitly against Yahweh's law. This is how the Edomites became "Jews" and undermined the true Hebrew religion and eventually killed Christ and gave rise to Talmudic Judaism. These Edomites, who are also descended from cursed Cain through Esau's Hittite wives, were dispersed into the nations as wandering Jews by the Romans after the conquest of Jerusalem in 70 AD. So the people commonly regarded as "Jews" are not Israelites at all but are Edomites and Canaanites. Any language they may speak is not true Hebrew.

Most people are completely unaware of the linguistic con-game that has been perpetrated on the world over the past two centuries. Through the Zionist movement, Jews worked together to form one universal language amongst themselves, and this effort came to full fruition after the founding of the state of Israel. But Modern Hebrew — the so-called "revival" of ancient Hebrew — really began earlier with a Lithuanian secular Jew who took the name Eliezer Ben-Yehuda (1858 to 1922). When Ben-Yehuda (born Eliezer Perelman) moved to Palestine in 1881, the languages spoken there were Yiddish, French, Arabic, and to a lesser extent, a modified version of Medieval (i.e., corrupted) Hebrew. Ben-Yehuda promoted the idea of reviving ancient Hebrew and making it the national language, and this idea won support from other secular nationalists. Ben-Yehuda created the first Modern Hebrew dictionary. He

established the linguistic rules followed today by the Academy of the Hebrew Language in Jerusalem that invents and approves new Modern Hebrew words. And so the inventing continues.

The linguistic invention that followed was accomplished by proscribing the “Modern Hebrew” letters to the various Jewish dialects from across the globe and gradually harmonizing these dialects into one standardized language written in Hebrew letters and declaring it “Modern Hebrew” and “Israeli Hebrew.” But a language that Yahweh God had ordained to die cannot be revived to be a spoken language again. Modern Hebrew is in reality an unholy mismatched patchwork of Yiddish, English, Arabic, Greek, Akkadian, Persian, Turkish, Spanish, German, and other words that the Canaanite merchants picked up as they roamed through white nations. Yiddish, perhaps the best-known dialect of the wandering Canaanites and very influential in the creation of Modern Hebrew, is really a type of Germanic dialect with old Hebrew words mixed in. This linguistic mess is hardly the language spoken by Abraham!

Thus a counterfeit “new” language was born. This language pretends to be the ancient Hebrew spoken by the patriarchs simply by using Hebrew letters to represent words from multiple different languages, all patched together. One could say it is a “Frankenstein language” since it is a dead language (Hebrew characters) stitched together with parts of modern and living languages, including some Biblical Hebrew but with most of those words given different meanings and pronunciations. If you think about it, if I wrote English words using Hebrew letters, am I suddenly writing Hebrew? No, I’m simply disguising English with Hebrew letters. This is exactly what Modern Hebrew is — a disguised linguistic beast sewn together from the dead and the living — and it has nothing truly to do with real, ancient Hebrew. It is a deception.

Thus, Modern Hebrew is a lie. It is not the revival of an ancient language; rather, it is a recent invention designed to deceive true Israelites and to empower the enemies of Christ in their fiendish pursuits. It is nothing more than that.

The New Language

In fulfillment of Yahweh’s prophecy, the original true Hebrew language long ago ceased to be a living language and has been replaced by a new language. That new language is English. English along with all our European languages have their roots in ancient Hebrew. This is how the language of Abraham, Isaac, and Jacob evolved into the “new language” foretold thousands of years ago. We descendants of these patriarchs now speak English as the primary language of the white Israelite world. Our language, the English language, is the new language promised by Yahweh. It really is that simple.
