
STATE PRISON SYSTEM PUTS "INCARCERATION" BOOK BACK ON SHELF

[RALEIGH] Faced with a possible lawsuit from the NC American Civil Liberties Union, the NC prison system has decided to ban a controversial book it had previously removed from its library shelves. "The New Jim Crow: Mass Incarceration in the Age of Colorblindness" by Michelle Alexander, was the book prison inmates were not allowed to read. However, a terse letter from the NCACLU to prison officials made it clear that it had no legal grounds for banning the book, and to continue to do so would be unconstitutional. NC State Director of Prisons Kenneth Lassiter says he will now review the system's list of "disapproved publications" to determine what other titles can be unbanned and placed back on prison library shelves.

REV. WYATT TEE WALKER, MLK ADVISOR, DIES AT 89

[CHESTER, VA] The Reverend Dr Wyatt Tee Walker, a close advisor to civil rights leader Dr Martin Luther King, Jr., died Tuesday morning, January 23, 2018, at an assisted living facility in Chester, Virginia. Family members say Dr. Walker had been in failing health for several years. Under Dr. King, Dr. Walker served as Executive Director of the Southern Christian Leadership Conference, the organization Dr. King founded. Prior to leading the SCLC, Rev. Walker was a well-known civil rights leader in Virginia. Rev. Walker is also credited with assisting Dr. King with his historic, "Letter from a Birmingham Jail."

EXCLUSIVE PROPOSED 1898 HISTORIC MARKER LANGUAGE RELEASED

Nothing becomes official until the NC Highway Historical Marker Advisory Committee meets on May 22 to formally review, and, ultimately, if it sees fit, approves it, but, as of now, the proposed 1898 historical marker planned for Market Street between Fourth and Fifth streets later this year, has new language.

And that new language eliminates the previous guesswork of exactly how many African-Americans were killed on Nov. 10, 1898 - the day the Wilmington race massacre began.

Titled "WILMINGTON COUP," the new proposed language for the approved historical marker reads:

Armed White mob met, Nov. 10, 1898, at armory here, marched 6 blocks and burned office of Daily Record, Black-

owned newspaper. Violence left untold numbers of African Americans dead. Led to overthrow of city government & installation of coup leader as mayor. Was part of a statewide political campaign based on calls for White supremacy and the exploitation of racial tensions.

The initial language of the marker that caused considerable controversy inaccurately stated that "Violence left up to 60 Blacks dead..." but research by the 1898 Wilmington Race Riot Commission in 2006 determined that the true number of Blacks killed during the massacre on that first day, let alone ultimately during the entire racial siege of Wilmington by White supremacists, was "unknown," and may never be known.

Hidden photo of Obama and Farrakhan released in new book

In autobiography, Askia Muhammad tells why and how the photo was kept a secret

It was during a mid-2005 Congressional Black Caucus (CBC) meeting on Capitol Hill when award-winning journalist Askia Muhammad captured one of the most significant photos of his career.


Muhammad had doggedly covered then Chicago Sen. Barack Obama since he "first laid eyes on him" at the 2004 Democratic National Convention. Now, here was the Senator in a warm conversation with constituent and fellow Chicagoan Minister Louis Farrakhan. As leader of the Nation of Islam, Farrakhan is another star in Black America, but

one whose name is synonymous with controversy.

Wasting no time, Muhammad snapped the news photo. But moments later, he faced a dilemma.

Obama had already become the darling of national Democratic politics. And the scent of a presi-

Dr. Talbert O. Shaw, former Shaw University president, dies at 89

He will forever be known as "the man who saved Shaw University."

Dr. Talbert Oscar Shaw, the 12th president of Shaw University, died last week in Boca Raton, Florida. He was 89.

Dr. Shaw served as president for 15 crucial years in the school's history - from 1987 to 2002. During that time, he literally save "the oldest historically Black university in the South" from closing due

Will U. S. Supreme Court stay legislative maps ruling too?

A federal three-judge panel has ruled that the NC legislative redistricting maps produced by its special master will be used for the upcoming 2018 midterm elections - the candidate filing period for which is scheduled to begin on Feb. 12 unless officially delayed, and that delay very well may happen. Republican legislative leaders have vowed to, once again, appeal yet another negative redistricting ruling they don't like to the U.S. Supreme Court.

"It is a shocking move for one of the same judges just reined in by a bi-par-

tisan U.S. Supreme Court less than 24 hours ago to again attempt to create chaos and confusion in an election process set to begin in just three weeks," wrote Rep. David Lewis [R-Harnett]

and Sen. Ralph Hise [R-Mitchell], co-chairs of the joint Redistrict Committee, referring to U.S. Fourth Circuit Court Judge James Wynn, who served on both separate three-judge panels that ruled

against Republican NC redistricting plans for both congressional and legislative districts.

It was just two weeks ago when Judge Wynn, an Obama appointee,



redistricting was unconstitutional, and ordered that they be immediately redrawn. State Republicans peti-

tioned the U.S. Supreme Court to stay that order, which it did last week, pending review.

NC Republicans are hoping the U.S. High Court will also stay the legislative map order.

"It is now up to #SCOTUS to preserve the role of State Legislatures under our Constitutional System," tweeted Dallas Woodhouse, Executive Director of the NC Republican Party.

Some legal analysts say that, while SCOTUS stayed the NC congressional redistricting ruling because the

to fraud and fiscal mismanagement; dramatically increased the endowment; doubled the enrollment; renovated various buildings on campus; and constructed the Talbert O. Shaw Living Learning Center.

Per the curriculum, Dr. Shaw, an ordained minister in his native Jamaica prior to coming to the United States in the late 1950's, implemented an ethics and values course that was hailed as trailblazing.

In a Dec. 2002 interview with the Black Press, shortly before he retired, Dr. Shaw, then 74, said he never

dreamed of becoming the president of a distinguished HBCU. He had earned his M.A. and Ph.D. in Ethics from the University of Chicago, going on to become the interim Dean of Howard University Divinity School and tenured Dean of Arts and Sciences at Morgan State University (where he said he was "quite comfortable") when he was approached in the late 1980s by a member of the Shaw University Search Committee.

Shaw said "no" at first but later relented. However, he had no idea just how large the challenge would be, given the dire financial condition the school was in.

"Yes, Shaw was in dire need when I got here," the

then outgoing president confirmed, "dangling on the [edge] of extinction, but I came with a vision and courage."

The IRS had filed two liens against the school because of \$750,000 owed in unpaid withholding taxes, interest and penalties. There was no endowment. Employees weren't being paid. Over \$1.2 million in federal loans was in default, and the university was drowning in over \$5 million of red ink.

Slowly but surely, under Dr. Shaw's leadership, faculty, staff and students embraced his school credo, "Strides to Excellence. Why Not The Best and it wasn't long before the Shaw University was on solid foot-

ing again. Funding was raised, debts were paid off or restructured, and the business community began investing.

Even the major White newspaper in Raleigh, *The News and Observer*, which had been publishing stories on why Shaw University needed to be closed, switched gears after Dr. Shaw confronted publisher, Frank Daniels Jr., who then gave the school a \$100,000 donation.

Shaw alumni from all over North Carolina and the nation reacted to the news of Dr. Shaw's death with sadness, but also with pride that they attended the school during his tenure.

"He planted the seed of becoming a college president

in me when I was 19 years old," says former Shaw University President Tashni-Ann Dubroy. "He is someone I respected, loved, cherished and endeared, she continued. "Rest in peace, Uncle Talley. The Shaw family was blessed to have you as our president."

"This institution has a purpose," Dr. Shaw said before stepping down in 2003. "It is deeply rooted in the Christian faith."

There will be a public viewing from 6 to 8 p.m. at The Gardens of Boca Raton in Boca Raton, Fl. for President Emeritus Talbert O. Shaw on Saturday. The funeral service will be held Sunday at 12 noon at the Deerfield Beach SDA Church in Deerfield Beach, Florida.

The new draft language also leaves off the name of Alex Manley, the publisher of the *Daily Record* (primarily because there already is a marker with his name at the spot on Seventh Street where the *Daily Record* was burned down). The new proposed marker language also deletes the name of Alfred Moore Waddell, the coup leader who

was ultimately installed as mayor after the violent takeover.

The term "race riot" is also removed from the previous language.

In a recent exclusive interview with *The Wilmington Journal*, Michael Hill, Research Supervisor at the NC Office of Archives and History, a division of the NC Dept. of Natural and Cultural Resources, confirmed that staff at the NC Highway Historical Program deter-

mined that some the proposed language of the planned 1898 marker needed to be changed before it is unveiled.

"We wish to seek input from the local community. We've received several emails, including from the local NAACP, and probably about a half dozen others," Mr. Hill told *The Journal*.

Ansley Wegner, the administrator of the NC Highway Historical Marker Program, developed several new drafts, based of community input.

"The next stage will be to share the new drafts with all interested local parties," Hill continued, including Rend Smith, of the nonprofit group, Working Narratives, which made the original application for the 1898 marker, and Deborah Dicks Maxwell, President of the NHCNAACP.

he New Hanover African-American Heritage Commission will also be included. Smith, as the applicant, will then have the right of first appeal to the marker

advisory committee when they meet on May 22.

question of partisan gerrymandering is one yet to be decided by the US Supreme Court (a case involving Wisconsin was heard late last year, and a similar case in Maryland has yet to be heard), North Carolina's leg-

islative redistricting case was already proven to involve racial gerrymandering, which the High Court had already declared unconstitutional, and sent back to the three-judge panel to remedy after concurring.

Part of that remedy was ultimately ordering the special master redrawing on new legislative maps because

the judicial panel determined that 9 of the 28 districts redrawn were still legally problematic.

Republicans are arguing that the State legislature should have been given the opportunity to fix those nine districts, not the special master. The GOP adds that the court had no right appointing the special master to do their job.

In its 92 page order, the three-judge panel, this time led by federal District Court Judge Catherine Eagles, firmly disagreed.

"The [U.S.] Supreme court long has held that, when a federal court concludes that a state districting plan violates the [U.S.] Constitution, the appropriate state redistricting body should have the first

dential run was strong.

Muhammad and others almost immediately realized that the public release of this photo could mean major trouble down the road. Mainly because of bigotry and fear-mongering, the public release of that photo could doom America's chances of electing Obama as its first Black President.

Muhammad had not even left the scene when he received a call and the photo was being summoned by a member of the Congressional Black Caucus. Muhammad ultimately surrendered the disk to Minister Farrakhan's chief of staff. And it remained one of America's best hidden secrets for the next 12 years.

For the first time, more than a decade later, the glowing photograph of now former President Barack Obama and Minister Louis Farrakhan has been published in a book by Muhammad to be released Jan. 31 - "The Autobiography of Charles 67X". Muhammad and some political observers still believe that if that photo had been released, it could

have drawn enough fire - even from some of Obama's supporters looking for excuses - to dent his chances of becoming President.

"I gave the picture up at the time and basically swore secrecy," Muhammad said in an exclusive interview with the Trice Edney News Wire this week. "But after the nomination was secured and all the way up until the inauguration; then for eight years after he was President, it was kept under cover."

As for any debate that the photo could have made a difference in the outcome of the Obama presidential election, Muhammad is emphatic: "I insist. It absolutely would have made a difference."

He has agreement in high places.

"I do believe that it would have had a very, very negative affect in that given moment as far as the candidacy of candidate Obama at that time," says Dr. Shayla Nunnally, president of the National Conference of Black Political Scientists. Her opinion was based largely on the "negative stereotypes about Muslim Americans about Black people and about their allegiance to the United States," which have often been twisted and used to fit bigoted agendas - especially after the terrorist

attacks of Sept. 11, 2001.

"On top of that," Nunnally said, "people have always characterized Minister Farrakhan as being a combative figure in American politics. That adds another layer."

Nunnally, a professor of political science who also teaches in the Africana Studies Institute at the University of Connecticut, specializes in public opinion, political behavior, race and politics.

She questioned what the release of the photo will mean "even now because there's so many conspiracy theories still floating."

Obama, who is a Christian, has constantly been the target of bigoted attacks, Nunnally pointed out. When a woman called him an Arab during a public forum, even his re-election opponent Sen. John McCain retrieved the microphone and corrected her, saying, "No ma'am. He's a decent family man." Nunnally also recalled how former Secretary of State Colin Powell once weighed in against negative stereotyping of Muslims saying, "He's a

Christian...But the really right answer is, what if he is a Muslim?"

Nunnally concluded, "There are many, many, many layers of what that picture can represent to people in their various perceptions. So, I say this to mean that I can see that the release of that photo in that given moment, it would have been highly controversial."

Also, pictured in the photo are Minister Farrakhan's son-in-law, Leonard Farrakhan Muhammad; His son and security chief, Mustapha Farrakhan; Minister Farrakhan's son Joshua Farrakhan; and the Rev. Willie Wilson, executive producer of the program for Farrakhan's Million Man March in 1995 and a chairman of the 20th anniversary.

In an interview, Wilson says he doesn't recall the photo and didn't know he was in it. But hearing the description, he also was certain it could have hurt Obama's campaign.

"I'm sure it would," Wilson said. "Given all of the furor related to the sermon that his pastor, Jeremiah Wright did,

I'm sure that it would more than likely have had a tremendous effect on his candidacy."

Wilson says Farrakhan is so controversial because, "He speaks truth and this is a country that has in so many ways attempted to cover up the realities of its wrong doings of which Minister Farrakhan is quite vocal in bringing to light."

The book tells of other notables who knew about the photograph and never divulged it. In addition to narratives of pivotal moments of his life, the autobiography is also a book of Muhammad's poetry.

Columnist and political observer A. Peter Bailey, anticipating the book release, says he believes the photo would have created controversy for Obama, but could not have caused him to lose the election or his re-election because of the groundswell of Black voter support for him.

"It could have done some damage," Bailey said. "But nothing could have stopped the election because Black support would have countered it."

CBC chair predicts Democratic victory because of Trump chaos

Vows to 'bust our butts' to take back House in November

(TriceEdneyWire.com) - U.S. Rep. Cedric Richmond (D-La.), chair of the Congressional Black Caucus, has vowed to "bust our butts" to win back the House for a Democratic majority in the Nov. 6, 2018 election.

"I think it's a real possibility. For the first time since I've been in Congress I think it's a real possibility," he said in a recent interview with the Trice Edney News Wire.

Richmond predicts a Democratic win mainly because of the chaos and reputed bigotry and racial insensitivity of the Trump administration.

He listed gains for Black America that the Trump administration has

attempted to turn back.

"If you look at Jeff Sessions in the Attorney General's office rolling back to the war on drugs; rolling back the fight against voter suppression; maybe even enhancing voter suppression," he said. "When you look at the President's comments - that's not a person who's trying to be a partner with the Black Caucus nor appreciate African-American issues."

The CBC executive committee leaders met with President Trump March 22, but declined a second meeting saying their concerns fell on deaf ears.

"We presented a 130-page policy paper. And we never got a response; nor to the eight follow up letters we got talking about issues. So until there's

some substantive issues I can't see it," he said.

Trump has also asked to meet with the entire Caucus, but Richmond says that's totally out of the question.

"We're not here to drink wine, eat cheese and have a reception. We're here to advance policies," Richmond said. "The Caucus overwhelmingly; almost unanimously voted not to go. Only one or two people. ... We've gotten no real outreach from this president."

Richmond told of how Democrats have had to fight back by making policy.

"Trump zeroed out Trio (educational programs); he zeroed out Upward Bound; he zeroed out CDBG (Community Development Block Grants), all of that in this budget.

What did we do? We passed a budget that increased Pell grants, we added summer Pell, we added more money to HBCUs, we added money to block grants," he listed. "He got rid of the Minority Business Development Agency. We added money to them."

All 435 House seats are up for votes in November. Currently the party break down is 239 Republicans, 193 Democrats, and three vacancies. This makes it necessary for Democrats to win approximately 27 seats in order to dominate the House.

Meanwhile, Richmond said CBC and Democrats will continue to fight back where possible.

"And then we're going to bust our butts to make sure we take back the house next year and then we'll have some checks and balances."

Rep. Danny Davis introduces bail reform bill

During a recent press conference on Capitol Hill, Rep. Danny Davis (D-Ill.) said that at any given time there are roughly 500,000 people sitting in local jails waiting for their day in court.

"These are people who have been charged with a crime, but are not convicted," said Davis. "Many of the people waiting in jail are forced to wait simply because they cannot afford to post bail."

On January 18, Davis introduced the Bail Fairness Act of 2018 to alleviate some of the burdens associated with the cash bail system.

The Chicago congressman was joined on Capitol Hill by Reps. Sheila Jackson Lee (D-Tex.) and Dwight Evans (D-Pa.) and Chicago businessman and philanthropist Dr. Willie Wilson. The four of them were flanked by two large posters; one poster read: "Taxpayers Spend \$17 billion on Pre-trial Detentions"; the other poster simply said, "Bail Fail" in large letters. Wilson said that he has paid the bails of non-violent Cook County Corrections inmates who were too poor to bail themselves out.

Davis' legislation would require states to release individuals charged with a non-violent misdemeanor on non-monetary conditions prior to their court date.

Civil rights groups and lawmakers are increasingly putting pressure on businesses operating in the cash bail system and becoming more vocal about problems in the industry.

As more cities begin to do away with the cash bail practice, some federal legislators are taking notice. Senators Kamala

Harris (D-Calif.) and Cory Booker (D-N.J.) have voiced similar concerns regarding the problems of money bail in the Senate. In September 2017, Harris joined with Republican Senator Rand Paul (R-Ky.) on the Pretrial Integrity and Safety Act. The bill would overhaul America's bail system just as Rep. Davis' legislation hopes to do.

A May 2017 report by Color of Change and the ACLU entitled, "Selling Off Our Freedom: How Insurance Corporations Have Taken Over Our Bail System," outlined the for-profit incentives behind the bail system in America.

The report revealed that there are fewer than 10 companies involved in the administration of over \$14 billion in bonds posted by for-profit bail each year. The bail industry collects approximately \$2 billion in profit annually.

"The result of bail corporations' control is that millions of people are no longer free: people stuck in jail and families stuck in debt to create profit for these corporations," the report read. The study also pointed out that, "the national median for bail for a felony arrest is now \$10,000, while the Federal Reserve has found that nearly half of Americans would be unable to pay for an unexpected expense of \$400."

The United States remains number one in the world in the rate of incarceration, with over two million people behind bars, in large part, because poor people are unable to pay their way out of incarceration. The money bail system disproportionately impacts the poor. There are currently over 43 million Americans living under the poverty line; nearly 30 percent of African Americans live in poverty.

"The original purpose of bail was to serve as an incentive to return to court when a person is arrested, released, and their case proceeds. However, the current money bail system has little to do with this original intent...people with money can almost always buy their way to freedom, regardless of the charges against them," wrote ACLU Deputy National Political Director Udi Ofer on December 11, 2017.

Rep. Davis has continued to focus on justice reform issues during his 20 years in Congress.

Davis' "Second Chance Act" was signed into law by President George W. Bush in 2007. The legislation assisted formerly incarcerated individuals to successfully re-enter society.

In November 2016, after his

15-year-old grandson was murdered in Chicago, Rep. Davis pushed for more funding for neighborhoods struggling with poverty. His focus was on the "10-20-30" policy proposed by South Carolina Rep. Jim

Clyburn. The "10-20-30" plan would focus cash on 10 percent of all government funding to be allocated to areas where 20 percent of the residents have lived in poverty for over 30 years.





Behind the Black unemployment rate

When the unemployment rate dropped and economic conditions improved under the leadership of President Barack Obama, 45 derided the gains as "fake news".

He suggested that the monthly Employment Situation (www.bls.gov) reports of the Bureau of Labor Statistics were inaccurate and "made up". These are the monthly reports that detail employment statistics, including unemployment rates. Now that 45 is in charge, he can't crow often enough about the statistics that he described as "phony" just 18 months ago.

For the last week, we have heard 45 and his surrogates crowing that "the Black unemployment rate is lower than it has ever been." And, with a Black unemployment rate of 6.8 percent, they are right that the rate is at its lowest since the Bureau of Labor Statistics started disaggregating data to report unemployment by race. Is this something worth crowing about? Does 45 deserve to get credit for it? The answer to both questions, from my perspective, is a resounding "no".

First of all, the 6.8 percent unemployment rate African Americans experienced was exactly TWICE the White unemployment rate of 3.4 percent. Suppose that white men had an unemployment rate of 6.8 percent? Would 45 and his minions be celebrating if whites had the same employment situation as African-Americans? I think not. So, celebrating the 6.8 percent rate without speaking of the inequality it is based on is like celebrating the inequality.

Secondly, the unemployment rate is an imperfect measure of the employment situation. The employment-population ratio is a far more accurate way of measuring how fully employed a population is. It measures the percentage of people who are employed. While 69 percent of white men are employed, just 63 percent of Black men are employed (the numbers for women are closer, with African-American women actually working MORE than White women, with an employment-population ratio of 59 percent for Black women and 55 percent for white women).

The employment-population ratio and labor force participation rates show racial disparities among men that are alarming. Differences in the employment-population ratio suggest that some African-Americans have stopped looking for work because they don't think they can find it. When the Black unemployment rate is adjusted to reflect these realities, it is closer to 10 percent than to the 6.8 percent 45 and his team are crowing out.

Furthermore, the 45th President inherited an economy that was improving. Falling unemployment rates are a result of the Obama expansion. Let's say it again, the Obama expansion. An economic expansion will naturally move unemployment rates downward, no matter who is the President. While 45 can only legitimately claim stock market gains for the last two months, as his regressive tax bill has handsomely rewarded corporate interests, stock market gains in the first month of this year might also be considered a result of the Obama expansion.

Will 45 take credit for the stagnant wages that plague all workers, but especially African-American workers? While unemployment rates have dropped, wages have not risen by very much (less than 2 percent last year). Sure, some workers got tax bill-related bonuses, and Walmart will raise their wages for some workers to \$11 an hour. Most workers are stuck making the same amount of money they made three years ago.

Does 45 take credit for income and wealth differences between African-Americans and whites? The average white family has a \$65,000 income, compared to just \$39,000 for African-Americans. And the average African-American household has just \$17,000 in wealth, compared to \$171,000 for Whites.

When 45 crows about a 6.8 percent unemployment rate for African-Americans, he normalizes the fact that African-Americans should have a higher unemployment rate than whites. And when he talks unemployment out of context and ignores income and wealth disparities, he is suggesting that the current conditions of African-Americans are something to celebrate.

If this President were really interested in the economic status of African-Americans he would have produced a different tax bill, ceased his attacks on health care, and directed his secretary of education to stop attacking public education and HBCUs. But 45 isn't interested in the economic status of African-Americans. He is interested in bragging about data he once dismissed as "phony".



Shutdown allowed Trump to play poisonous political game

Donald Trump had the government shutdown that he wanted. No one should be confused about this. The shutdown allowed Trump and Republicans to play their poisonous politics of division.

Democrat Dick Durbin and Republican Lindsay Graham, representing a bipartisan group, brought him that agreement. That's when Trump purposefully blew up the process, scorning immigrants from "shithole countries."

Even when Democratic Senate leader Chuck Schumer agreed with Trump's demand for billions for the wall, there was still no deal. He "couldn't take yes for an answer," Schumer concluded. Why would Trump and Republicans force the shutdown?

The Trump campaign made that clear, rolling out a vicious television ad calling Democrats "complicit" for slayings committed by undocumented immigrants. The White House and Republican legislators repeated endlessly scurrilous talking points that they knew were a lie: Democrats favor protecting illegal immigrants over funding our soldiers, supporting our veterans and providing services for Americans. This is ugly, race-based politics at its

worst.

Republicans reveled in it, claiming they had the upper hand. It's worth remembering that many recent mass murders in America - in Newtown, Orlando, Las Vegas, Charleston and Sutherland Springs - involved U.S.-born assailants. Are Republicans, who in league with the National Rifle Association block any reform of our ridiculous gun laws, responsible for all of those murders?

That's the logic of the Trump campaign ad slurring Democrats on immigration. Now a deal has been reached to reopen the government, at least until Feb. 8. In theory, Democrats will gain relief for the Dreamers that is favored by some 85 percent of Americans.

Trump will probably shake out billions to waste on his wall. Government will reopen, with the same distorted priorities.

Whether the government will finally get a real budget for the remainder of this fiscal year (which ends on the last day of September) remains to be seen.

Will Trump finally take yes for an answer? Trump and his campaign aides clearly see the political gain from parading as tough on immigration over and over again. He said in the public meeting he held that he'd be willing to "take the heat" of a bipartisan immigra-

tion deal.

But he has preferred constantly to sow division rather than solve problems. The second obstacle is the House leadership and caucus. There's a majority in the House for good immigration reform, but the Republican leadership refuses to take up a measure that would pass unless a majority of Republicans alone support it. That makes the leadership hostage to the most right-wing faction in the party. And a large number of them don't want any deal, period.

Trump's aides say he is the great dealmaker. There's no question if he wants a deal, there is one available. The question remains is he prepared to make a deal. Now, he'll have until Feb. 8 to make up his mind.

The sad product of all this is that America's politics will grow uglier and more divisive.

The White House and Republicans see themselves as having profited by appealing to our fears, by playing race-bait politics, by peddling hate. They will surely keep doing what they think works. Trump will continue to drive Americans apart - until we come together to call him and the Republicans who echo him to account.

"Since 1804 Haiti has maintained national independence. I fling these facts at the feet of the detractors of the Negro and of Haiti. They may help them to solve the problem of her future. They not only indicate the Negro's courage, but demonstrate his intelligence as well. No better test of the intelligence of people can be had than is furnished in their laws, their institutions and their great men. To produce these in any considerable degree of perfection, a high order of ability is always required. Haiti has no cause to shrink from this test or from any other." - Frederick Douglass, American Abolitionist, "Lecture on Haiti," January 2, 1893

President Donald Trump's timing could not have been more ironic or revealing. On the eve of the eighth anniversary of the January 12 earthquake that devastated the island nation of Haiti (and the start of the Martin Luther King, Jr. holiday weekend), President Trump sat in a bipartisan meeting on immigration reform and publicly questioned

why the United States-a nation founded and built by immigrants-should continue to accept immigrants from Haiti, El Salvador and Africa. With a slur heard round the world, President Trump is quoted to have uttered an obscenity to describe those countries-and Haiti, in particular.

This would not be the first time Haiti has been on the receiving end of President Trump's ridicule and contempt. Only weeks before, it was reported that during an earlier cabinet meeting on immigration, the president allegedly complained that immigrants from Nigeria would "never go back to their huts," and that people coming from Haiti "all have AIDS." And despite then-candidate Trump's pledge at a Miami rally to be the "greatest champion" of Haitian people, the Trump administration has given 60,000 Haitians living in this country under temporary protected status-granted after Haiti's catastrophic 2010 earthquake-until July 2019 to leave or be deported.

The slur is reprehensible and deeply disappointing, but it is not surprising. It lives in a universe of targeted travel bans with discriminatory religious preferences, a candidacy kicked off slandering Mexicans, sympathizing with white supremacists, attacks on protesting Black athletes, and so on. The reported obscenity is, quite frankly, in keeping

with past and current sentiments the president has expressed publicly and via proxy through his administration's policies.

The true obscenity is that our nation's president is shaping immigration policy, not based on purported American ideals of inclusiveness, but based on the demonization of countries that are primarily Black or Brown; not based on facts, but by stoking fear; and not based on knowledge, but influenced by a narrow-minded worldview.

Haiti is not a slur. It is the first Black republic in the world. It is the second oldest independent nation in the Western hemisphere after the United States. Haiti achieved its independence by launching the only successful slave revolt in history. But Haiti's fight did not end on the battlefield. It moved to the global arena where external forces would punish and destabilize the young island nation for claiming its freedom, resulting in lasting economic and political turmoil. France forced Haiti to pay more than \$20 billion in today's dollars as reparations for losing a profitable slave colony-drowning Haiti in debt. The United States, which provided aid to the French to help stop the rebellion, subjected Haiti to a crippling economic embargo until it recognized its independence in 1862. Over the years the United States would

go on to invade and occupy Haiti, as well as play an oversized role in its politics and elections.

Nonetheless, Haiti is deeply woven into the fabric of America's history and founding. Haitians fought in the Revolutionary War. The city of Chicago was founded by a Haitian immigrant from St. Marc. Haitian music, art and food transformed and shaped the city of New Orleans. And the Haitian slave rebellion was directly responsible for the Louisiana Purchase, which doubled the size of the United States.

As a citizen who believes Trump's slander is inconsistent with who we should aspire to be, I abhor the president's misrepresentation of America. As a former mayor of New Orleans, a city richly cultivated by the presence of Haitians, I am distressed by the president's miseducation of the valuable contributions of Haitian immigrants. As the proud descendant of a family who emigrated from Haiti in 1805, I will always challenge the president's wrong-headed assumption that immigrants are the living embodiment of the flaws and failures or upheavals of their countries of origin and cannot contribute positively in their adopted homes.

From its work to repeal the Affordable Care Act to its specious process for passing the Tax Cuts and Jobs Act, ramming it through the Congress with no hearings, this Congress, which has shamelessly sanctioned everything the current president has done, it has shown that it cares about American people - as long as they are the correct race, the correct religion and fall into the correct economic class. In voicing his disappointment over the government shutdown, McConnell sounded almost human. Had one not known his role in making sure the struggling masses continue to struggle, one might have been fooled.

But clearly, what this GOP government wants to do is be "loyal" to the president, who is trying desperately to honor his "base" - reportedly about 30 percent - and leave rest of Americans alone. They have watched and stood by silently for the most part while he has attacked Muslims, the press, the FBI and the Justice Department and members of America's security detail. They have said very little about the president's obvious racism, shown by racist remarks he made following the eruption of violence in Charlottesville, and his most recent comments about immigrants from so-called "shithole countries," which include, in his opinion, Haiti and African countries.

They have virtually given him a pass to be an arrogant white male who says he wants to "make America great again" which is a euphemism for his desire to "make America white again."

The Congress - both House and Senate - has shown its lack of spine, principles and Christian morality. Even the Evangelicals, who once stood for a strict morality that one could respect even if one did not agree with it - has jumped on the president's bandwagon. Even as this president has revealed his racism and sexism and homophobia and Xenophobia, his arrogance and ignorance, frankly, about the issues which he must deal with, they have been silent.

McConnell has not ever, to my knowledge, supported the right of all Americans to have health care; he and the GOP have voiced no concern about the masses of people who work not one, but two or three jobs, making minimum wage, if that, and still cannot make ends meet.

The GOP has come off as a "good ol' boys" club, led by a jock-type bully who cares about nobody but themselves. The GOP is coming off as being very concerned with the military and is making what is happening about "putting immigration before the military." That sentiment will enrage the vast numbers of Americans and will help the GOP gain traction to do what it wants as concerns immigrations, including making the children who have been allowed to flourish in this country bait for their ultimate goal. The GOP wants more people from white countries to be allowed in this country, and the number of people of color to be vastly reduced.

The preoccupation of white people with the so-called "browning" of America is not new. Benjamin Franklin voiced concern about it in 1751; He asked, in a document he wrote that year, "Why increase the sons of Africa by planting them in America, where we have so fair an opportunity, by excluding all Blacks and Tawneys (sic) of increasing the lovely White and Red?" (<https://emahiser.christogenea.org/benjamin-franklin's-stance-race-1751>) The history of the world is full of the cries of white people trying to keep the world white - ironic, since the majority of peoples in this world are people of color.

The administration does not want people of color in this country; the GOP will work to make it more and more difficult for people of color of any religious persuasion to come to this country and to stay in this country. It (the GOP) has shown and will not show compassion or a desire for mercy for tax-paying immigrants to be deported. The dog and pony show of shutting the government down seems to be a theatrical ploy to make it easier for the administration's immigration policies to be passed. In their political minds, they are hearing the man who is now president say, "Built that wall" while he was a candidate.

They like that and they want that.

So, McConnell's statements of caring for "the American people" sound particularly hollow. Honesty and civility has not ever been a part of politics; politicians uses the people in order to catapult them into power, and then they ignore the cries and the needs of those same people as they increase their wealth and power.

It is no different now. McConnell's words after the shutdown began were sickening to listen to, coming from a man who has shown no regard for the masses for the last eight years. He and the GOP are destroying democracy as we have known it. They have shown they have no courage, no morals and no ethics, even as they waddle behind a president who cares for nothing and no one but himself.





Oh Happy Day! Edwin Hawkins goes home to his Father's house

Pleasanton, Calif. - Edwin Hawkins, the four-time Grammy® Award-winning leader of The Edwin Hawkins Singers' 1969 million-seller "Oh Happy Day," died Jan. 15 at his home in the Bay Area, after a bout with pancreatic cancer. He was 74 years old.

"It is with deep sadness that we announce the passing of Dr. Edwin Hawkins - a celebrated artist, innovator and music icon. Though he will be greatly missed the world over, the message of love, life and encouragement that he incorporated into his music gives us all the same hope that we'll join him in heaven and sing 'Oh Happy Day,'" the Hawkins family said.

"Edwin Hawkins was not only a musical hero to me but he came to be a mentor and a close friend," said Grammy® winning singer-producer Donald Lawrence. "His group also had a huge influence on Richard Smallwood, who has known Edwin since Richard was 19 years old." Smallwood adds, "Edwin changed the face of gospel music and helped create a fresh sounding genre that spread around the entire world. He was a humble and kind spirit who not only encouraged others who were privileged to meet him, but also inspired millions to be daring in their creativity."

One of eight children, Edwin Hawkins was born Aug. 19, 1943, in Oakland and raised in the Campbell Village projects. He discovered music early and began playing the keyboards in the Church of God in Christ (COGIC) denomination at the age of 5.


He and his friend Betty Watson co-founded the 46-member-strong Northern California State Youth Choir in 1967 so that they could attend the annual COGIC convention. They recorded an album, "Let Us Go into the House of the Lord," to finance the trip.

The 500 copies they ordered didn't come in time for the trek but one of the LPs eventually fell into the hands of a rock music DJ, Abe "Voco" Kesh, at KSAN-FM Radio. He began to play the hippy-soul song in the Bay area and soon the song's success spread East.

"It is with deep sadness that we announce the passing of Dr. Edwin Hawkins - a celebrated artist, innovator and music icon. Though he will be greatly missed the world over, the message of love, life and encouragement that he incorporated into his music gives us all the same hope that we'll join him in heaven and sing 'Oh Happy Day,'" the Hawkins family said.

"My mother had an old hymnal and I had a knack for rearranging hymns," Hawkins once said. "'Oh Happy Day' was an old hymn and I rearranged it. It was actually one of the least likely songs to become a hit. There were some much stronger songs on there."

Record executive Neil Bogart picked up the song

and distributed it through Buddha Records. "Oh Happy Day" reached No. 2 on the Billboard R&B Singles chart and No. 4 on the Pop Singles chart in 1969. Their rendition won them a Grammy in 1970 for Best Soul Gospel Performance.

The tune has sold over 7 million copies to date and it established Hawkins' career. "I wasn't planning to go into the music business and I wasn't looking for a record deal," he said in the book, "Uncloudy Days: The Gospel Music Encyclopedia." "The record's success decided my fate."

Hawkins often toured with his younger and equally successful singing brother, Walter, and Walter's then wife, Tramaine, as The Hawkins Family in the 1970s. Their energetic stage show filled civic centers and concert halls across the world, including D.A.R. Constitution Hall in Washington, D.C.

Edwin Hawkins, with his group and as a soloist, continued to make gospel radio hits throughout the next two decades including, "Worship the Lord," "God Will Take Care of You," "Give Me a Star" and "To My Father's House." In recent years, Hawkins recorded occasionally and toured largely in Europe.

He also sponsored the Edwin Hawkins Music & Arts Seminar to teach the next generation of musicians the business of music. "This is a sad day in music," says Liz Black, midday radio host for WLIR, a gospel radio station in New York City. "I knew and loved Edwin Hawkins' music even before I was in the church and I know that I'm not alone in that."

In 2001, The Recording Industry Association of America (RIAA) ranked "Oh Happy Day" No. 63 on its Top 365 Songs of the 20th Century listing.
